Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB20-055 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, lines 5 and 6, strike "ADVISORY BOARD SHALL
- 2 RECOMMEND TO THE DEPARTMENT" and substitute "DEPARTMENT SHALL
- 3 CONVENE STAKEHOLDERS TO INFORM THE DEPARTMENT REGARDING".
  
- 4 Page 3, strike lines 1 and 2 and substitute "CONVENING STAKEHOLDERS,
- 5 THE DEPARTMENT SHALL INCLUDE A BROAD RANGE OF EXPERTISE,
- 6 INCLUDING:".
  
- 7 Page 3, line 11, strike "ADVISORY BOARD," and substitute
- 8 "DEPARTMENT,".
  
- 9 Page 6, line 10, after the period insert "THE REIMBURSEMENT FORMULA
- 10 MUST EXCLUDE THE FIRST EIGHTEEN THOUSAND DOLLARS IN ACTUAL
- 11 VALUE THAT IS OTHERWISE ELIGIBLE FOR THE INCOME CREDIT AUTHORIZED
- 12 BY SECTION 39-22-537.5.".
  
- 13 Page 7, line 7, strike "portion and (1)(a)(II)" and substitute "portion,
- 14 (1)(a)(II), and (2)".
  
- 15 Page 7, line 16, strike "26-16.5-105" and substitute "25-16.5-105".
  
- 16 Page 7, after line 16 insert:
- 17 "(2) ~~Any moneys~~ THE MONEY generated pursuant to subsection (1)
- 18 of this section shall be annually appropriated to the department: ~~for~~

1 ~~allocation to the advisory board~~  
2 (a) For the purpose of funding the recycling resources economic  
3 opportunity activities authorized by section 25-16.5-106.7, as well as any  
4 administrative costs associated therewith, including ~~without limitation~~ the  
5 grants authorized to be made under section 25-16.5-106.7 (3) and grant  
6 program oversight authorized by section 25-16.5-105.5 (3); AND  
7 (b) ~~Such moneys may also be used~~ To fund studies pursuant to  
8 ~~section~~ SECTIONS 25-16.5-105 (1)(i), 25-16.5-112 (2), AND 25-16.5-113,  
9 TO MAKE REIMBURSEMENTS PURSUANT TO SECTION 25-16.5-106.7 (6.5),  
10 AND TO FINANCE THE STATEWIDE CAMPAIGN DESCRIBED IN SECTION  
11 25-17-108."

12 Page 8, line 15, after the period add "THE FIRST EIGHTEEN THOUSAND  
13 DOLLARS IN ACTUAL VALUE THAT IS OTHERWISE ELIGIBLE FOR THE INCOME  
14 CREDIT AUTHORIZED BY SECTION 39-22-537.5 IS NOT ELIGIBLE FOR  
15 REIMBURSEMENT."

16 Page 9, after line 17 insert:

17 **"SECTION 7. Appropriation.** For the 2020-21 state fiscal year,  
18 \$985,283 is appropriated to the department of public health and  
19 environment for use by the division environmental health and  
20 sustainability. This appropriation is from the recycling resources  
21 economic opportunit fund created in section 25-16.5-106.5 (1)(a), C.R.S.,  
22 and is based on an assumption that the division will require an additional  
23 2.1 FTE. To implement this act, the division may use this appropriation  
24 for the recycling resources economic opportunity fund."

25 Renumber succeeding section accordingly.

26 Page 1, line 102 strike "RECYCLING." and substitute "RECYCLING, AND,  
27 IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."
