After consideration on the merits, the Committee recommends the following:

HB21-1287 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, line 9, strike "TECHNOLOGY, MAIL, FAX," and
2 substitute "TECHNOLOGY".

3 Page 3, line 5, strike "PROPOSED MARRIAGE OR CIVIL UNION" and
4 substitute "PROSPECTIVE MARRIAGE".

5 Page 3, strike lines 8 through 10 and substitute:
6 "PURSUANT TO THIS SECTION SHALL COMPLETE THE TRAINING AND
7 CURRICULA DEVELOPED BY THE HUMAN TRAFFICKING COUNCIL CREATED
8 IN SECTION 18-3-505 FOR PERSONS WHO WORK IN OR WHO FREQUENT
9 PLACES WHERE HUMAN TRAFFICKING VICTIMS ARE LIKELY TO APPEAR. THE
10 TRAINING AND CURRICULA MUST BE COMPLETED PRIOR TO PERMITTING
11 PARTIES TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN
12 REQUIREMENTS WITHOUT APPEARING IN PERSON PURSUANT TO THIS
13 SECTION; EXCEPT THAT IF A COUNTY CLERK AND RECORDER PERMITS THE
14 PARTIES TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN
15 REQUIREMENTS WITHOUT APPEARING IN PERSON ON AND BEFORE THE
16 EFFECTIVE DATE OF HB 21-1287, THE TRAINING AND CURRICULA MUST BE
17 COMPLETED NO LATER THAN THIRTY DAYS AFTER THE EFFECTIVE DATE OF
18 HB 21-1287. A COUNTY CLERK AND RECORDER WHO PERMITS THE PARTIES
19 TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN REQUIREMENTS
20 WITHOUT APPEARING IN PERSON SHALL MAINTAIN RECORDS
21 DEMONSTRATING COMPLIANCE WITH THIS SUBSECTION (3) AND SHALL
22 DISPLAY A NOTICE OF COMPLIANCE WITH THIS SUBSECTION (3) IN A PLACE

1 THAT IS ACCESSIBLE TO THE PUBLIC IN THE COUNTY CLERK AND
2 RECORDER'S OFFICE AND ON ITS WEBSITE."

3 Page 3, lines 19 and 20, strike "TECHNOLOGY, MAIL, FAX," and substitute
4 "TECHNOLOGY".

5 Page 4, line 8, strike "MARRIAGE OR".

6 Page 4, strike lines 11 through 13 and substitute:

7 "PURSUANT TO THIS SECTION SHALL COMPLETE THE TRAINING AND
8 CURRICULA DEVELOPED BY THE HUMAN TRAFFICKING COUNCIL CREATED
9 IN SECTION 18-3-505 FOR PERSONS WHO WORK IN OR WHO FREQUENT
10 PLACES WHERE HUMAN TRAFFICKING VICTIMS ARE LIKELY TO APPEAR. THE
11 TRAINING AND CURRICULA MUST BE COMPLETED PRIOR TO PERMITTING
12 PARTIES TO A PROPOSED CIVIL UNION TO SATISFY CERTAIN REQUIREMENTS
13 WITHOUT APPEARING IN PERSON PURSUANT TO THIS SECTION; EXCEPT THAT
14 IF A COUNTY CLERK AND RECORDER PERMITS THE PARTIES TO A PROPOSED
15 CIVIL UNION TO SATISFY CERTAIN REQUIREMENTS WITHOUT APPEARING IN
16 PERSON ON AND BEFORE THE EFFECTIVE DATE OF HB 21-1287, THE
17 TRAINING AND CURRICULA MUST BE COMPLETED NO LATER THAN THIRTY
18 DAYS AFTER THE EFFECTIVE DATE OF HB 21-1287. A COUNTY CLERK AND
19 RECORDER WHO PERMITS THE PARTIES TO A PROPOSED CIVIL UNION TO
20 SATISFY CERTAIN REQUIREMENTS WITHOUT APPEARING IN PERSON SHALL
21 MAINTAIN RECORDS DEMONSTRATING COMPLIANCE WITH THIS SUBSECTION
22 (3) AND SHALL DISPLAY A NOTICE OF COMPLIANCE WITH THIS SUBSECTION
23 (3) IN A PLACE THAT IS ACCESSIBLE TO THE PUBLIC IN THE COUNTY CLERK
24 AND RECORDER'S OFFICE AND ON ITS WEBSITE."
