Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB22-1063 be amended as follows, and as so amended, be referred to the Committee on Legislative Council with favorable recommendation:

1 Amend the Judiciary Committee Report, dated February 9, 2022, page 1,
2 strike lines 1 and 2 and substitute:

3 "Amend printed bill, page 3, strike lines 2 through 4 and substitute:

4 "SECTION 1. In Colorado Revised Statutes, **add** part 19 to
5 article 3 of title 2 as follows:

6 PART 19".

7 Page 3, after line 5 insert:

8 "2-3-1901. **Legislative oversight committee for Colorado jail**
9 **standards - creation - duties.** (1) **Creation.** (a) THERE IS CREATED A
10 LEGISLATIVE OVERSIGHT COMMITTEE CONCERNING COLORADO JAIL
11 STANDARDS, REFERRED TO IN THIS PART 19 AS THE "COMMITTEE".

12 (b) THE COMMITTEE CONSISTS OF SIX MEMBERS. THE PRESIDENT
13 OF THE SENATE, THE MINORITY LEADER OF THE SENATE, THE SPEAKER OF
14 THE HOUSE OF REPRESENTATIVES, AND THE MINORITY LEADER OF THE
15 HOUSE OF REPRESENTATIVES SHALL APPOINT THE MEMBERS OF THE
16 COMMITTEE AS FOLLOWS:

17 (I) THE PRESIDENT OF THE SENATE SHALL APPOINT TWO SENATORS
18 TO SERVE ON THE COMMITTEE AND DESIGNATE ONE OF THE SENATORS AS
19 THE VICE-CHAIR OF THE COMMITTEE, AND THE MINORITY LEADER OF THE
20 SENATE SHALL APPOINT ONE SENATOR TO SERVE ON THE COMMITTEE;

21 (II) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
22 APPOINT TWO REPRESENTATIVES TO SERVE ON THE COMMITTEE AND
23 DESIGNATE ONE OF THE REPRESENTATIVES AS THE CHAIR OF THE
24 COMMITTEE, AND THE MINORITY LEADER OF THE HOUSE OF
25 REPRESENTATIVES SHALL APPOINT ONE REPRESENTATIVE TO SERVE ON THE
26 COMMITTEE;

27 (III) THE PRESIDENT OF THE SENATE, THE MINORITY LEADER OF

1 THE SENATE, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE
2 MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES SHALL MAKE THEIR
3 APPOINTMENTS BY JULY 1, 2022. IN THE CASE OF A VACANCY, THE PERSON
4 MAKING THE ORIGINAL APPOINTMENT OR REAPPOINTMENT SHALL FILL ANY
5 VACANCY BY APPOINTMENT.

6 (c) (I) MEMBERS OF THE COMMITTEE MAY RECEIVE PAYMENT OF
7 PER DIEM AND REIMBURSEMENT FOR ACTUAL AND NECESSARY EXPENSES
8 AUTHORIZED PURSUANT TO SECTION 2-2-307.

9 (II) THE DIRECTOR OF RESEARCH OF THE LEGISLATIVE COUNCIL
10 AND THE DIRECTOR OF THE OFFICE OF LEGISLATIVE LEGAL SERVICES SHALL
11 SUPPLY STAFF ASSISTANCE TO THE COMMITTEE, BUT SHALL NOT SUPPLY
12 STAFF ASSISTANCE TO ANY SUBCOMMITTEES CREATED BY THE COMMITTEE.

13 (2) **Duties.** (a) THE COMMITTEE SHALL MEET NO MORE THAN FOUR
14 TIMES EACH YEAR.

15 (b) THE COMMITTEE IS RESPONSIBLE FOR THE OVERSIGHT OF THE
16 COMMISSION. THE CHAIR OF THE COMMITTEE SHALL ESTABLISH
17 ORGANIZATIONAL RULES AND PROCEDURAL RULES AS ARE NECESSARY FOR
18 THE OPERATION OF THE COMMISSION.

19 (c) THE COMMITTEE MAY INTRODUCE UP TO A TOTAL OF THREE
20 BILLS, JOINT RESOLUTIONS, OR CONCURRENT RESOLUTIONS DURING THE
21 2024 LEGISLATIVE SESSION. BILLS THAT THE COMMITTEE INTRODUCES ARE
22 EXEMPT FROM THE FIVE-BILL LIMITATION SPECIFIED IN RULE 24 (b)(1)(A)
23 OF THE JOINT RULES OF THE SENATE AND THE HOUSE OF REPRESENTATIVES.
24 JOINT RESOLUTIONS AND CONCURRENT RESOLUTIONS THAT THE
25 COMMITTEE INTRODUCES ARE EXEMPT FROM THE LIMITATIONS SET OUT IN
26 RULE 26 (g) OF THE RULES OF THE HOUSE OF REPRESENTATIVES AND RULE
27 30 (f) OF THE RULES OF THE SENATE. THE COMMITTEE IS EXEMPT FROM
28 THE REQUIREMENT TO REPORT BILLS OR OTHER MEASURES TO THE
29 LEGISLATIVE COUNCIL AS SPECIFIED IN RULE 24 (b)(1)(D) AND RULE 24A
30 (d)(8) OF THE JOINT RULES OF THE SENATE AND THE HOUSE OF
31 REPRESENTATIVES AND IN SECTION 2-3-303 (1)(f), COLORADO REVISED
32 STATUTES. THE COMMITTEE IS SUBJECT TO RULE 24A OF THE JOINT RULES
33 OF THE SENATE AND HOUSE OF REPRESENTATIVES, EXCEPT TO THE EXTENT
34 THAT THE RULE MAY CONFLICT WITH THIS PART 19. BILLS RECOMMENDED
35 BY THE COMMITTEE MUST BE INTRODUCED BY THE INTRODUCTION
36 DEADLINE FOR HOUSE BILLS SPECIFIED IN RULE 23 (a)(1) OF THE JOINT
37 RULES OF THE SENATE AND HOUSE OF REPRESENTATIVES. THE CHAIR AND
38 VICE-CHAIR SHALL JOINTLY ESTABLISH THE LAST DATE FOR THE MEETING
39 AT WHICH THE COMMITTEE MAY APPROVE BILL REQUESTS, THE LAST DATE
40 BY WHICH COMMITTEE MEMBERS MUST FINALIZE BILL DRAFTS OR BY
41 WHICH BILL DRAFTS WILL BE DEEMED FINALIZED FOR FISCAL NOTE
42 PURPOSES, AND THE LAST DATE BY WHICH THE COMMITTEE WILL CONSIDER
43 AND TAKE FINAL ACTION ON BILL DRAFTS.

1 (d) THE COMMITTEE SHALL RECEIVE AND APPROVE THE REPORT OF
2 THE COMMISSION REQUIRED BY SECTION 2-3-1903 (2).".

3 Page 3, line 6, strike "**17-26-401.**" and substitute "**2-3-1902.**".

4 Page 3, line 8, strike "IN THE DEPARTMENT OF PUBLIC SAFETY".

5 Page 3, line 9, strike "PART 4" and substitute "PART 19", and strike
6 "CREATE" and substitute "RECOMMEND".".

7 Page 1 of the report, strike lines 3 and 4 and substitute:
8 "Page 3, line 11, strike "PART 4 AS "JAILS", AND UPDATE THE" and
9 substitute "PART 19 AS "JAILS".".

10 Page 2 of the report, line 2, strike ""JULY 31, 2022." and substitute
11 ""JULY 31, 2022. THE COMMISSION SHALL MEET MONTHLY. THE CHAIR OF
12 THE COMMITTEE SHALL APPOINT A CHAIR AND VICE-CHAIR FROM AMONG
13 THE COMMISSION MEMBERS.". ".

14 Page 2 of the report, strike line 4 and substitute:
15 "Page 6, line 4, strike "**17-26-402. Commission - duties - rules.**" and
16 substitute "**2-3-1903. Commission - duties - report.**". ".

17 Page 2 of the report, strike lines 14 through 19 and substitute:
18 "RECOMMENDATIONS AND PRESENT IT TO THE COMMITTEE FOR APPROVAL
19 BY NOVEMBER 15, 2023. THE DIRECTOR OF RESEARCH OF THE
20 LEGISLATIVE COUNCIL SHALL SUPPLY STAFF ASSISTANCE TO THE
21 COMMISSION, INCLUDING ASSISTING WITH COMPLETING THE REPORT. THE
22 DIRECTOR OF RESEARCH OF THE LEGISLATIVE COUNCIL SHALL NOT SUPPLY
23 STAFF ASSISTANCE TO ANY SUBCOMMITTEES CREATED BY THE
24 COMMISSION.". ".

25 Page 2 of the report, after line 20 insert:
26 "Page 21, line 5, strike "**17-26-403.**" and substitute "**2-3-1904.**", and
27 strike "PART 4" and substitute "PART 19".".

28 Page 2 of the report, after line 24 insert:
29 "Page 21, after line 20 insert:

30 "SECTION 4. Appropriation. For the 2022-23 state fiscal year,
31 \$96,039 is appropriated to the legislative department. This appropriation
32 is from the general fund. To implement this act, the department may use
33 this appropriation as follows:

1 (a) \$90,379 for use by the legislative council, which amount is
2 based on an assumption that the council will require an additional 0.9
3 FTE; and

4 (b) \$5,660 for use by the general assembly."

5 Renumber succeeding section accordingly.

6 Page 1, line 102, strike "JAILS." and substitute "JAILS, AND, IN
7 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
