After consideration on the merits, the Committee recommends the following:

HB22-1300 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, strike lines 1 through 6.

2 Reletter succeeding paragraphs accordingly.

3 Page 7, after line 14 insert:

4 "(VII) REQUIRING LICENSED MASSAGE THERAPISTS TO MAINTAIN  
5 COPIES OF VALID MASSAGE THERAPY LICENSURE, AS REQUIRED BY ARTICLE  
6 235 OF TITLE 12, THAT MUST BE IMMEDIATELY PRESENTED TO A LICENSING  
7 AUTHORITY, THE LICENSING AUTHORITY'S DESIGNEES, OR LAW  
8 ENFORCEMENT UPON REQUEST;"

9 Renumber succeeding subparagraphs accordingly.

10 Page 9, strike lines 3 through 7 and substitute "TO SUBSECTION (4)(a)(III)  
11 OF THIS SECTION, THE COUNTY SHERIFF'S OFFICE SHALL CONDUCT A  
12 BACKGROUND CHECK ON THE APPLICANT'S OR LICENSEE'S CRIMINAL  
13 HISTORY RECORD AND PROVIDE THE LOCAL LICENSING AUTHORITY, OR THE  
14 LICENSING AUTHORITY'S DESIGNEE, INFORMATION TO DETERMINE  
15 WHETHER THE APPLICANT OR LICENSEE IS APPROVED OR DENIED FOR A  
16 LICENSE BASED ON THE CRIMINAL HISTORY RECORD INFORMATION. IN THE  
17 EVENT THE".

18 Page 13, line 10, strike "REQUIRES:" and substitute "REQUIRES, "ILLCIT  
19 MESSAGE BUSINESS" MEANS A BUSINESS THAT MAY PROVIDE MASSAGE  
20 BUT ENGAGES IN HUMAN TRAFFICKING-RELATED OFFENSES, AS DESCRIBED  
21 IN SECTIONS 18-3-503 AND 18-3-504."

1 Page 13, strike lines 11 through 19.

2 Page 13, line 24, strike "THE COLORADO".

3 Page 13, strike lines 25 through 27 and substitute "THE MUNICIPAL POLICE  
4 DEPARTMENT SHALL CONDUCT A BACKGROUND CHECK ON THE  
5 APPLICANT'S OR LICENSEE'S CRIMINAL HISTORY RECORD AND PROVIDE THE  
6 MUNICIPALITY INFORMATION TO DETERMINE WHETHER THE APPLICANT OR  
7 LICENSEE IS APPROVED OR DENIED FOR A LICENSE BASED ON THE CRIMINAL  
8 HISTORY RECORD INFORMATION."

9 Page 14, strike line 1.
