After consideration on the merits, the Committee recommends the following:

<u>HB23-1043</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 4, line 21, strike "FIVE" and substitute "SEVEN".
- 2 Page 4, line 23, strike "FIFTEEN" and substitute "FOURTEEN".
- 3 Page 4, line 27, strike "AND" and substitute "OR".
- Page 5, line 1, strike "THE" and substitute "THE COUNTY DEPARTMENT
  SHALL NOTIFY THE PARTIES TO THE CASE. WITHIN SEVENTY-TWO HOURS
  OF NOTIFICATION, ANY PARTY WANTING THE CHILD OR YOUTH TO REMAIN
  IN THAT PLACEMENT SHALL FILE A MOTION WITH THE COURT REGARDING
  PLACEMENT OF THE CHILD OR YOUTH. THE".
- 9 Page 5, line 3, strike "IMMEDIATELY".
- 10 Page 5, strike lines 4 and 5 and substitute "CUSTODY OF THE RELATIVE OR
- 11 KIN IF NO PARTY, WITH PROPER NOTIFICATION, HAS FILED A MOTION TO
- 12 MAINTAIN THE CHILD OR YOUTH IN THE PLACEMENT WITHIN SEVENTY-TWO
- 13 HOURS. THE COUNTY DEPARTMENT".
- 14 Page 5, line 6, strike "FIFTEEN" and substitute "FOURTEEN".
- 15 Page 5, strike lines 11 and 12 and substitute:
- 16 "(3) A COUNTY DEPARTMENT SHALL CONDUCT OR REQUEST THAT17 A".

Page 5, line 16, strike "KIN. WHEN" and substitute "KIN ON ANON-EMERGENCY BASIS, WHEN".

- 1 Page 5, line 17, strike "NON-COURT BASIS," and substitute 2 "NON-COURT-INVOLVED BASIS, WHEN".
- Page 5, line 18, strike "CUSTODY OR" and substitute "CUSTODY, OR WHEN
  THE COUNTY HAS".
- 5 Page 5, line 22, strike "DEPARTMENT, WHEN THE" and substitute 6 "DEPARTMENT;".
- 7 Page 5, strike line 23 and substitute "OR ANOTHER".
- 8 Page 6, line 24, strike "IMMEDIATELY".

Page 6, line 26, after "COURT," insert "OR IF NO PARTY, WITH PROPER
NOTIFICATION, HAS FILED A MOTION TO MAINTAIN THE CHILD OR YOUTH IN
THE PLACEMENT WITHIN SEVENTY-TWO HOURS,".

12 Page 7, line 2, after the period add "THE COURT MAY ORDER THE REPORTS 13 OF FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECKS FROM THE 14 COLORADO BUREAU OF INVESTIGATION OR FROM THE FEDERAL BUREAU OF 15 INVESTIGATION THAT WERE RELIED UPON BY THE COUNTY TO EVALUATE 16 THE PLACEMENT TO BE RELEASED BY THE COUNTY DEPARTMENT AFTER 17 PROVIDING AN OPPORTUNITY FOR THE INDIVIDUAL WHOSE RESULTS WOULD 18 BE RELEASED TO OBJECT OR REQUEST APPROPRIATE PROTECTIONS OR 19 **REDACTIONS.".** 

Page 7, strike line 18 and substitute "SECTION 18-1.3-406 (2)(a)(I),
EXCLUDING THE CONVICTION OF ESCAPE;".

Page 7, line 27, strike "18-3-203;" and substitute "18-3-203, WITHIN THE
PRECEDING FIVE YEARS;".

Page 8, strike line 2 and substitute "THREE YEARS. IF THE RELATIVE OR KIN
HAS A FELONY DRUG-RELATED CONVICTION LESS THAN FIVE YEARS PRIOR,
ANY KINSHIP OR GUARDIANSHIP ASSISTANCE PAYMENTS ON BEHALF OF THE
CHILD OR YOUTH MUST NOT BE MADE WITH FEDERAL MONEY PROVIDED
PURSUANT TO TITLE IV-E OF THE FEDERAL "SOCIAL SECURITY ACT", AS
AMENDED.".

Page 8, line 3, strike "CONVICTIONS," and substitute "CONVICTIONS
RELATED TO DOMESTIC VIOLENCE,".

- 1 Page 8, line 16, strike "AUTOMATED DATABASE" and substitute "CHILD
- 2 WELFARE INFORMATION SYSTEM AND THE EQUIVALENT REGISTRIES AND
- $3 \qquad {\sf DATABASES} {\rm \, IN\, OTHER\, STATES} {\rm \, IF\, THE\, INDIVIDUAL\, HAS\, RESIDED\, IN\, ANOTHER}$
- 4 STATE IN THE PRIOR FIVE YEARS, AS PRESCRIBED BY RULE,".
- 5 Page 8, strike lines 20 and 21 and substitute "NEGLECT; AND".
- 6 Page 8, line 26, before "TO" insert "AND THE EQUIVALENT REGISTRIES AND
- 7 DATABASES IN OTHER STATES IF THE INDIVIDUAL HAS RESIDED IN ANOTHER
- 8 STATE IN THE PRIOR FIVE YEARS, AS PRESCRIBED IN RULE,".
- 9 Page 9, lines 11 and 12, strike "BEFORE THE COURT".
- 10 Page 11, lines 21 and 22, strike "A DEFERRED PROSECUTION
- 11 AGREEMENT,".
