After consideration on the merits, the Committee recommends the following:

HB23-1089 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, line 17, strike "REMAINS" and substitute "IS".
- 2 Page 2, line 18, strike "WITHIN THE SCHOOL DISTRICT".
- 3 Page 2, line 19, strike "OF THE SCHOOL OF ORIGIN." and substitute "OTHER
4 THAN AN APPROVED FACILITY SCHOOL, AS DEFINED IN SECTION 22-2-402,
5 OR A STATE-LICENSED DAY TREATMENT FACILITY AND WAS CONSIDERED
6 A RESIDENT OF THE SCHOOL DISTRICT AT THE TIME THE CHILD BECAME A
7 STUDENT IN OUT-OF-HOME PLACEMENT OR AT THE TIME OF ENROLLMENT
8 IN THE SCHOOL OF ORIGIN, WHICHEVER IS MOST RECENT."
- 9 Page 3, line 10, after "22-32-138," insert "OTHER THAN AN APPROVED
10 FACILITY SCHOOL, AS DEFINED IN SECTION 22-2-402, OR A STATE-LICENSED
11 DAY TREATMENT FACILITY,".
- 12 Page 3, after line 11 insert:
13 "SECTION 3. In Colorado Revised Statutes, 19-3-208, add (3)(e)
14 as follows:
15 **19-3-208. Services - county required to provide - out-of-home**
16 **placement options - rules - definitions.** (3) (e) THE DEPARTMENT SHALL
17 CONVENE A WORKING GROUP WITHIN SIX MONTHS AFTER THE EFFECTIVE
18 DATE OF THIS SUBSECTION (3)(e), INCLUDING THE DEPARTMENT OF
19 EDUCATION, COUNTY DEPARTMENTS OF HUMAN AND SOCIAL SERVICES,
20 REPRESENTATIVES FROM THE SPECIAL EDUCATION DIRECTORS, AND OTHER
21 APPROPRIATE SCHOOL DISTRICT REPRESENTATIVES, TO IDENTIFY ISSUES
22 RELATED TO FOSTER YOUTH EDUCATION, TRANSPORTATION, AND
23 STABILITY, AS DESCRIBED IN THIS SUBSECTION (3), AND TOGETHER, PRIOR
24 TO THE 2025 REGULAR LEGISLATIVE SESSION, DEVELOP WRITTEN

- 1 RECOMMENDATIONS TO THE GENERAL ASSEMBLY REGARDING ANY
- 2 REGULATORY OR STATUTORY CHANGES THAT MAY BE REQUIRED.".
