After consideration on the merits, the Committee recommends the following:

HB23-1107 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Judiciary Committee Report, dated March 1, 2023, and
- 2 substitute:
  
- 3 "Amend page 2 of the printed bill, strike lines 2 through 20.
  
- 4 Page 3 of the bill, strike lines 1 through 16.
  
- 5 Renumber succeeding sections accordingly.
  
- 6 Page 4 of the bill, strike lines 18 through 27.
  
- 7 Page 5 of the bill, strike lines 1 through 12.
  
- 8 Renumber succeeding sections accordingly.
  
- 9 Page 6 of the bill, lines 15 and 16, strike "2023-24 AND FOR EACH STATE
- 10 FISCAL YEAR THEREAFTER," and substitute "2024-25".
  
- 11 Page 6 of the bill, line 17, strike SEVEN MILLION FIVE HUNDRED
- 12 THOUSAND" and substitute "THREE MILLION".
  
- 13 Page 6 of the bill, after line 20, insert:
- 14 "SECTION 3. In Colorado Revised Statutes, 24-32-120, **add**
- 15 (1)(c)(V) as follows:
- 16 **24-32-120. Justice reinvestment crime prevention initiative -**
- 17 **program - rules - cash funds - reports - repeal.** (1) (c) (V) (A) ON
- 18 JULY 1, 2024, THE STATE TREASURER SHALL TRANSFER ALL UNEXPENDED
- 19 AND UNENCUMBERED MONEY IN THE FUND TO THE STATE DOMESTIC

1 VIOLENCE AND SEXUAL ASSAULT SERVICES FUND CREATED IN SECTION  
2 26-7.5-105 (4).

3 **SECTION 4.** In Colorado Revised Statutes, 25-20.5-801, **amend**  
4 (9)(e) as follows:

5 **25-20.5-801. Community crime victims grant program -**  
6 **created - cash fund - repeal.** (9) (e) The state treasurer shall transfer all  
7 unexpended and unencumbered money in the fund on ~~September 1, 2024,~~  
8 AUGUST 31, 2023, to the general fund.

9 **SECTION 5. Effective date.** This act takes effect upon passage;  
10 except that section 4 of this act takes effect only if Senate Bill 23-160  
11 does not become law."

12 Renumber succeeding section accordingly."
