Committee on Judiciary.

After consideration on the merits, the Committee recommends the following:

HB23-1107 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, strike line 11 and substitute:
2 "(b) FOR".
- 3 Page 2, line 12, strike "SECTION, FOR".
- 4 Page 3, strike lines 3 through 16.
- 5 Page 4, line 21, strike "FOR" and substitute "EXCEPT AS DESCRIBED IN
6 SUBSECTION (1.5)(d)(II) OF THIS SECTION, FOR".
- 7 Page 4, after line 26 insert:
8 "(II) BEGINNING IN STATE FISCAL YEAR 2024-25, THE GENERAL
9 ASSEMBLY MAY APPROPRIATE LESS THAN THE AMOUNT REQUIRED
10 PURSUANT TO SUBSECTION (1.5)(d)(I) OF THIS SECTION FOR A STATE
11 FISCAL YEAR AND INSTEAD APPROPRIATE THE DIFFERENCE BETWEEN THE
12 AMOUNT ACTUALLY APPROPRIATED AND THE MINIMUM AMOUNT REQUIRED
13 TO THE COLORADO CRIME VICTIM SERVICES FUND CREATED IN SECTION
14 24-33.5-505.5. IN DETERMINING WHETHER TO REDUCE THE
15 APPROPRIATION, THE GENERAL ASSEMBLY SHALL CONSIDER THE
16 RECOMMENDATION OF THE DEPARTMENT OF PUBLIC SAFETY SUBMITTED
17 PURSUANT TO SUBSECTION (1.5)(d)(III) OF THIS SECTION."
- 18 Page 4, line 27, strike "(II)" and substitute "(III)".
- 19 Page 5, strike lines 3 through 6 and substitute "GENERAL ASSEMBLY
20 SHOULD REDUCE THE APPROPRIATION TO THE FUND CREATED IN THIS
21 SECTION, AS PERMITTED IN SUBSECTION (1.5)(d)(II) OF THIS SECTION, AND

1 APPROPRIATE ADDITIONAL MONEY TO THE".

2 Page 6, line 17, strike "SEVEN" and substitute "SIX".

3 Page 6, after line 20, insert:

4 "SECTION 5. In Colorado Revised Statutes, 25-20.5-801, amend
5 (9)(e) as follows:

6 **25-20.5-801. Community crime victims grant program -**
7 **created - cash fund - repeal.** (9) (e) The state treasurer shall transfer all
8 unexpended and unencumbered money in the fund on ~~September 1, 2024,~~
9 AUGUST 31, 2023, to the general fund.

10 SECTION 6. In Colorado Revised Statutes, 25-20.5-801, amend
11 (9)(e); and add (11) as follows:

12 **25-20.5-801. Community crime victims grant program -**
13 **created - cash fund - repeal.** (9) (e) The state treasurer shall transfer all
14 unexpended and unencumbered money in the fund on ~~September 1, 2024,~~
15 AUGUST 31, 2028, to the general fund.

16 (11) ON SEPTEMBER 1, 2023, AND ON JULY 1 EACH YEAR
17 THEREAFTER, THE STATE TREASURER SHALL TRANSFER ONE MILLION
18 DOLLARS TO THE COMMUNITY CRIME VICTIMS GRANT PROGRAM CASH
19 FUND CREATED IN SUBSECTION (9) OF THIS SECTION.

20 SECTION 7. **Effective date.** (1) Except as otherwise provided
21 in this section, this act takes effect upon passage.

22 (2) Section 5 of this act takes effect only if Senate Bill 23-160
23 does not become law.

24 (3) Section 6 of this act takes effect only if Senate Bill 23-160
25 becomes law, in which case section 6 take effect upon the effective date
26 of this act or Senate Bill 23-160, whichever is later."

27 Renumber succeeding section accordingly.
