Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB23-1198 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Education Committee Report, dated March 8, 2023, page 1,
2 strike lines 6 and 7 and substitute:
 - 3 "Page 3 of the printed bill, line 17, strike "**rules.**" and substitute "**rules -**
4 **repeal.**".
 - 5 Page 4 of the bill, line 1, strike "THREE" and substitute "ONE".
 - 6 Page 4 of the bill, line 2, strike "MODELS" and substitute "MODEL".
 - 7 Page 4 of the bill, strike lines 21 through 23 and substitute:
 - 8 "(III) ELIGIBILITY REQUIREMENTS FOR LOCAL EDUCATION
9 PROVIDERS TO RECEIVE DIRECT PAYMENTS."."
- 10 Page 1 of the report, after line 11 insert:
 - 11 "Page 5 of the bill, strike lines 11 and 12 and substitute "TO PARTICIPATE
12 IN THE EXTERNSHIP PROGRAM, THE DEPARTMENT MAY ALLOCATE MONEY
13 DIRECTLY TO".
- 14 Page 1 of the report, after line 13 insert:
 - 15 "Page 5 of the bill, line 15, strike "EMPLOYER; OR" and substitute
16 "EMPLOYER."
- 17 Page 5 of the bill, strike lines 16 through 18."

1 Page 2 of the report, after line 8 insert:

2 "Page 6 of the bill, after line 19 insert:

3 "(8) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1,
4 2025."."

5 Page 2 of the report, strike line 9 and substitute:

6 "Page 7 of the bill, strike lines 15 through 27.

7 Strike page 8 of the bill.

8 Page 9 of the bill, strike lines 1 through 25.

9 Page 9 of the bill, before line 26 insert:

10 **"SECTION 4. Appropriation.** For the 2023-24 state fiscal year,
11 \$223,039 is appropriated to the department of labor and employment for
12 use by the division of employment and training. This appropriation is
13 from the general fund and is based on an assumption that the division will
14 require an additional 0.8 FTE. To implement this act, the division may
15 use this appropriation for the STEM teacher externship program. Any
16 money appropriated in this section not expended prior to July 1, 2024, is
17 further appropriated to the division for the 2024-25 state fiscal year for
18 the same purpose."

19 Page 1 of the bill, strike lines 104 through 106 and substitute
20 **"DISCIPLINES, AND, IN CONNECTION THEREWITH, MAKING AN**
21 **APPROPRIATION."**
