After consideration on the merits, the Committee recommends the following:

SB23-051 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 6, line 23, strike "and (15); **repeal** (10) and
- 2 (17);" and substitute "(15), and (17); **repeal** (10);".
- 3 Page 8, line 2, strike ""COUNCIL" and substitute ""COMMITTEE".
- 4 Page 8, line 3, strike "COUNCIL" and substitute "COMMITTEE".
- 5 Page 8, line 5, strike ""COUNCIL" and substitute ""COMMITTEE".
- 6 Page 8, line 6, strike "COUNCIL" and substitute "COMMITTEE".
- 7 Page 9, strike lines 19 and 20 and substitute:
  - 8 "(17) "State apprenticeship council" or "SAC" means the state
  - 9 apprenticeship council ~~created in~~ ESTABLISHED PURSUANT TO section
  - 10 ~~8-15.7-103~~ 8-15.7-105."
- 11 Page 9, line 22, after "**add**" insert "(1)(b.5) and".
- 12 Page 10, after line 4, insert:
  - 13 "(b.5) ESTABLISH THE STATE APPRENTICESHIP COUNCIL, WHICH
  - 14 OPERATES UNDER THE DIRECTION OF THE SAA, TO PROVIDE ADVICE AND
  - 15 GUIDANCE TO THE SAA;".
- 16 Page 10, strike lines 10 and 11 and substitute "SUPPORT TO THE SAC IN
- 17 CARRYING OUT ITS DUTIES;".

- 1 Page 12, line 17, strike "**Council**" and substitute "**Committee**".
- 2 Page 12, line 19, strike "COUNCIL" and substitute "to oversee  
3 COMMITTEE".
- 4 Page 12, line 20, strike "to oversee" and substitute "AS A SUBCOMMITTEE  
5 OF THE SAC TO ADVISE THE SAA ON".
- 6 Page 13, line 9, strike "shall:" and substitute "shall PERFORM THE  
7 FOLLOWING DUTIES AS A SUBCOMMITTEE OF THE SAC:".
- 8 Page 14, line 19, strike "**Council**" and substitute "**Committee**".
- 9 Page 14, line 22, strike "COUNCIL" and substitute "to oversee  
10 COMMITTEE".
- 11 Page 14, lines 22 and 23, strike "to oversee" and substitute "AS A  
12 SUBCOMMITTEE OF THE SAC TO ADVISE THE SAA ON".
- 13 Page 15, line 14, strike "shall:" and substitute "shall PERFORM THE  
14 FOLLOWING DUTIES AS A SUBCOMMITTEE OF THE SAC:".
- 15 Page 16, strike lines 22 through 27.
- 16 Page 17, strike lines 1 through 12 and substitute:
- 17 **"SECTION 7.** In Colorado Revised Statutes, **amend 8-15.7-105**  
18 as follows:
- 19 **8-15.7-105. State apprenticeship council - created - members**  
20 **powers - duties.** (1) (a) ~~The chairs of the SAC and the IAC shall~~  
21 ~~establish an ad hoc joint resolution committee of the SAC and IAC,~~  
22 ~~referred to in this section as the "ad hoc committee". The ad hoc~~  
23 ~~committee consists of two members from both the IAC and the SAC~~  
24 ~~appointed by the director. The ad hoc committee shall resolve conflicts~~  
25 ~~that arise between the SAC and the IAC and shall define the jurisdiction~~  
26 ~~of the SAC and the IAC.~~ THE DIRECTOR SHALL ESTABLISH THE STATE  
27 APPRENTICESHIP COUNCIL TO PROVIDE ADVICE AND GUIDANCE TO THE  
28 STATE APPRENTICESHIP AGENCY ON THE OPERATION OF THE STATE'S  
29 APPRENTICESHIP SYSTEM.
- 30 (b) THE SAC:
- 31 (I) IS COMPOSED OF PERSONS FAMILIAR WITH APPRENTICEABLE  
32 OCCUPATIONS;
- 33 (II) INCLUDES AN EQUAL NUMBER OF REPRESENTATIVES OF

1 EMPLOYER AND EMPLOYEE ORGANIZATIONS AND INCLUDES MEMBERS OF  
2 THE PUBLIC WHO MUST NOT NUMBER MORE THAN THE NUMBER OF  
3 REPRESENTATIVES OF EITHER EMPLOYER OR EMPLOYEE ORGANIZATIONS;  
4 (III) INCLUDES ALL THE MEMBERS OF THE CABCT AND CANEI;  
5 (c) THE CHAIRS OF THE CABCT AND CANEI SHALL SERVE AS  
6 CO-CHAIRS OF THE SAC.  
7 (1.5) THE SAC MAY CONVENE ADDITIONAL SUBCOMMITTEES AS  
8 NEEDED TO FULFILL ITS DUTIES.  
9 (2) The ~~ad hoc committee of the SAC and the IAC~~ SAC shall:  
10 (a) Publish a statement defining the SAC's CABCT's jurisdiction  
11 of the building and construction trades, and update the statement  
12 periodically as necessary as determined by the ~~ad hoc committee~~ SAC;  
13 and  
14 (b) Resolve conflicts and complaints that arise between the SAC  
15 CABCT and the ~~IAC~~ CANEI as determined by the ~~ad hoc committee~~  
16 SAC.  
17 (3) If there is a tie among the ~~ad hoc committee~~ SAC members in  
18 determining a resolution to a conflict, the director shall break the tie. A  
19 decision of the ~~ad hoc committee~~ SAC is final."

20 Page 17, after line 21 insert:

21 "(b) Apprentices in the apprenticeship program will be employed  
22 by licensed contractors."

23 Page 38, strike lines 10 through 18 and substitute:

24 "**SECTION 40. Safety clause.** The general assembly hereby  
25 finds, determines, and declares that this act is necessary for the immediate  
26 preservation of the public peace, health, or safety."
