- 14 CRIMINAL SENTENCING AS DESCRIBED IN SUBSECTION (8)(a)(I) OF THIS
- 15 SECTION; EXCEPT THAT, THE UPDATE IS NOT REQUIRED IF THE COMMISSION
- 16 HAS MADE A FINAL RECOMMENDATION TO THE GENERAL ASSEMBLY
- 17 CONCERNING SENTENCING REFORM.".
- Page 2, line 16, strike "REPORT" and substitute "REPORTS" and strike "IS"
- 19 and substitute "ARE".
- 20 Page 2, line 18, strike "NOVEMBER 15, 2023." and substitute "THE
- 21 DEADLINE TO SUBMIT THE REPORT".
- 22 Page 2, line 19, strike "2024." and substitute "2025.".

- 1 Page 3, strike lines 1 through 16.
- 2 Renumber succeeding section accordingly.
- 3 Page 1, strike lines 102 through 104 and substitute "CONFINEMENT.".
