After consideration on the merits, the Committee recommends the following:

SB23-202 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, strike lines 10 through 13, and substitute:  
2       "(b) "QUALIFYING STUDENT" MEANS A STUDENT THAT IS A  
3 DESCENDANT OF PEOPLE WHO WERE LIVING IN NORTH AMERICA PRIOR TO  
4 THE TIME PEOPLE FROM EUROPE BEGAN SETTLING IN NORTH AMERICA, IS  
5 AN ENROLLED MEMBER OF A FEDERALLY RECOGNIZED OR  
6 STATE-RECOGNIZED INDIAN TRIBE, OR IS A LINEAL DESCENDANT OF A  
7 TRIBALLY ENROLLED PARENT OR GRANDPARENT."

8 Page 2, line 19, strike "FEATHERS." and substitute "FEATHERS, IN LINE  
9 WITH THE MIGRATORY BIRD TREATY ACT OF 1918."

10 Page 3, strike lines 10 and 11, and substitute:  
11       "(III) IS A LINEAL DESCENDANT OF A TRIBALLY ENROLLED PARENT  
12 OR GRANDPARENT."

13 Page 3, strike lines 22 through 24.

14 Page 4, strike lines 10 through 13, and substitute:  
15       "(c) "QUALIFYING STUDENT" MEANS A STUDENT THAT IS A  
16 DESCENDANT OF PEOPLE WHO WERE LIVING IN NORTH AMERICA PRIOR TO  
17 THE TIME PEOPLE FROM EUROPE BEGAN SETTLING IN NORTH AMERICA, IS  
18 AN ENROLLED MEMBER OF A FEDERALLY RECOGNIZED OR STATE-  
19 RECOGNIZED INDIAN TRIBE, OR IS A LINEAL DESCENDANT OF A TRIBALLY  
20 ENROLLED PARENT OR GRANDPARENT."

21 Page 4, line 19, strike "FEATHERS." and substitute "FEATHERS, IN LINE  
22 WITH THE MIGRATORY BIRD TREATY ACT OF 1918."

- 1 Page 5, strike lines 9 and 10, and substitute:
- 2 "(III) IS A LINEAL DESCENDANT OF A TRIBALLY ENROLLED PARENT
- 3 OR GRANDPARENT."
  
- 4 Page 5, strike lines 18 through 20.
