30 It has been an honor to serve and represent House District 4 in the
31 Colorado General Assembly for the last five years, and it is with sincere
32 gratitude that I submit my resignation effective August 4, 2023.
33
34 I am grateful for the opportunities I had to work on various issues
35 including helping my constituents and people across the state of Colorado
36 in accessing and strengthening basic human rights. In my service at the
37 legislature, I had the privilege to serve as the Assistant Majority Leader
38 in the 2021 and 2022 legislative sessions and the Vice Chair to the
39 Behavioral Health Transformational Task Force in 2021. I have also
40 valued my time with the Colorado Democratic Latino Caucus, which
41 doubled our representation in the Legislature to 14 members. I am
42 hopeful that we will reach parity in the future.
43

1 I am proud to have been a part of the positive changes made during my
 2 tenure and know that there is more to be done. I have full faith in my
 3 legislative colleagues and the future House District 4 Representative —
 4 I hope they will continue to pass policies that prioritize the Coloradans
 5 who don't have the loudest voices but are closest to the pain, those who
 6 are most impacted and are not privileged to have paid corporate lobbyists
 7 at the Capitol. I trust that they will continue to work on policies so that
 8 Coloradans can access affordable housing and healthcare, and that people
 9 who are housed can keep their housing and those that are unhoused,
 10 struggling with substance use or mental health issues are treated with
 11 dignity and support. I am asking my colleagues to break down oppressive
 12 systems that continue to disproportionately prosecute, incarcerate, and
 13 create barriers for adults and children of color to thrive in our state. As I
 14 have often done over the past five years, I leave reminding my colleagues
 15 that they are there to represent the PEOPLE, not special interests.

 17 I thank my colleagues in the Colorado House and the Senate. I thank the
 18 many staff, both partisan and non-partisan, from maintenance to drafters
 19 to custodial, for your passion and commitment to ensuring the people's
 20 house is operational. I thank the people of House District 4 for electing
 21 me to serve our community for the last five years. Lastly, I thank my
 22 family for their ongoing support and patience while I navigated the halls
 23 of the Capitol. Although I am leaving the Legislature, I will not be going
 24 far. As I assume my role as Denver City Councilperson at-large, I will
 25 have the great opportunity to return my focus back to the City and County
 26 of Denver, where I have served kids and families for the last two decades.
 27 I am excited to continue to serve the people of Denver and Colorado.

48 **Call for the First Extraordinary Session**
49 **of the Seventy-Fourth General Assembly**

50
51 Pursuant to the authority vested in the Governor of the State of Colorado
52 and, in particular, pursuant to article IV, section 9 of the Colorado
53 Constitution, and as recognized in article V, section 7, I, Jared Polis,
54 Governor of the State of Colorado, hereby find that the following
55 extraordinary occasions exist to convene the Seventy-Fourth General
56 Assembly to meet in special session.

1 I. Background

2
3 With home values rising at historic rates across Colorado,
4 Coloradans face an immediate crisis with a forty-percent average increase
5 in their property tax bills if property tax bills are not reduced. Taxpayers
6 are facing higher property tax bills not just this year but in future years,
7 and these are immediate, statewide concerns. Increased property taxes
8 make it harder for Coloradans to stay in their homes, build wealth, and
9 save for the future. Increasing property taxes not only impacts
10 homeowners but also renters that bear the burden of increased costs on
11 landlords. Renters are most vulnerable to increased property taxes
12 because they do not benefit from the corresponding gain in equity,
13 making it harder for hardworking Colorado renters to thrive and have
14 economic freedom. The skyrocketing values affect Coloradans' ability to
15 afford housing costs and an inflationary economy with higher interest
16 rates is making it difficult for fixed-income seniors to stay in a home that
17 was once affordable. Colorado taxpayers deserve and need bipartisan
18 solutions now.

19
20 SB23-303 (presented to voters as Proposition HH) proposed
21 reducing assessment rates and limiting the growth in property tax
22 collections to protect Colorado homeowners. It would have replaced
23 revenue lost to local governments by setting aside \$200 million in general
24 fund and raising the state Taxpayer's Bill of Rights (TABOR) revenue
25 limit for ten years. If Proposition HH had passed, it would have provided
26 immediate relief for nonresidential and residential property owners in
27 Colorado through 2032 without jeopardizing the revenue that goes to
28 support fire districts, libraries, and schools. It also would have created a
29 new subclass of renewable energy agricultural land for valuation for
30 assessment and made the senior homestead exemption portable to give
31 seniors more flexibility to downsize or move to a new property without
32 losing the exemption. SB 23-303 addressed subject matter of significance
33 to the people of Colorado.

34
35 Without the passage of Proposition HH at the ballot, there remains
36 an immediate and dire need for solutions to help Coloradans impacted by
37 rising property values. Some counties have warned homeowners that they
38 should expect a forty to fifty percent increase in their 2024 and 2025
39 property tax bills. For Colorado's working families, the blow of higher
40 property tax is felt in the greater context of rise in interest and inflation
41 rates and cost of living. The General Assembly has the opportunity to
42 provide support and optimism for families as they face next year,
43 especially for the critical low-and-moderate income families that use
44 income tax credits to pay for food and housing costs.

45
46 I am calling this extraordinary session to ask the General Assembly
47 to put people over politics by taking immediate action to provide
48 Colorado taxpayers relief that also balances the interests of local entities
49 funded with property tax revenue. The General Assembly now has the
50 ability to propose a solution that would provide property tax savings to
51 Coloradans while still fully funding schools. As property taxes for 2023
52 become due in early 2024, Coloradans cannot logistically receive
53 additional tax savings for this tax year without the immediate passage of
54 new residential property tax measures. Colorado law sets forth deadlines
55 by which local governments administer property tax. This extraordinary

1 session must begin on November 17, 2023 in order to give local
2 jurisdictions time to administer the new valuations, set levies, and meet
3 the first payment deadline.

4
5 Additionally, low-income Colorado children will benefit from
6 access to food during the summer months when they are not in school,
7 and I am asking the General Assembly to take immediate action to
8 support our children. The Colorado Department of Human Services
9 (CDHS) requires immediate legislative action to meet a federal deadline
10 to access federal Summer Electronic Benefits Transfer (EBT) funding for
11 over 300,000 food-insecure Colorado children during the summer of
12 2024. Without sufficient clarity prior to the Second Regular Session of
13 the Seventy-Fourth General Assembly, Colorado risks not being able to
14 provide families with needed support to prevent hunger during the
15 summer of 2024.

16
17 This call for an extraordinary session of the General Assembly
18 does not prescribe the specific form that the legislation should take;
19 however, as required by Article IV, section 9 of the Colorado
20 Constitution, the business to be transacted at this special session shall be
21 limited to the matters stated in Section III of this Executive Order.

22 23 II. Purpose and Need

24 25 A. Residential Property Tax Relief

26
27 With Colorado housing values among those increasing the fastest
28 in the nation, we must urgently work together to provide solutions to
29 Colorado homeowners facing significant property tax bill increases. We,
30 therefore, believe it is right and proper to provide immediate relief for the
31 next year, two years, or longer that balances the interests of Colorado
32 taxpayers and essential local government revenue needs like fire
33 department services and school funding.

34
35 The General Assembly should consider taking legislative action to
36 create a property tax relief package to offset value increases that also
37 balances the interests of schools and local governments that are funded
38 with property tax. This could include but is not limited to changes to
39 reserve policy, general fund, and TABOR tax refund mechanisms.

40
41 Simultaneously, to ensure that we are protecting Colorado
42 taxpayers from future extreme property tax increases and being fiscally
43 responsible, the General Assembly should also consider creating and
44 providing a process to review and recommend long-term property tax
45 relief. The General Assembly should consider a review of best practices
46 to create property tax relief for homeowners and businesses, while
47 preventing lapses in the administration of public services by local
48 governments that rely on property tax revenue to provide such public
49 services, and make legislative changes to create long-term tax relief and
50 stability for Colorado homeowners and businesses.

51 52 B. Resources to Enable Colorado's Families to Receive Summer EBT

53
54 In 2022, Congress enacted the Consolidated Appropriations Act
55 (PL 117-328), increasing access to meals for children during the summer
56 months. Summer EBT is a new, permanent federal program to provide

1 nutrition benefits to qualifying families for the months in which students
2 are not in school. By participating in the program, Colorado would
3 receive an estimated \$35 million annually for over 300,000 food-insecure
4 Colorado children during the critical summer months when there is
5 limited access to other resources such as the free and reduced lunch
6 program. States have until January 1, 2024 to provide the U.S.
7 Department of Agriculture with an intent to administer the program for
8 summer 2024. The need to rapidly establish systems and structures for
9 this new program necessitates immediate action before the Second
10 Regular Session of the 74th General Assembly to reduce the risk of
11 non-compliance.

12

13 Given this critical timeline, the General Assembly should consider
14 taking appropriate legislative action to allow the CDHS to establish and
15 administer this program in partnership with CDE beginning in summer
16 2024. Such action should include but is not limited to providing resources
17 for program administration and establishing relevant departmental
18 authorities, including the authority to issue benefits, promulgate rules, and
19 access the data needed for the purposes of administering the Summer
20 EBT program in accordance with federal law.

21

22 III. Proclamation

23

24 I, Jared Polis, Governor of the State of Colorado, with this proclamation
25 find extraordinary occasions exist to convene the Seventy-Fourth General
26 Assembly of this State and summon the members of the Seventy-Fourth
27 General Assembly to meet in Special Session at 9:00 AM on November
28 17, 2023, at the State Capitol, in the City and County of Denver, and
29 designate the following specific subjects for consideration, appropriate
30 legislative action, and finding:

31

32 A. Concerning a property tax relief package to reduce Coloradans'
33 property tax burden in 2023.

34

35 B. Concerning the fiscal impact of the tax relief package on the
36 interests of schools and local governments that are funded with property
37 tax potentially utilizing reserves, TABOR surplus, and general fund.

38

39 C. Concerning necessary administrative changes attributed to the
40 tax relief package only for 2023.

41

42 D. Concerning TABOR tax refund mechanisms only for 2023.

43

44 E. Concerning rental assistance only during the 2022-2023 fiscal
45 year.

46 F. Concerning adjustments to the Earned Income Tax Credit only
47 for the 2023 tax year, utilizing resources available from 2022-2023 fiscal
48 year.

49

50 G. Concerning the creation of a process to review and make
51 recommendations on long-term property tax relief.

52

53 H. Concerning the nutrition of over 300,000 food-insecure
54 Colorado children during the summer months by establishing
55 departmental authority to authorize the Summer Electronic Benefits
56 Transfer program in Colorado beginning in summer 2024.
