After consideration on the merits, the Committee recommends the following:

HB24-1174 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 5, line 3, after the period, add "THE EIGHT
2 HOURS OF INSTRUCTION IN A COURSE DO NOT NEED TO BE CONSECUTIVE."
- 3 Page 6, line 1, strike "SCORE" and substitute "SCORE, AS DETERMINED BY
4 THE INSTRUCTOR,".
- 5 Page 6, line 3, strike "AMMUNITION;" and substitute "AMMUNITION AND
6 WHICH DOES NOT NEED TO BE CONDUCTED IN A SINGLE DAY;".
- 7 Page 6, line 6, strike "DEVELOPED OR ADOPTED" and substitute "THAT
8 MEETS THE MINIMUM REQUIREMENTS FOR THE EXAM ESTABLISHED".
- 9 Page 6, line 7, strike "(6)(b)" and substitute "(6)".
- 10 Page 6, line 17, strike "DEVELOPED OR ADOPTED" and substitute "THAT
11 MEETS THE MINIMUM REQUIREMENTS FOR THE EXAM ESTABLISHED".
- 12 Page 6, line 18, strike "(6)(b)" and substitute "(6)".
- 13 Page 6, line 25, strike "SCORE" and substitute "SCORE, AS DETERMINED BY
14 THE INSTRUCTOR,".
- 15 Page 7, line 16, strike "(a)".
- 16 Page 7, line 18, strike "REQUIREMENTS" and substitute "MINIMUM
17 REQUIREMENTS FOR A WRITTEN CONCEALED HANDGUN COMPETENCY
18 EXAM. THE MINIMUM REQUIREMENTS FOR THE EXAM MUST INCLUDE
19 TESTING A STUDENT'S KNOWLEDGE ON THE SUBJECTS DESCRIBED IN

1 SUBSECTIONS (3)(a) TO (3)(f) OF THIS SECTION."

2 Page 7, strike lines 19 through 25.

3 Page 7, after line 25, insert:

4 "(7) A CONCEALED HANDGUN TRAINING CLASS AND A REFRESHER
5 CLASS IS SUBJECT TO THE REQUIREMENTS OF THE FEDERAL "AMERICANS
6 WITH DISABILITIES ACT OF 1990", 42 U.S.C. SEC. 12101 ET SEQ."

7 Page 8, strike lines 12 through 16 and substitute:

8 "(b) BE CERTIFIED AS A FIREARMS INSTRUCTOR BY ONE OF THE
9 FOLLOWING ENTITIES, THAT HAS INSTRUCTORS CERTIFIED BY A
10 NATIONALLY RECOGNIZED ORGANIZATION THAT CUSTOMARILY OFFERS
11 FIREARMS TRAINING:

12 (I) A FEDERAL, STATE, COUNTY, OR MUNICIPAL LAW ENFORCEMENT
13 AGENCY;

14 (II) A COLLEGE OR UNIVERSITY;

15 (III) A NATIONALLY RECOGNIZED ORGANIZATION THAT
16 CUSTOMARILY OFFERS FIREARMS TRAINING; OR

17 (IV) A FIREARMS TRAINING SCHOOL."
