Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB25-027 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, line 11, strike "**definitions.**" and substitute
2 "**notice to revisor of statutes - definitions - repeal.**".

3 Page 4 of the bill, after line 8 insert:

4 "(3) THE WORK GROUP MUST BE FUNDED ENTIRELY BY GIFTS,
5 GRANTS, AND DONATIONS, INCLUDING IN-KIND DONATIONS AS PART OF A
6 PUBLIC-PRIVATE PARTNERSHIP AGREEMENT, AND NO ADDITIONAL
7 GENERAL FUND MONEY SHALL BE APPROPRIATED FOR THE
8 IMPLEMENTATION OF THE WORK GROUP."

9 Renumber succeeding subsections accordingly.

10 Page 7 of the bill, line 16, strike "BY JULY 31, 2025." and substitute "AS
11 SOON AS POSSIBLE AFTER THE EFFECTIVE DATE OF THIS SUBSECTION (5)
12 BUT NO LATER THAN TWENTY-EIGHT DAYS AFTER THE EFFECTIVE DATE OF
13 THIS SUBSECTION (5)".

14 Page 7 of the bill, line 25, strike "SEPTEMBER 1, 2025." and substitute
15 "FIFTY-SIX DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION."

16 Page 7 of the bill, line 26, strike "IN 2025" and substitute "DURING THE
17 FIRST SIX MONTHS OF ITS OPERATION".

18 Page 7 of the bill, line 27, strike "IN 2026." and substitute "DURING THE
19 SECOND SIX MONTHS OF ITS OPERATION."

20 Page 8 of the bill, line 16, strike "(5)(b)" and substitute "(6)(b)".

- 1 Page 9 of the bill, line 19, strike "(5)" and substitute "(6)".
- 2 Page 9 of the bill, line 21, strike "JUNE 30, 2026," and substitute "ONE
3 YEAR AND ONE MONTH AFTER THE EFFECTIVE DATE OF THIS SUBSECTION
4 (8),".
- 5 Page 9 of the bill, line 23, strike "(6)" and substitute "(7)".
- 6 Page 9 of the bill, line 27, after "EDUCATION." insert "THE DEPARTMENT
7 OF EDUCATION SHALL SUBMIT THE REPORT TO THE GENERAL ASSEMBLY AS
8 PART OF ITS "SMART" ACT PRESENTATION REQUIRED BY SECTION
9 2-7-203.".
- 10 Page 10 of the bill, after line 8 insert:
- 11 **"SECTION 4. Appropriation.** For the 2025-26 state fiscal year,
12 \$50,000 is appropriated to the department of public safety for use by the
13 executive director's office. This appropriation is from the trauma-
14 informed practices for school safety drills fund created in section 24-33.5-
15 2705 (9), C.R.S. To implement this act, the office may use this
16 appropriation for administrative services related to the office of school
17 safety.".
- 18 Renumber succeeding section accordingly.
- 19 Page 1 of the bill, line 102, strike "SAFETY." and substitute "SAFETY,
20 AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.".
- 21 Amend the Education Committee Report, dated February 5, 2025, page
22 1, line 6, strike "(4) (a) (I)" and substitute "(5) (a) (I)".
- 23 Page 1 of the report, line 19, strike "GOVERNOR;". and substitute
24 "GOVERNOR;".
- 25 Page 2 of the report, after line 20 insert:
- 26 "(H) A REPRESENTATIVE FROM THE FIRE AND LIFE SAFETY SECTION
27 OF THE DIVISION OF FIRE PREVENTION AND CONTROL, APPOINTED BY THE
28 PRESIDENT OF THE SENATE;
- 29 Reletter succeeding sub-subparagraphs accordingly.".
- 30 Page 2 of the report, line 32, strike "(8)" and substitute "(9) (a)".

1 Page 2 of the report, strike lines 35 through 39 and substitute:

2 "THROUGH GIFTS, GRANTS, OR DONATIONS TO THE STATE TREASURER.

3 (b) THE OFFICE MAY ENTER INTO A PUBLIC-PRIVATE PARTNERSHIP
4 AGREEMENT TO CARRY OUT THE REQUIREMENTS OF THIS SECTION. FOR
5 PURPOSES OF THIS SECTION, IF THE OFFICE ENTERS INTO A PUBLIC-PRIVATE
6 PARTNERSHIP AGREEMENT, THE PUBLIC-PRIVATE PARTNERSHIP
7 AGREEMENT IS CONSIDERED AN IN-KIND DONATION THAT COUNTS AS A
8 GIFT, GRANT, OR DONATION IN THE MONETARY AMOUNT THAT
9 CORRELATES WITH THE VALUE OF THE CONTRACT."

10 Page 3 of the report, strike lines 1 through 9 and substitute:

11 "(10) (a) IF BY JUNE 30, 2027, SUBSECTIONS (2), (4), (5), (6), (7),
12 (8), AND (9) OF THIS SECTION HAVE NOT TAKEN EFFECT, THE STATE
13 TREASURER SHALL TRANSFER ALL MONEY RECEIVED FOR PURPOSES OF
14 IMPLEMENTING THIS SECTION TO THE STATE EDUCATION FUND CREATED IN
15 SECTION 17 (4) OF ARTICLE IX OF THE STATE CONSTITUTION.

16 (b) IF SUBSECTIONS (2), (4), (5), (6), (7), (8), AND (9) OF THIS
17 SECTION TAKE EFFECT PURSUANT TO SUBSECTION (11)(a) OF THIS SECTION,
18 ON THE DAY PRIOR TO THE REPEAL OF THIS SECTION OR ONE YEAR LATER
19 PURSUANT TO SUBSECTION (11)(b) OF THIS SECTION, THE STATE
20 TREASURER SHALL TRANSFER ALL UNEXPENDED AND UNENCUMBERED
21 MONEY RECEIVED FOR PURPOSES OF IMPLEMENTING THIS SECTION TO THE
22 STATE EDUCATION FUND CREATED IN SECTION 17 (4) OF ARTICLE IX OF
23 THE STATE CONSTITUTION.

24 (11) (a) SUBSECTIONS (2), (4), (5), (6), (7), (8), AND (9) OF THIS
25 SECTION TAKE EFFECT IF THE OFFICE RECEIVES FIFTY THOUSAND DOLLARS
26 OF GIFTS, GRANTS, OR DONATIONS FOR THE PURPOSE OF THIS SECTION OR
27 IF THE OFFICE RECEIVES AN IN-KIND DONATION AS PART OF A
28 PUBLIC-PRIVATE PARTNERSHIP AGREEMENT FOR WHICH THE VALUE IS
29 EQUAL TO FIFTY THOUSAND DOLLARS. THE OFFICE SHALL NOTIFY THE
30 REVISOR OF STATUTES IN WRITING OF THE DATE ON WHICH THE CONDITION
31 SPECIFIED IN THIS SUBSECTION (11)(a) HAS OCCURRED BY EMAILING THE
32 NOTICE TO REVISOROFSTATUTES.GA@COLEG.GOV. SUBSECTIONS (2), (4),
33 (5), (6), (7), (8), AND (9) OF THIS SECTION TAKE EFFECT UPON THE DATE
34 IDENTIFIED IN THE NOTICE THAT THE COMMISSION HAS RECEIVED FIFTY
35 THOUSAND DOLLARS OF GIFTS, GRANTS, OR DONATIONS, OR AN IN-KIND
36 DONATION AS PART OF A PUBLIC-PRIVATE PARTNERSHIP AGREEMENT FOR
37 WHICH THE VALUE IS EQUAL TO FIFTY THOUSAND DOLLARS, FOR THE
38 PURPOSES OF THIS SECTION OR, IF THE NOTICE DOES NOT SPECIFY THAT
39 DATE, UPON THE DATE OF THE NOTICE TO THE REVISOR OF STATUTES.

40 (b) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2027; EXCEPT

1 THAT, IF THE REVISOR OF STATUTES RECEIVES NOTICE PURSUANT TO THIS
2 SECTION, THEN THIS SECTION IS REPEALED, EFFECTIVE ONE YEAR AFTER
3 THE REQUIREMENTS OF SUBSECTION (7) OF THIS SECTION ARE SATISFIED.".
