Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB25-290 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Finance Committee Report, dated April 22, 2025, page 3, line  
2 42, strike "FUND." and substitute "GENERAL FUND."
- 3 Page 4, line 2, strike the first "FUND" and substitute "FUND, OTHER THAN  
4 INTEREST,".
- 5 Page 4, strike lines 5 and 6 and substitute:  
6 "(3) SUBJECT TO ANNUAL".
- 7 Page 4, line 8, after "AND" insert "ANY".
- 8 Page 7, after line 19 insert:  
9 "Page 15 of the bill, line 18, strike "(2)(e)" and substitute "(2)(d), (2)(e)".
- 10 Page 15 of the bill, after line 25 insert:  
11 "(2) (d) IF CLAIMS MADE PURSUANT TO THIS ARTICLE 13 EXCEED  
12 THE BALANCE IN THE UNCLAIMED PROPERTY TRUST FUND, THE STATE  
13 TREASURER SHALL TRANSFER FROM THE GENERAL FUND TO THE  
14 UNCLAIMED PROPERTY TRUST FUND AN AMOUNT NEEDED TO PAY THE  
15 CLAIMS AND SHALL NOTIFY THE JOINT BUDGET COMMITTEE OF THE  
16 GENERAL ASSEMBLY OF THE TRANSFER AND THE AMOUNT OF THE  
17 TRANSFER FROM THE GENERAL FUND."
- 18 Page 15 of the bill, line 26, strike "(2)".

1 Page 8 of the committee report, line 11, strike "YEAR." and substitute:

2 "YEAR.

3 **SECTION 5. Appropriation.** (1) For the 2025-26 state fiscal  
4 year, \$25,000,000 is appropriated to the department of health care policy  
5 and financing. This appropriation is from the provider stabilization fund  
6 created in section 25.5-3-603 (1)(a), C.R.S. To implement this act, the  
7 department may use this appropriation as follows:

8 (a) \$138,505 for personal services related to general  
9 administration, which amount is based on an assumption that the  
10 department will require an additional 2.0 FTE;

11 (b) \$15,900 for operating expenses related to general  
12 administration; and

13 (c) \$24,845,595 for provider stabilization payments related to  
14 other medical services.".

15 Page 8 of the committee report, strike lines 14 through 16 and substitute:

16 "Page 1 of the bill, strike line 107 and substitute "**FUNDS TO STABILIZE THE**  
17 **HEALTH-CARE SAFETY NET AND MAKING AN APPROPRIATION.**".
