**BILL TOPIC: PROTECT PRIVACY OF SUBSTANCE USE DISORDER PATIENTS**

#### **Summary of Legislation**

This bill, as amended by the House Public Health Care and Environment Committee, requires the Office of Behavioral Health (OBH) in the Department of Human Services (DHS) to review its own and other states' policies and procedures, as well as federal requirements, regarding the collection and protection of data with substance use disorder patients' personal identifying information. OBH must conduct the review on or before December 1, 2016, use it to identify necessary changes or improvements to its policies, and implement any changes identified as soon as practicable.

On and after December 1, 2016, OBH may no longer collect the personal identifying information of substance use disorder patients whose care is paid for entirely by private funds or private insurance. The bill provides exceptions:

- for records of any controlled substance distributed, administered, dispensed, or used;
- if the patient is a DUI offender in treatment as a condition of probation;
- for any patient whose treatment is paid for with state or federal funds; or
- as necessary to fulfill federal requirements.

#### **State Expenditures**

This bill increases state General Fund expenditures by \$38,000 in FY 2016-17 in DHS.

The bill requires DHS to review its own and other states' policies and procedures, as well as federal requirements, regarding the collection of substance use disorder patients' personal identifying information. To complete the review by December 1, 2016, and prepare to implement any

recommended changes, DHS must hire a consultant with legal expertise. The fiscal note assumes the consultant will work 40 hours per week for 10 weeks at \$95 per hour, resulting in a \$38,000 increase in General Fund expenditures.

Workload and costs in DHS may increase depending on the recommendations following the review. Once the recommendations are known, the fiscal note assumes that DHS will request any required funding through the annual budget process.

#### **Effective Date**

The bill takes effect August 10, 2016, if the General Assembly adjourns on May 11, 2016, as scheduled, and no referendum petition is filed.

#### **State Appropriations**

In FY 2016-17, the bill requires a General Fund appropriation of \$38,000 to the Department of Human Services.

#### **Departmental Difference**

In FY 2016-17, DHS estimates that the bill increases General Fund expenditures by an additional \$679,020. This cost is to update electronic database systems to ensure that the state does not collect the personal identifying information of patients paying for services with private insurance or personal funds. The fiscal note disagrees with this assessment. Providers serving private pay patients who do not consent to share their information with the state can ensure the information is not collected by OBH without the need for system modifications.
