After consideration on the merits, the Committee recommends the following:

HB16-1034 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 2, strike "(7.7)" and substitute "(10.8)".
- 2 Page 2, strike lines 6 through 9 and substitute:
 - 3 "(10.8) "REGISTERED EMERGENCY MEDICAL RESPONDER" MEANS
 - 4 AN INDIVIDUAL WHO HAS SUCCESSFULLY COMPLETED THE TRAINING AND
 - 5 EXAMINATION REQUIREMENTS FOR EMERGENCY MEDICAL RESPONDERS,
 - 6 WHO PROVIDES ASSISTANCE TO THE INJURED OR ILL UNTIL MORE HIGHLY
 - 7 TRAINED AND QUALIFIED PERSONNEL ARRIVE, AND WHO IS REGISTERED
 - 8 WITH THE DEPARTMENT PURSUANT TO PART 11 OF THIS ARTICLE."
- 9 Page 4, line 7, after "A" insert "VOLUNTARY".
- 10 Page 4, line 8, after "INDIVIDUALS" insert "MAY".
- 11 Page 4, line 10, strike "OVERSIGHT" and substitute "VOLUNTARY
- 12 REGISTRATION".
- 13 Page 4, line 19, after "OF THE" insert "VOLUNTARY".
- 14 Page 4, strike lines 25 and 26 and substitute "WHO HAS SUCCESSFULLY
- 15 COMPLETED THE TRAINING AND EXAMINATION REQUIREMENTS FOR
- 16 EMERGENCY MEDICAL RESPONDERS, WHO PROVIDES".

1 Page 5, strike lines 8 through 12 and substitute:

2 "(3) "REGISTERED EMERGENCY MEDICAL RESPONDER" MEANS AN
3 INDIVIDUAL WHO HAS SUCCESSFULLY COMPLETED THE TRAINING AND
4 EXAMINATION REQUIREMENTS FOR EMERGENCY MEDICAL RESPONDERS,
5 WHO PROVIDES ASSISTANCE TO THE INJURED OR ILL UNTIL MORE HIGHLY
6 TRAINED AND QUALIFIED PERSONNEL ARRIVE, AND WHO IS REGISTERED
7 WITH THE DEPARTMENT PURSUANT TO THIS PART 11."

8 Page 5, line 14, after "A" insert "VOLUNTARY".

9 Page 5, strike line 16 and substitute "NOT HOLD HIMSELF OR HERSELF OUT
10 AS A REGISTERED MEDICAL".

11 Page 5, line 19, strike "IS REGISTERED" and substitute "MEETS THE
12 REQUIREMENTS SET FORTH IN THIS PART 11".

13 Page 7, line 1, strike "CERTIFICATION".

14 Page 7, line 3, strike "CERTIFICATION".

15 Page 7, line 5, strike "CERTIFICATION".

16 Page 7, line 8, strike "CERTIFICATION".

17 Page 7, line 11, strike "CERTIFICATION".

18 Page 7, line 13, strike "CERTIFICATION".

19 Page 7, line 16, strike "CERTIFICATION".

- 1 Page 9, line 9, after "BY" insert "REGISTERED".
- 2 Page 9, line 21, strike "AN EMERGENCY" and substitute "A REGISTERED
- 3 EMERGENCY" and strike "OF AN" and substitute "OF A REGISTERED".
- 4 Page 9, line 22, strike "AND" and substitute "OR".
- 5 Page 9, line 23, strike "AN" and substitute "A REGISTERED".
- 6 Page 14, line 20, strike "first responder," and substitute "~~first responder,~~".
- 7 Page 14, strike lines 26 and 27.
- 8 Strike page 15 and substitute:

9 **"SECTION 9. Act subject to petition - effective date.** This act
10 takes effect at 12:01 a.m. on the day following the expiration of the
11 ninety-day period after final adjournment of the general assembly (August
12 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a
13 referendum petition is filed pursuant to section 1 (3) of article V of the
14 state constitution against this act or an item, section, or part of this act
15 within such period, then the act, item, section, or part will not take effect
16 unless approved by the people at the general election to be held in
17 November 2016 and, in such case, will take effect on the date of the
18 official declaration of the vote thereon by the governor."
