A BILL FOR AN ACT

101 **CONCERNING AUTOCYCLES, AND, IN CONNECTION THEREWITH,**
102 **CLARIFYING THAT AN AUTOCYCLE IS A TYPE OF MOTORCYCLE**
103 **AND REQUIRING AUTOCYCLE DRIVERS AND PASSENGERS TO USE**
104 **SAFETY BELTS AND, IF APPLICABLE, CHILD SAFETY RESTRAINTS.**

Bill Summary

Transportation Legislation Review Committee. The bill amends the definition of autocycle to explicitly exclude motorcycles, clarify that the driver and each passenger in an autocycle ride in either a fully or a

partly enclosed seating area, and eliminate the requirements that an autocy-
cle be equipped with air bags and a hardtop enclosure that protects
occupants from the elements and can support the weight of the vehicle
without harming occupants when the vehicle is resting on the enclosure.
The bill also amends the definitions of "motor vehicle" used in the laws
governing mandatory safety belt and child restraint system use to clarify
that those laws apply to autocy-
cles.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-1-102, **amend**
3 (7.5) ~~AND (55)~~ as follows:

4 **42-1-102. Definitions.** As used in articles 1 to 4 of this title,
5 unless the context otherwise requires:

6 (7.5) "Autocycle" means a three-wheeled ~~motor vehicle~~
7 ~~MOTORCYCLE THAT DOES NOT USE HANDLEBARS OR ANY OTHER DEVICE~~
8 ~~THAT IS DIRECTLY CONNECTED TO A SINGLE FRONT WHEEL TO STEER AND~~
9 in which the driver and each passenger ~~rides~~ RIDE in ~~an~~ A FULLY OR
10 PARTLY enclosed seating area that is equipped ~~with:~~ WITH SAFETY BELTS
11 FOR ALL OCCUPANTS THAT ~~CONSTITUTE A SAFETY BELT SYSTEM, AS~~
12 ~~DEFINED IN SECTION 42-4-237 (1)(b).~~ FOR PURPOSES OF THIS SUBSECTION
13 (7.5), "PARTLY ENCLOSED SEATING AREA" MEANS A SEATING AREA THAT
14 IS ENTIRELY OR PARTLY SURROUNDED ON THE SIDES BY THE FRAME OR
15 BODY OF A VEHICLE BUT IS NOT FULLY ENCLOSED.

22 (55) "Motorcycle" means ~~AN AUTOCYCLE OR a motor vehicle that~~

1 uses handlebars or any other device connected to the front wheel to steer

4 ~~autocycle~~, low-speed electric vehicle, or low-power scooter.

5 **SECTION 2.** In Colorado Revised Statutes, 42-2-103, **amend**
6 **(1)(b), (1)(d), and (1)(e) introductory portion; and add (2.5) as follows:**

7 **42-2-103. Motorcycles - low-power scooters - driver's license**
8 **required.** (1) (b) The department shall require an applicant for a general
9 motorcycle endorsement to demonstrate the applicant's ability to exercise
10 ordinary and reasonable care and control in the operation of a motorcycle
11 THAT IS NOT AN AUTOCYCLE. The department shall also require an
12 applicant for a limited three-wheel motorcycle endorsement to
13 demonstrate the applicant's ability to exercise ordinary and reasonable
14 care and control in the operation of a three-wheel motorcycle THAT IS NOT
15 AN AUTOCYCLE.

16 (d) Except as provided in paragraph (c) of this subsection (1)
17 SUBSECTION (1)(e) OF THIS SECTION, a person with only a limited
18 three-wheel motorcycle endorsement may drive a three-wheel motorcycle
19 THAT IS NOT AN AUTOCYCLE but shall not drive a two-wheel motorcycle
20 on a roadway.

21 (e) The driver of a motorcycle need not obtain a two- or
22 three-wheel motorcycle endorsement if the motorcycle IS AN AUTOCYCLE
23 OR IF THE MOTORCYCLE has:

24 (2.5) AN OPERATOR OF AN AUTOCYCLE SHALL POSSESS A VALID
25 DRIVER'S LICENSE OR MINOR DRIVER'S LICENSE.

26 **SECTION 3.** In Colorado Revised Statutes, 42-3-201, **amend**
27 **(1)(a)(I)(D) and (1)(a)(I)(E); and repeal (1)(a)(I)(F) as follows:**

1 **42-3-201. Number plates furnished - style - periodic reissuance**
2 **- tabs - rules.** (1) (a) (I) The department shall issue to every owner
3 whose vehicle is registered two number plates; except that the department
4 shall issue one number plate for the following:

5 (D) A vehicle drawn by a motor vehicle; OR

6 (E) An item of special mobile machinery. or

7 (F) An autocycle.

8 **SECTION 4.** In Colorado Revised Statutes, 42-3-202, **amend**
9 **(1)(a) as follows:**

10 **42-3-202. Number plates to be attached.** (1)(a) The owner shall
11 attach the number plates assigned to a self-propelled vehicle, other than
12 a motorcycle, autocycle, MOTORCYCLE or street rod vehicle, to the vehicle
13 with one in the front and the other in the rear. The owner shall attach the
14 number plate assigned to a motorcycle, autocycle, street rod vehicle,
15 trailer, semitrailer, other vehicle drawn by a motor vehicle, or special
16 mobile machinery to the rear of the vehicle. The owner shall display
17 number plates during the current registration year, except as otherwise
18 provided in this article ARTICLE 3.

19 **SECTION 5.** In Colorado Revised Statutes, 42-3-203, **repeal**
20 **(1)(b) as follows:**

21 **42-3-203. Standardized plates - notice of funding through**
22 **gifts, grants, and donations - rules - repeal.** (1) (b) The department
23 shall issue a registered autocycle a license plate that:

24 (I) Is the same size as a motorcycle license plate; and

25 (II) Displays the registration number in numerals or letters of at
26 least one-and-one-half inches in height.

27 **SECTION 6.** In Colorado Revised Statutes, 42-4-236, **amend**

1 (1)(a.8) as follows:

2 **42-4-236. Child restraint systems required - definitions -**
3 **exemptions.** (1) As used in this section, unless the context otherwise
4 requires:

5 (a.8) "Motor vehicle" means a passenger car; a pickup truck; or a
6 van, minivan, or sport utility vehicle with a gross vehicle weight rating of
7 less than ten thousand pounds. "Motor vehicle" does not include
8 motorcycles THAT ARE NOT AUTOCYCLES, low-power scooters,
9 motorscooters, motorbicycles, motorized bicycles, and farm tractors and
10 implements of husbandry designed primarily or exclusively for use in
11 agricultural operations.

12 **SECTION 7.** In Colorado Revised Statutes, 42-4-237, **amend**
13 (1)(b) and (2) as follows:

14 **42-4-237. Safety belt systems - mandatory use - exemptions -**
15 **penalty.** (1) As used in this section:

16 (b) "Safety belt system" means a system utilizing a lap belt, a
17 shoulder belt, or any other belt or combination of belts installed in a
18 motor vehicle OR AN AUTOCYCLE to restrain drivers and passengers,
19 which system conforms to federal motor vehicle safety standards.

20 (2) Unless exempted pursuant to subsection (3) of this section,
21 every driver of and every front seat passenger in a motor vehicle AND
22 EVERY DRIVER OF AND EVERY PASSENGER IN AN AUTOCYCLE equipped
23 with a safety belt system shall wear a fastened safety belt while the motor
24 vehicle is being operated on a street or highway in this state.

25 **SECTION 8. Safety clause.** The general assembly hereby finds,
26 determines, and declares that this act is necessary for the immediate
27 preservation of the public peace, health, and safety.
