**Bill Summary**

The bill requires the director of the division of professions and occupations in the department of regulatory agencies to promulgate rules for applicants for cosmetologist or barber licensure to furnish proof of training, not to exceed 50 credits or 1,500 contact hours.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-8-114, **amend** (3)  
3 introductory portion, (3)(a), and (3)(b) as follows:

4 **12-8-114. Qualifications of applicants - requirements - rules.**

5 (3) THE DIRECTOR SHALL PROMULGATE RULES TO IMPLEMENT THIS  
6 SECTION, BUT SHALL NOT REQUIRE an applicant for examination ~~shall~~ TO  
7 furnish proof of training of ~~not less~~ MORE than the number of hours of  
8 course completion in the subject area in which the applicant seeks  
9 licensure as follows:

10 (a) (I) FIFTY CREDITS, AS DEFINED BY:

11 (A) INSTITUTIONAL ACCREDITATION REQUIREMENTS;

12 (B) THE COLORADO COMMISSION ON HIGHER EDUCATION  
13 FULL-TIME EQUIVALENT CLOCK-TO-CREDIT HOUR REQUIREMENTS; OR

14 (C) THE DEPARTMENT OF EDUCATION ACCREDITATION  
15 REQUIREMENTS; OR

16 (II) One thousand ~~eight~~ FIVE hundred contact hours for a  
17 cosmetologist;

18 (b) (I) FIFTY CREDITS, AS DEFINED BY:

19 (A) INSTITUTIONAL ACCREDITATION REQUIREMENTS;

20 (B) THE COLORADO COMMISSION ON HIGHER EDUCATION  
21 FULL-TIME EQUIVALENT CLOCK-TO-CREDIT HOUR REQUIREMENTS; OR

22 (C) THE DEPARTMENT OF EDUCATION ACCREDITATION  
23 REQUIREMENTS; OR

24 (II) One thousand five hundred contact hours for a barber;

25 **SECTION 2. Act subject to petition - effective date.** This act  
26 takes effect at 12:01 a.m. on the day following the expiration of the

1 ninety-day period after final adjournment of the general assembly (August  
2 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a  
3 referendum petition is filed pursuant to section 1 (3) of article V of the  
4 state constitution against this act or an item, section, or part of this act  
5 within such period, then the act, item, section, or part will not take effect  
6 unless approved by the people at the general election to be held in  
7 November 2018 and, in such case, will take effect on the date of the  
8 official declaration of the vote thereon by the governor.
