**Bill Summary**

**Sunset Process - Senate State, Veterans, and Military Affairs Committee.** The bill repeals the repeal of the statutory sections that create the court security cash fund (cash fund), the court security cash fund commission, and duties related to the cash fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 13-1-203, **add** (5) as  
3 follows:

4 **13-1-203. Court security cash fund commission - creation -**  
5 **membership - repeal.** (5) THIS SECTION IS REPEALED, EFFECTIVE  
6 SEPTEMBER 1, 2027. BEFORE ITS REPEAL, THIS SECTION IS SCHEDULED FOR  
7 REVIEW IN ACCORDANCE WITH SECTION 2-3-1203.

8 **SECTION 2.** In Colorado Revised Statutes, **repeal** 13-1-206.

9 **SECTION 3.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
10 (4)(a)(V) and **add** (19) as follows:

11 **2-3-1203. Sunset review of advisory committees - legislative**  
12 **declaration - definition - repeal.** (4) (a) The following statutory  
13 authorizations for the designated advisory committees will repeal on July  
14 1, 2017:

15 (V) ~~The court security cash fund commission created in part 2 of~~  
16 ~~article 1 of title 13, C.R.S.;~~

17 (19) (a) THE FOLLOWING STATUTORY AUTHORIZATIONS FOR THE  
18 DESIGNATED ADVISORY COMMITTEES ARE SCHEDULED FOR REPEAL ON  
19 SEPTEMBER 1, 2027:

20 (I) THE COURT SECURITY CASH FUND COMMISSION CREATED IN  
21 SECTION 13-1-203.

22 (b) THIS SUBSECTION (19) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
23 2029.

24 **SECTION 4. Safety clause.** The general assembly hereby finds,  
25 determines, and declares that this act is necessary for the immediate  
26 preservation of the public peace, health, and safety.
