**Sunset Process - Senate Education Committee.** The bill implements the recommendations of the sunset review and report on the school safety resource center advisory board (board) by eliminating the repeal date of the board and extending the board indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1804,  
3 **amend (6)(a)** as follows:

4 **24-33.5-1804. School safety resource center advisory board -**  
5 **created - repeal.** (6) (a) This section is repealed, effective July 1, 2017  
6 SEPTEMBER 1, 2022.

7 **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **amend**  
8 **(13)(a)** introductory portion; **repeal (4)(a)(VIII);** and **add (13)(a)(IV)** as  
9 follows:

10 **2-3-1203. Sunset review of advisory committees - legislative**  
11 **declaration - definition - repeal.** (4) (a) The following statutory  
12 authorizations for the designated advisory committees will repeal on July  
13 1, 2017:

21 **SECTION 3. Safety clause.** The general assembly hereby finds,
