After consideration on the merits, the Committee recommends the following:

HB17-1027 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike line 3 and substitute "(4)(b)(III)(A),  
2 (4)(b)(III)(C), (4)(b)(V), and (4)(b)(VII) as follows:".

3 Page 2, line 6, strike "**audit.**" and substitute "**annual report.**".

4 Page 2, strike line 7 and substitute:

5 "(4) (b) (III) At least quarterly, the state treasurer shall transfer all  
6 available moneys from the Emily Maureen Ellen Keyes organ and tissue  
7 donation awareness fund:

8 (A) To donor alliance, inc., or its successor organization, to  
9 provide funding for activities to promote organ and tissue donation  
10 through the creation and dissemination, by means of electronic media and  
11 otherwise, of educational information including public service  
12 announcements and information to increase awareness in the medical  
13 professions and related fields. Donor alliance, inc., or its successor  
14 organization, shall create, by amendment to its articles of incorporation  
15 or bylaws or otherwise, as appropriate, an advisory group to allocate  
16 moneys received pursuant to this sub-subparagraph (A). Such advisory  
17 body shall include a representative of any qualified transplant  
18 organization. Such organizations shall include those for organs, tissue,  
19 ~~bone marrow, and blood~~ AND LIVING DONATIONS. The advisory body  
20 created under this sub-subparagraph (A) shall report in writing in a form

1 and manner determined by the department and at such intervals as  
2 required by the department on the use of moneys received under this  
3 sub-subparagraph (A). No moneys made available pursuant to this  
4 paragraph (b) shall be used to encourage fetal tissue donation.

5 (C) Before any payment to Donor Alliance, Inc., or its successor  
6 organization, from the Emily Maureen Ellen Keyes organ and tissue  
7 donation awareness fund may be made for any purpose, to the department  
8 for the reasonable costs associated with the initial installation of the organ  
9 and tissue donor registry, the setup for electronic transfer of the donor  
10 information for the organ and tissue donor registry to the federally  
11 designated organ procurement organization, and computer programming,  
12 REPROGRAMMING, and form changes necessary as a result of the creation  
13 OR MODIFICATION of the organ and tissue donor registry.

14 (V) An applicant may make a donation of one dollar or more to".

15 Page 3, line 14, strike "A DRIVER'S LICENSE OR" and substitute "AN  
16 IDENTIFICATION CARD, A DRIVER'S LICENSE, OR AN".

17 Page 3, strike lines 19 through 22 and substitute:

18 "(VII) ~~This paragraph (b) is repealed July 1, 2018~~ BY OCTOBER  
19 1, 2017, AND BY EACH OCTOBER 1 THEREAFTER, DONOR ALLIANCE, INC.,  
20 OR ITS SUCCESSOR ORGANIZATION, SHALL SUBMIT TO THE DEPARTMENT AN  
21 ANNUAL REPORT DETAILING THE AMOUNTS AND SPECIFIC USES OF ALL  
22 FUNDS RECEIVED BY DONOR ALLIANCE, INC., FROM THE EMILY MAUREEN  
23 ELLEN KEYES ORGAN AND TISSUE DONATION AWARENESS FUND.  
24 BEGINNING IN 2017, THE DEPARTMENT SHALL PRESENT DONOR ALLIANCE,  
25 INC.'S ANNUAL REPORT AS PART OF ITS "STATE MEASUREMENT FOR  
26 ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT (SMART)  
27 GOVERNMENT ACT" HEARING REQUIRED BY SECTION 2-7-203."

28 Page 4 of the bill, strike lines 26 and 27.

29 Page 5 of the bill, strike lines 1 through 19 and substitute:

30 "**SECTION 3. Act subject to petition - effective date.** This act  
31 takes effect September 15, 2017; except that, if a referendum petition is  
32 filed pursuant to section 1 (3) of article V of the state constitution against  
33 this act or an item, section, or part of this act within the ninety-day period  
34 after final adjournment of the general assembly, then the act, item,

1 section, or part will not take effect unless approved by the people at the  
2 general election to be held in November 2018 and, in such case, will take  
3 effect on the date of the official declaration of the vote thereon by the  
4 governor."

5 Page 1, line 104 strike "AUDIT EVERY TEN YEARS," and substitute  
6 "ANNUAL REPORT ON THE USE OF DONATED FUNDS,".
