AGE AND SERVICE CREDIT REQUIREMENTS FOR FULL SERVICE RETIREMENT BENEFITS PURSUANT TO SECTION 24-51-602 SHALL NOT BE EMPLOYED AFTER RETIREMENT PURSUANT TO THIS SUBSECTION (1.9) BY THE EMPLOYER IN THE SCHOOL DIVISION THAT WAS THE TEACHER'S LAST EMPLOYER UNTIL TWO YEARS AFTER THE TEACHER'S DATE OF RETIREMENT.

- (i) On or before December 1, 2020, the association shall submit a report to the finance committees of the house of representatives and the senate, or any successor committees, regarding the employment after service retirement provisions of this subsection (1.9). The employers in the school division of the association that employ teachers, school bus drivers, or school food services cooks pursuant to this subsection (1.9) shall provide information requested by the association for the purposes of the report. The report shall include:
- (I) THE NUMBER OF TEACHERS, SCHOOL BUS DRIVERS, AND SCHOOL FOOD SERVICES COOKS WHO HAVE BEEN EMPLOYED AFTER SERVICE RETIREMENT PURSUANT TO THIS SUBSECTION (1.9) AS OF THE DATE OF THE REPORT;
- (II) THE EXTENT TO WHICH THIS SUBSECTION (1.9) HAS HELPED EMPLOYERS IN THE SCHOOL DIVISION ADDRESS TEACHER, SCHOOL BUS DRIVER, AND SCHOOL FOOD SERVICES COOK SHORTAGES;
- (III) THE COSTS, IF ANY, TO THE ASSOCIATION AS A RESULT OF THIS SUBSECTION (1.9); AND
- (IV) ANY OTHER INFORMATION DEEMED RELEVANT BY THE ASSOCIATION.".
