Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB17-1321 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 7, strike lines 15 through 27.

2 Page 8, strike lines 1 through 13.

3 Renumber succeeding sections accordingly.

4 Page 20, after line 15 insert:

5 "SECTION 12. In Colorado Revised Statutes, 33-6-105, **amend**
6 (1) as follows:

7 **33-6-105. Disposition of fines and surcharges.** (1) (a) Except
8 as otherwise provided in ~~paragraph (b) of this subsection (1)~~ SUBSECTION
9 (1)(b) OF THIS SECTION, all ~~moneys~~ MONEY collected for fines under
10 articles 1 to 6 of this ~~title~~ TITLE 33, either by payment of a penalty
11 assessment or assessed by a court upon conviction and resulting from
12 issuance of a citation by a wildlife officer of the division of parks and
13 wildlife, shall be transmitted to the state treasurer, who shall credit THE
14 MONEY COLLECTED AS FOLLOWS:

15 (I) UNTIL TWO HUNDRED FOURTEEN THOUSAND ONE HUNDRED
16 SEVENTY-FOUR DOLLARS OF THE MONEY COLLECTED HAVE BEEN CREDITED
17 TO THE GENERAL FUND, one-half to the general fund and one-half to the
18 wildlife cash fund or, for offenses involving nongame wildlife, to the
19 nongame and endangered wildlife cash fund; AND

20 (II) AFTER THE GENERAL FUND HAS BEEN CREDITED TO THE FULL

1 AMOUNT REQUIRED PURSUANT TO SUBSECTION (1)(a)(I) OF THIS SECTION,
2 TO THE WILDLIFE CASH FUND OR, FOR OFFENSES INVOLVING NONGAME
3 WILDLIFE, TO THE NONGAME AND ENDANGERED WILDLIFE CASH FUND.

4 (b) When an arrest has been made or the citation for any wildlife
5 offense has been issued by a park officer of the division of parks and
6 wildlife or by any other Colorado peace officer, as defined in this ~~title~~
7 TITLE 33, the state treasurer shall credit one-half of the ~~moneys~~ MONEY
8 collected to the ~~general~~ WILDLIFE CASH fund and one-half to the Colorado
9 town, city, county, city and county, or state agency whose officer issued
10 the citation."

11 Renumber succeeding sections accordingly.

12 Page 30, after line 19 insert:

13 "SECTION 25. In Colorado Revised Statutes, 33-15-103, **amend**
14 (1)(a) as follows:

15 **33-15-103. Disposition of fines - notice of court decisions.**

16 (1) (a) All ~~moneys~~ MONEY collected for fines under this ~~article~~ ARTICLE
17 15 and articles 10 to 13 and 32 of this ~~title~~ TITLE 33, either by payment of
18 a penalty assessment or assessed by a court upon conviction, shall be
19 transmitted to the state treasurer, who shall credit ~~such moneys~~ THE
20 MONEY to the parks and outdoor recreation cash fund; except that, when
21 an arrest has been made or the citation for any offense, including those
22 committed under article 14 of this ~~title~~ TITLE 33, has been issued by a
23 wildlife officer of the division of parks and wildlife, all ~~moneys~~ MONEY
24 collected for the fine shall be transmitted to the state treasurer, who shall
25 credit THE MONEY COLLECTED AS FOLLOWS:

26 (I) UNTIL SIX THOUSAND TWO HUNDRED FIFTY DOLLARS OF THE
27 MONEY COLLECTED HAVE BEEN CREDITED TO THE GENERAL FUND, one-half
28 to the wildlife cash fund and one-half to the general fund; AND

29 (II) AFTER THE GENERAL FUND HAS BEEN CREDITED TO THE FULL
30 AMOUNT REQUIRED PURSUANT TO SUBSECTION (1)(A)(I) OF THIS SECTION,
31 TO THE WILDLIFE CASH FUND."
