After consideration on the merits, the Committee recommends the following:

HB17-1324 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 8, line 6, strike "OR SECTION 22-60.5-205".
- 2 Page 8, strike lines 18 and 19 and substitute "SECTION 22-60.5-201 (1)(a),
- 3 (1)(b), OR (1)(c); AND".
- 4 Page 9, line 12, strike "IN THE SAME RURAL SCHOOL DISTRICT".
- 5 Page 9, line 16, strike "IN THE SAME RURAL SCHOOL DISTRICT".
- 6 Page 9, line 20, strike "IN THE SAME RURAL SCHOOL DISTRICT".
- 7 Page 9, line 24, strike "IN THE SAME RURAL SCHOOL DISTRICT".
- 8 Page 10, lines 1 and 2, strike "IN THE SAME RURAL SCHOOL DISTRICT".
- 9 Page 10, after line 12 insert:
  - 10 "(4) (a) TO ENSURE THAT THE CREDITS ALLOWED BY SUBSECTIONS
  - 11 (2) AND (3) OF THIS SECTION ARE ALLOWED ONLY TO QUALIFIED RURAL
  - 12 TEACHERS AND QUALIFIED RURAL STUDENT TEACHERS WHO ARE ELIGIBLE
  - 13 FOR THE CREDITS, NO LATER THAN DECEMBER 1 OF EACH INCOME TAX
  - 14 YEAR COMMENCING ON OR AFTER JANUARY 1, 2018, THE DEPARTMENT OF
  - 15 EDUCATION SHALL SUBMIT TO THE DEPARTMENT OF REVENUE:
  - 16 (I) A LIST OF ALL QUALIFIED RURAL TEACHERS WHO ARE ELIGIBLE
  - 17 FOR A CREDIT ALLOWED BY SUBSECTION (2)(a), (2)(b), (2)(c), (2)(d), OR

1 (2)(e) OF THIS SECTION FOR THE INCOME TAX YEAR THAT SPECIFICALLY  
2 IDENTIFIES THE AMOUNT OF THE CREDIT ALLOWED FOR EACH TEACHER;  
3 AND

4 (II) A LIST OF ALL QUALIFIED RURAL STUDENT TEACHERS WHO ARE  
5 ELIGIBLE FOR THE CREDIT ALLOWED BY SUBSECTION (3) OF THIS SECTION  
6 FOR THE INCOME TAX YEAR.

7 (b) THE DEPARTMENT OF EDUCATION SHALL COORDINATE WITH  
8 THE DEPARTMENT OF REVENUE TO ENSURE THAT THE LISTS PROVIDED TO  
9 THE DEPARTMENT OF REVENUE PURSUANT TO SUBSECTION (4)(a) OF THIS  
10 SECTION PROVIDE SUFFICIENT INFORMATION, INCLUDING, TO THE EXTENT  
11 DEEMED NECESSARY BY THE DEPARTMENT OF REVENUE, MAILING  
12 ADDRESSES AND COMPLETE OR PARTIAL SOCIAL SECURITY NUMBERS, TO  
13 ALLOW THE DEPARTMENT OF REVENUE TO MATCH THE INDIVIDUALS  
14 IDENTIFIED ON THE LISTS WITH THEIR INCOME TAX RETURNS.

15 (c) IF NECESSARY TO ALLOW THE DEPARTMENT OF EDUCATION TO  
16 OBTAIN THE INFORMATION NEEDED TO PROVIDE LISTS TO THE  
17 DEPARTMENT OF REVENUE AS REQUIRED BY SUBSECTION (4)(a) OF THIS  
18 SECTION, THE DEPARTMENT OF EDUCATION SHALL MODIFY ITS ELECTRONIC  
19 EDUCATOR LICENSING SYSTEM TO ACCEPT OR REQUIRE STUDENT TEACHER  
20 LICENSING INFORMATION."

21 Renumber succeeding subsections accordingly.
