Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB17-019 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

1 Amend printed bill, page 5, line 2, strike "**reporting.**" and substitute  
2 "**reporting - rules.**".

3 Page 5, strike line 3 and substitute "SEPTEMBER 1, 2017, THE  
4 DEPARTMENT OF HUMAN SERVICES IN CONSULTATION WITH THE".

5 Page 5, line 7, strike "THE" and substitute "USING CONSULTING SERVICES  
6 AS NECESSARY, THE".

7 Page 5, line 11, after the period add "THE PROCESSES FOR EDUCATION AND  
8 MARKETING REQUIRED PURSUANT TO THIS SUBSECTION (1) SHALL BE  
9 COMPLETED ON OR BEFORE SEPTEMBER 1, 2017.

10 (b) FOR THE SOLE PURPOSE OF ENSURING MEDICATION  
11 CONSISTENCY FOR PERSONS WITH MENTAL HEALTH DISORDERS IN THE  
12 CRIMINAL AND JUVENILE JUSTICE SYSTEMS, THE DEPARTMENT OF  
13 CORRECTIONS, COUNTIES, THE DIVISION OF YOUTH CORRECTIONS,  
14 COMMUNITY MENTAL HEALTH CENTERS, AND OTHER PROVIDERS SHALL  
15 SHARE PATIENT-SPECIFIC MENTAL HEALTH AND TREATMENT INFORMATION.  
16 ALL SUCH INFORMATION SHARING MUST COMPLY WITH CONFIDENTIALITY  
17 REQUIREMENTS, INCLUDING ANY NECESSARY MEMORANDUMS OF  
18 UNDERSTANDING BETWEEN PROVIDERS, SET FORTH IN THE FEDERAL  
19 "HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT OF 1996",  
20 45 CFR PARTS 2, 160, 162, AND 164.

1 (2) BEGINNING JULY 1, 2018, THE OFFICE SHALL HAVE THE  
2 FOLLOWING DUTIES AND RESPONSIBILITIES AND SHALL INCLUDE A REQUEST  
3 FOR THE FINANCING OF SUCH DUTIES AND RESPONSIBILITIES IN THE  
4 DEPARTMENT OF HUMAN SERVICES'S NOVEMBER 2017 BUDGET REQUEST  
5 TO THE JOINT BUDGET COMMITTEE:".

6 Page 5, line 12, strike "(b)" and substitute "(a)" and strike the first and  
7 second "JULY" and substitute "SEPTEMBER".

8 Page 5, line 18, strike "(c)" and substitute "(b)".

9 Page 8, before line 2 insert:

10 **"SECTION 2. Appropriation.** (1) For the 2017-18 state fiscal  
11 year, \$26,000 is appropriated to the department of human services. This  
12 appropriation is from the general fund. To implement this act, the  
13 department may use this appropriation as follows:

14 (a) \$24,000 for use by the office of behavioral health for personal  
15 services; and

16 (b) \$2,000 for use by the office of behavioral health for operating  
17 expenses.".

18 Renumber succeeding section accordingly.

19 Page 1, strike line 103 and substitute "SYSTEMS, AND, IN CONNECTION  
20 THEREWITH, MAKING AN APPROPRIATION.".

21 Amend the Judiciary Committee Report, dated February 13, 2017, page  
22 2, strike lines 13 and 14.

23 Page 5 of the bill, strike lines 23 through 27.

24 Page 6, strike lines 1 through 6.

25 Page 6, line 7, strike "(b)" and substitute "(c)" and strike "JULY 1, 2017,"  
26 and substitute "SEPTEMBER 1, 2018,".

27 Page 6, line 12, strike "(2)(a)" and substitute "(1)(b)".

28 Page 6, line 18, strike "(3) (a)" and substitute "(c) (I)".

- 1 Page 7, line 2, strike "(b)" and substitute "(II)".
- 2 Page 7, line 13, strike "(4)" and substitute "(d)".
- 3 Page 7, line 18, strike "JULY 1, 2017." and substitute "SEPTEMBER 1,  
4 2018."
- 5 Page 2 of the Report, strike line 20 and substitute:  
6 "Page 7, line 19, strike "(5)" and substitute "(3) (a)" and strike "2018,"  
7 and substitute "2019,"."
