A BILL FOR AN ACT

101 **CONCERNING THE COLORADO COMMISSION FOR THE DEAF AND HARD**
102 **OF HEARING, AND, IN CONNECTION THEREWITH, RENAMING THE**
103 **COMMISSION THE COLORADO COMMISSION FOR THE DEAF, HARD**
104 **OF HEARING, AND DEAFBLIND; CREATING THE COLORADO**
105 **DEAFBLIND CITIZENS COUNCIL TO ADVISE THE COMMISSION ON**
106 **DEAFBLIND ISSUES; CLARIFYING AND EXPANDING THE**
107 **COMMISSION'S DUTIES TO PROVIDE SERVICES TO THE DEAF,**
108 **HARD OF HEARING, AND DEAFBLIND; AND CHANGING THE**
109 **MEMBERSHIP OF THE COMMITTEE CHARGED WITH REVIEWING**
110 **GRANT APPLICATIONS.**

The bill changes the name of the "Colorado commission for the deaf and hard of hearing" to the "Colorado commission for the deaf, hard of hearing, and deafblind". The bill expands the commission's duties to include establishing a community access program for one-on-one system navigation and changes the membership on the committee reviewing grant applications under the act. The bill creates the deafblind citizens council to advise the commission on assisting the deafblind community.

Currently the laws of the state refer to "deaf or hard of hearing". The bill updates the references to "deaf, hard of hearing, or deafblind".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 13-71-137 as
3 follows:

4 **13-71-137. Duties and responsibilities of auxiliary services**
5 **providers for jurors who are deaf, hard of hearing, or deafblind.** The
6 court may provide, through the list of available resources coordinated
7 through the Colorado commission for the deaf, ~~and~~ hard of hearing, AND
8 DEAFBLIND pursuant to section 26-21-106 (4), ~~C.R.S.~~, a qualified
9 ~~interpreter~~ AUXILIARY SERVICES PROVIDER, as defined in section
10 13-90-202 (8), to assist during a trial a juror who is deaf, ~~or~~ hard of
11 hearing, OR DEAFBLIND. In the presence of the jury, the court shall instruct
12 the qualified ~~interpreter~~ AUXILIARY SERVICES PROVIDER to make true and
13 complete translations of all court proceedings to the juror who is deaf, ~~or~~
14 hard of hearing, OR DEAFBLIND to the best of the qualified ~~interpreter's~~
15 AUXILIARY SERVICES PROVIDER'S ability. The qualified interpreter ~~shall be~~
16 IS subject to the same orders and admonitions given to the jurors. The
17 court shall permit a qualified ~~interpreter~~ AUXILIARY SERVICES PROVIDER

1 to be present and assist a juror who is deaf, ~~or~~ hard of hearing, OR
2 DEAFBLIND during the deliberations of the jury. In the presence of the
3 jury, the court shall instruct the qualified ~~interpreter~~ AUXILIARY SERVICES
4 PROVIDER to refrain from participating in any manner in the deliberation
5 of the jury and to refrain from having any communications with any
6 member of the jury regarding deliberation, except for true and complete
7 translations of jurors' remarks made during deliberation. A jury verdict
8 reached in the presence of a qualified ~~interpreter~~ AUXILIARY SERVICES
9 PROVIDER, during deliberation, ~~shall be~~ IS valid.

10 **SECTION 2.** In Colorado Revised Statutes, **amend** 13-90-201 as
11 follows:

12 **13-90-201. Legislative declaration.** The general assembly hereby
13 finds and declares that it is the policy of this state to secure the rights of
14 persons who are deaf, ~~or~~ hard of hearing, ~~and cannot readily hear or~~
15 ~~understand or communicate in spoken language~~ OR DEAFBLIND and who
16 consequently cannot equally participate in or benefit from proceedings of
17 the courts or any board, commission, agency, or licensing or law
18 enforcement authority of the state unless qualified ~~interpreters~~ or auxiliary
19 services are available to assist them.

20 **SECTION 3.** In Colorado Revised Statutes, 13-90-202, **amend**
21 (3), (4), (5), (6), (7), and (9) as follows:

22 **13-90-202. Definitions.** As used in this part 2, unless the context
23 otherwise requires:

24 (3) "Auxiliary services" means those aids and services that assist
25 in effective communication with a person who is deaf, ~~or~~ hard of hearing,
26 OR DEAFBLIND, including: ~~but not limited to:~~

27 (a) THE SERVICES OF A QUALIFIED INTERPRETER;

1 (a) (b) The provision of a QUALIFIED ~~computer-aided~~
2 ~~COMMUNICATION ACCESS~~ realtime ~~translations~~ TRANSLATION (CART)
3 reporter;

4 ~~(b)~~ (c) The provision of an assistive listening device; or

5 ~~(c)~~ (d) The acquisition or modification of equipment or devices to
6 assist in effective communication with a person who is deaf, ~~or~~ hard of
7 hearing, OR DEAFBLIND.

8 (4) "Commission" means the Colorado commission for the deaf,
9 ~~and~~ hard of hearing, AND DEAFBLIND in the department of human services
10 created in section 26-21-104. ~~C.R.S.~~

11 (5) ~~"Computer-aided COMMUNICATION ACCESS~~ realtime translation
12 (CART) reporter" means a word-for-word speech-to-text translation
13 service for ~~people who are~~ THE deaf, ~~or~~ hard of hearing, OR DEAFBLIND.

14 (6) "Deaf, ~~or~~ hard of hearing, OR DEAFBLIND" means a person who
15 has a functional hearing loss of sufficient severity to prevent aural
16 comprehension, even with the assistance of hearing aids.

17 (7) "Effective communication" means those methods of
18 communication that are individualized and culturally appropriate to a
19 person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND so that he or she
20 can easily ~~understand~~ ACCESS all auditory information.

21 (9) "State court system" means the system of courts, or any part
22 thereof, established pursuant to articles 1 to 9 of this ~~title~~ TITLE 13 and
23 article VI of the state constitution. "State court system" ~~shall~~ DOES not
24 include the municipal courts or any part thereof.

25 **SECTION 4.** In Colorado Revised Statutes, 13-90-204, **amend**
26 (1) introductory portion, (1)(a), (1)(b), (1)(c), (1)(d), and (1)(f) as follows:

27 **13-90-204. Appointment of auxiliary services providers.** (1) A

1 ~~qualified interpreter or auxiliary service shall be provided by~~ An
2 appointing authority SHALL PROVIDE A QUALIFIED AUXILIARY SERVICES
3 PROVIDER to interpret the proceedings to a person who is deaf, ~~or~~ hard of
4 hearing, OR DEAFBLIND and to interpret the statements of the person who
5 is deaf, ~~or~~ hard of hearing, OR DEAFBLIND in the following instances:

6 (a) When a person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND
7 is present and participating as the principal party of interest or a witness
8 at any civil or criminal proceeding, including but not limited to any
9 criminal or civil court proceeding in the state court system; a
10 court-ordered or court-provided alternative dispute resolution, mediation,
11 arbitration, or treatment; an administrative, commission, or agency
12 hearing; or a hearing of a licensing authority of the state;

13 (b) When a person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND
14 is involved in any stage of grand jury or jury proceedings as a potential
15 or selected juror;

16 (c) When a juvenile whose parent or parents are deaf, ~~or~~ hard of
17 hearing, OR DEAFBLIND is brought before a court for any reason;

18 (d) When a person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND
19 is arrested and taken into custody for an alleged violation of a criminal
20 law of the state or any of its political subdivisions. Such appointment
21 shall be made prior to any attempt to notify the arrestee of his or her
22 constitutional rights and prior to any attempt to interrogate or to take a
23 statement from ~~such~~ THE person; except that a person who is deaf, ~~or~~ hard
24 of hearing, OR DEAFBLIND and who is otherwise eligible for release shall
25 not be held pending the arrival of a qualified interpreter.

26 (f) When effective communication cannot be established without
27 an auxiliary service and when an alleged victim or witness is a person

1 who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND, who uses sign language
2 for effective communication, and who is questioned or otherwise
3 interviewed by a person having a law enforcement or prosecutorial
4 function in any criminal investigation, except where the length,
5 importance, or complexity of the communication does not warrant
6 provision of an auxiliary service. Assessment of whether the length,
7 importance, or complexity of the communication warrants provision of
8 an auxiliary service shall be made in accordance with United States
9 department of justice regulations effectuating Title II of the federal
10 "Americans with Disabilities Act of 1990", as from time to time may be
11 amended, Pub.L. 101-336, codified at 42 U.S.C. sec. 12101 et seq.,
12 including regulations, analysis, and technical assistance.

13 **SECTION 5.** In Colorado Revised Statutes, **amend** 13-90-205 as
14 follows:

15 **13-90-205. Coordination of auxiliary services requests.** (1) The
16 commission, in collaboration with the judicial department, shall establish,
17 monitor, coordinate, and publish a list of available resources regarding
18 communication accessibility for persons who are deaf, ~~or~~ hard of hearing,
19 OR DEAFBLIND, including ~~but not limited to~~ qualified interpreters and
20 auxiliary services PROVIDERS, for use by an appointing authority pursuant
21 to section 13-90-204. ~~Such~~ THE list shall MUST contain ~~but not be limited~~
22 ~~to,~~ the names of private ~~community programs~~ INDIVIDUAL PROVIDERS and
23 agencies that secure qualified interpreters and auxiliary services for
24 assignment.

25 (2) Whenever a qualified interpreter or auxiliary service is required
26 pursuant to section 13-90-204, the appointing authority shall secure ~~such~~
27 ~~interpreter or~~ THE auxiliary service through the list of available resources

1 made available and coordinated by the commission IN ACCORDANCE WITH
2 SUBSECTION (1) OF THIS SECTION.

3 (3) THE COMMISSION SHALL PROVIDE AUXILIARY SERVICES FOR A
4 PROCEEDING DESCRIBED BY SECTION 13-90-204 (1)(a), (1)(b), OR (1)(c).

5 THE COMMISSION DOES NOT HAVE ADDITIONAL RESPONSIBILITIES
6 BEYOND THE REQUIREMENTS OF SUBSECTION (1) OF THIS SECTION FOR A
7 PROCEEDING DESCRIBED IN SECTION 13-90-204 (1)(d) OR (1)(f).

8 **SECTION 6.** In Colorado Revised Statutes, 13-90-207, **amend**
9 (1) introductory portion, (1)(b), and (1)(c) as follows:

10 **13-90-207. Requirements to be met prior to commencing**
11 **proceedings.** (1) Prior to commencing any proceedings pursuant to
12 section 13-90-204 requiring a qualified ~~interpreter or auxiliary service~~
13 SERVICES PROVIDER, the following conditions shall be met:

14 (b) The qualified ~~interpreter or auxiliary service~~ SERVICES
15 PROVIDER shall be in full view and spatially situated to assure effective
16 communication with the person or persons who are deaf, ~~or~~ hard of
17 hearing, OR DEAFBLIND.

18 (c) The appointing authority shall make a reasonable attempt to
19 provide a qualified ~~interpreter or auxiliary service~~ SERVICES PROVIDER
20 that is effective to the person who is deaf, ~~or~~ hard of hearing, OR
21 DEAFBLIND.

22 **SECTION 7.** In Colorado Revised Statutes, **amend** 13-90-208 as
23 follows:

24 **13-90-208. Waiver.** The right of a person who is deaf, ~~or~~ hard of
25 hearing, OR DEAFBLIND to a qualified ~~interpreter or auxiliary service~~ may
26 not be waived except in writing by the person who is deaf, ~~or~~ hard of
27 hearing, OR DEAFBLIND. Prior to executing ~~such~~ a waiver, a person who

1 is deaf, ~~or~~ hard of hearing, OR DEAFBLIND may have access to counsel for
2 advice and shall have actual, full knowledge of the right to effective
3 communication. ~~Such~~ THE waiver is subject to the approval of counsel,
4 if any, to the person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND and
5 is also subject to the approval of the appointing authority. In no event is
6 the failure of the person who is deaf, ~~or~~ hard of hearing, OR DEAFBLIND
7 to request a qualified interpreter ~~or~~ auxiliary service deemed a waiver of
8 this right.

9 **SECTION 8.** In Colorado Revised Statutes, 18-1.3-701, **amend**
10 (1)(c) as follows:

11 **18-1.3-701. Judgment for costs and fines - definitions.**

12 (1) (c) Judgments collected pursuant to this section for fees for
13 ~~interpreters or~~ auxiliary services provided pursuant to section 13-90-204,
14 ~~C.R.S.~~, and reimbursed pursuant to section 13-90-210, ~~C.R.S.~~, shall be
15 remitted to the Colorado commission for the deaf, ~~and~~ hard of hearing,
16 AND DEAFBLIND in the department of human services created in section
17 26-21-104. ~~C.R.S.~~

18 **SECTION 9.** In Colorado Revised Statutes, 24-1-120, **amend**
19 (5)(h) as follows:

20 **24-1-120. Department of human services - creation.** (5) The
21 department of human services shall include the following:

22 (h) The Colorado commission for the deaf, ~~and~~ hard of hearing,
23 AND DEAFBLIND, created by article 21 of title 26. ~~C.R.S. Said~~ THE
24 commission shall exercise its powers, duties, and functions under the
25 department as if transferred by a **type 2** transfer.

26 **SECTION 10.** In Colorado Revised Statutes, 24-34-104, **amend**
27 (25)(a)(XII) as follows:

1 **24-34-104. General assembly review of regulatory agencies**
2 **and functions for repeal, continuation, or reestablishment - legislative**
3 **declaration - repeal.** (25) (a) The following agencies, functions, or both,
4 are scheduled for repeal on September 1, 2024:

5 (XII) The Colorado commission for the deaf, ~~and~~ hard of hearing,
6 AND DEAFBLIND created in article 21 of title 26;

7 **SECTION 11.** In Colorado Revised Statutes, **amend** 26-21-101
8 as follows:

9 **26-21-101. Short title.** ~~This article shall be known and may be~~
10 ~~cited as~~ THE SHORT TITLE OF THIS ARTICLE 21 IS the "Colorado
11 Commission for the Deaf, ~~and~~ Hard of Hearing, AND DEAFBLIND Act".

12 **SECTION 12.** In Colorado Revised Statutes, **amend** 26-21-102
13 as follows:

14 **26-21-102. Legislative declaration.** The general assembly hereby
15 finds, determines, and declares that a commission for the deaf, ~~and~~ hard
16 of hearing, ~~would facilitate~~ AND DEAFBLIND FACILITATES the provision of
17 ~~general governmental~~ STATE AND LOCAL GOVERNMENT services to the
18 deaf, ~~and~~ hard of hearing, ~~community~~ AND DEAFBLIND while making
19 government more efficient. Under the federal "Americans with
20 Disabilities Act of 1990", 42 U.S.C. sec. 12101 ET SEQ., AS AMENDED,
21 Colorado has a duty to provide EQUIVALENT ACCESS TO STATE
22 GOVERNMENT AND PUBLIC ACCOMMODATIONS to the deaf, ~~and~~ hard of
23 hearing, ~~equivalent access to governmental services~~ AND DEAFBLIND. This
24 duty requires state departments and agencies to provide auxiliary services,
25 ~~telecommunications~~ COMMUNICATIONS TECHNOLOGY equipment, and
26 other resources ~~in order to enable~~ ENSURE access. ~~for the deaf and hard~~
27 ~~of hearing community.~~ Centralizing and unifying such resources under a

1 COLORADO commission ~~has the potential to create~~ CREATES cost savings
2 for ~~both the state. and the deaf and hard of hearing community.~~ In
3 addition, ~~such~~ THE consolidation of resources ~~will facilitate~~ FACILITATES
4 quality control and ~~thus increase~~ INCREASES the ~~quality~~ EFFECTIVENESS
5 of ~~governmental~~ services while increasing access TO SERVICES by the
6 deaf, ~~and hard of hearing, community to those services~~ AND DEAFBLIND.

13 ~~programs included in the commission's statutory duties.~~

14 (2) (1) "Auxiliary services" means ~~qualified interpreters,~~
15 ~~communication access realtime translation providers, assistive listening~~
16 ~~devices or systems, and other effective methods of making spoken or~~
17 ~~written information available to deaf or hard of hearing individuals~~ THOSE
18 AIDS AND SERVICES THAT ASSIST IN EFFECTIVE COMMUNICATION WITH A
19 PERSON WHO IS DEAF, HARD OF HEARING, OR DEAFBLIND, INCLUDING BUT
20 NOT LIMITED TO:

21 (a) THE SERVICES OF A QUALIFIED INTERPRETER AS DEFINED BY
22 SECTION 13-90-202 (8);

23 (b) THE PROVISION OF A QUALIFIED COMMUNICATION ACCESS
24 REALTIME TRANSLATION (CART) REPORTER;

25 (c) THE PROVISION OF AN ASSISTIVE LISTENING DEVICE; OR

26 (d) THE ACQUISITION OR MODIFICATION OF EQUIPMENT OR DEVICES
27 TO ASSIST IN EFFECTIVE COMMUNICATION WITH A PERSON WHO IS DEAF,

1 HARD OF HEARING, OR DEAFBLIND.

2 (2) "CITIZENS COUNCIL" MEANS THE COLORADO DEAFBLIND
3 CITIZENS COUNCIL APPOINTED BY THE COMMISSION IN ACCORDANCE WITH
4 SECTION 26-21-105 (2)(f).

5 (3) "Commission" means the Colorado commission for the deaf,
6 ~~and~~ hard of hearing, AND DEAFBLIND.

7 ~~(3.3) "Deaf-blind" or "deaf-blind community" includes persons
8 whose varying degrees of hearing and visual acuity limit total aural and
9 visual comprehension.~~

10 ~~(3.6) "Deaf or hard of hearing" or "deaf and hard of hearing
11 community" includes:~~

12 ~~(a) Persons whose varying degrees of hearing acuity limit total
13 aural comprehension; and~~

14 ~~(b) Persons whose varying degrees of hearing acuity and visual
15 acuity limit total aural and visual comprehension.~~

16 (4) ~~"Fund" means the Colorado commission for the deaf and hard
17 of hearing cash fund created in section 26-21-107~~ "COMMUNICATIONS
18 TECHNOLOGY" MEANS ANY COMMUNICATION DEVICE OR APPLICATION
19 UTILIZING RADIO, TELEVISION, CELLULAR PHONE, COMPUTER AND
20 NETWORK HARDWARE AND SOFTWARE, SATELLITE, CABLE, BROADBAND
21 SYSTEMS, OR SIMILAR MEDIUM AND THE SERVICES AND APPLICATIONS
22 ASSOCIATED WITH THOSE MEDIUMS, INCLUDING VIDEO AND
23 TELECONFERENCE SERVICES.

24 (5) ~~"Grant program" means the Colorado commission for the deaf
25 and hard of hearing grant program created in section 26-21-107.5.~~

26 (6) (5) "Late deafened" means a person whose hearing loss began
27 in late childhood, adolescence, or adulthood, after the person acquired

1 oral language skills.

2 (6) "LATENT DEAFBLIND" MEANS A PERSON WHO HAS AN EXISTING
3 EAR AND EYE CONDITION THAT HAS NOT YET MANIFESTED.

4 (7) "LOW VISION" MEANS AN EYE CONDITION WHERE VISUAL
5 ACUITY IS 20/70 OR POORER IN THE BETTER EYE AND THE CONDITION
6 CANNOT BE CORRECTED OR IMPROVED WITH OPTICAL CORRECTIVE
7 DEVICES.

8 (8) "ORIENTATION AND MOBILITY SPECIALIST" MEANS A
9 PROFESSIONAL THAT FOCUSES ON INSTRUCTING INDIVIDUALS WHO ARE
10 DEAFBLIND ON HOW TO EFFECTIVELY AND INDEPENDENTLY TRAVEL
11 THROUGH THEIR ENVIRONMENT.

12 ~~(7)~~ (9) "State court system" means the system of courts, or any
13 part thereof, established pursuant to articles 1 to 9 of title 13 C.R.S., and
14 article VI of the state constitution. "State court system" ~~shall~~ DOES not
15 include the municipal courts or any part thereof.

16 ~~(8) "Telecommunications" means the science and technology of~~
17 ~~transmitting voice, audio, facsimile, image, video, computer data, and~~
18 ~~multimedia information over significant distances by the use of~~
19 ~~electromagnetic energy in the form of electricity, radio, or fiber optics.~~

20 (10) "SUPPORT SERVICE PROVIDER" MEANS A PERSON WHO
21 PROVIDES VISUAL AND ENVIRONMENTAL INFORMATION, ACTS AS A
22 SIGHTED GUIDE, OR FACILITATES COMMUNICATION FOR DEAFBLIND
23 INDIVIDUALS.

24 **SECTION 14.** In Colorado Revised Statutes, 26-21-104, **amend**
25 (1), (2)(c), (2)(d), (2)(f), and (2)(g) as follows:

26 **26-21-104. Commission created - appointments.** (1) Effective
27 ~~July 1, 2000, there is hereby created~~ The Colorado commission for the

1 deaf, ~~and~~ hard of hearing, AND DEAFBLIND IS CREATED in the department
2 of human services. The ~~Colorado~~ commission for the deaf and hard of
3 hearing shall exercise its powers, duties, and functions under the
4 department of human services as if it were transferred to ~~said~~ THE
5 department by a **type 2** transfer under the provisions of the
6 "Administrative Organization Act of 1968", ARTICLE 1 OF TITLE 24.

7 (2) The commission consists of seven members as follows:

8 (c) One member who is a professional working with individuals
9 in the deaf, ~~and hard of hearing~~ HARD-OF-HEARING, OR DEAFBLIND
10 community;

11 (d) One member who is a parent of a deaf, ~~or hard of hearing~~
12 ~~HARD-OF-HEARING, OR DEAFBLIND~~ person;

13 (f) One member who is an auxiliary ~~service~~ SERVICES provider for
14 the deaf, ~~or~~ hard of hearing, OR DEAFBLIND and who is qualified to use at
15 least one of the titles listed in section 6-1-707 (1)(e); ~~C.R.S.~~; and

16 (g) One member who is ~~deaf-blind~~ DEAFBLIND.

17 **SECTION 15.** In Colorado Revised Statutes, 26-21-105, **amend**
18 (1), (2)(a), and (2)(e); and **add** (2)(f) as follows:

19 **26-21-105. Appointment of commission director - commission**
20 **procedures - citizens council - creation.** (1) The executive director of
21 the department of human services or ~~his or her~~ THE EXECUTIVE
22 DIRECTOR'S designee shall appoint ~~the administrator~~ A DIRECTOR of the
23 Colorado commission. ~~for the deaf and hard of hearing.~~ The members of
24 the commission may interview candidates for administrator and
25 EXECUTIVE DIRECTOR OF THE DEPARTMENT SHALL provide comment and
26 input to the ~~executive director~~ COMMISSION on the hiring of a candidate
27 THE DIRECTOR.

1 (2) (a) The commission shall convene for its first meeting OF
2 EACH FISCAL YEAR no later than ~~September~~ OCTOBER 1, 2000. ~~At the first~~
3 ~~meeting, a chair shall be elected by the commission.~~

21 **SECTION 22. Act subject to petition - effective date.** This act
