A BILL FOR AN ACT

101 CONCERNING THE SAFE2TELL PROGRAM, AND, IN CONNECTION  
102 THEREWITH, CREATING NEW DUTIES FOR THE SAFE2TELL  
103 PROGRAM, REQUIRING THE SAFE2TELL PROGRAM TO PREPARE  
104 AN ANNUAL REPORT THAT ANALYZES DATA FROM THE PROGRAM  
105 AND MAKES RECOMMENDATIONS ON IMPROVING THE PROGRAM,  
106 AND MAKING AN APPROPRIATION.

Bill Summary

following:

- ! Provide training and support to all preschool, elementary, and secondary schools and school districts in Colorado regarding school safety, including answering questions and discussing reports received by the program;
- ! Provide educational materials to all preschool, elementary, and secondary schools in Colorado aimed at preventing misuse of the program;
- ! Provide technical assistance and support to law enforcement officials and school officials when there is misuse of the program; and
- ! Analyze and follow up with law enforcement and schools to determine the outcome of a report made to the program, including actions taken on the report.

The bill requires the safe2tell program to prepare a written report analyzing data from the previous year on or before each December 1, beginning in 2018. The report must include data from the preceding fiscal year concerning the following and any recommendations concerning the following:

- ! A summary of outcomes and actions taken on reports made to the program;
- ! The number of safe2tell reports by category, broken down by month;
- ! The total number of incidents of misuse of the program, broken down into categories;
- ! The number of reports received involving a single incident;
- ! The number of times safe2tell was used by a reporting party to make a threat against or otherwise harm another person;
- ! The number of times a reporting party was in crisis and was reporting to the program to obtain assistance and the time it took to identify the reporting party and respond;
- ! The effectiveness of the safe2tell dispatch center in the department of public safety; and
- ! Recommendations regarding how to improve the program based on the available data.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-31-606, **amend**  
3 (2)(i); and **add** (2)(k), (2)(l), (2)(m), and (2)(n) as follows:

4 **24-31-606. Safe2tell program - creation - duties.** (2) The

1 program must:

2 (i) Develop training curriculum and teaching materials for a train  
3 the trainer program; ~~and~~

4 (k) PROVIDE TRAINING AND SUPPORT TO ALL PRESCHOOL,  
5 ELEMENTARY, AND SECONDARY SCHOOLS AND SCHOOL DISTRICTS IN  
6 COLORADO REGARDING SCHOOL SAFETY RELATED TO THE SAFE2TELL  
7 PROGRAM, INCLUDING ANSWERING QUESTIONS AND DISCUSSING REPORTS  
8 RECEIVED BY THE PROGRAM;

9 (l) PROVIDE EDUCATIONAL MATERIALS TO ALL PRESCHOOL,  
10 ELEMENTARY, AND SECONDARY SCHOOLS IN COLORADO AIMED AT  
11 PREVENTING MISUSE OF THE PROGRAM;

12 (m) PROVIDE TECHNICAL ASSISTANCE AND SUPPORT TO LAW  
13 ENFORCEMENT OFFICIALS AND SCHOOL OFFICIALS WHEN THERE IS MISUSE  
14 OF THE PROGRAM; AND

15 (n) ANALYZE AND FOLLOW UP WITH LAW ENFORCEMENT AND  
16 SCHOOLS TO DETERMINE THE OUTCOME OF A REPORT MADE TO THE  
17 PROGRAM, INCLUDING ACTIONS TAKEN ON THE REPORT.

18 **SECTION 2.** In Colorado Revised Statutes, **add** 24-31-611 as  
19 follows:

20 **24-31-611. Annual report.** (1) ON OR BEFORE DECEMBER 1,  
21 2018, AND ON OR BEFORE DECEMBER 1 OF EACH YEAR THEREAFTER, THE  
22 PROGRAM SHALL ANALYZE DATA FROM THE PRECEDING FISCAL YEAR AND  
23 PREPARE A WRITTEN REPORT. THE PROGRAM SHALL POST THE REPORT ON  
24 THE PROGRAM'S WEBSITE AND SHALL SUBMIT THE REPORT TO THE  
25 EDUCATION AND JUDICIARY COMMITTEES OF THE HOUSE OF  
26 REPRESENTATIVES AND THE SENATE, OR ANY SUCCESSOR COMMITTEES, BY  
27 JANUARY 1 OF THE YEAR FOLLOWING PUBLICATION OF THE REPORT. THE

1 REPORT MUST INCLUDE DATA FROM THE PRECEDING FISCAL YEAR  
2 CONCERNING THE FOLLOWING AND ANY RECOMMENDATIONS CONCERNING  
3 THE FOLLOWING TO THE EXTENT THE INFORMATION IS AVAILABLE:

4 (a) A SUMMARY OF OUTCOMES AND ACTIONS TAKEN ON REPORTS  
5 MADE TO THE PROGRAM;

6 (b) THE NUMBER OF SAFE2TELL REPORTS BY CATEGORY, BROKEN  
7 DOWN BY MONTH;

8 (c) THE TOTAL NUMBER OF INCIDENTS OF MISUSE OF THE  
9 PROGRAM, BROKEN DOWN INTO CATEGORIES;

10 (d) THE NUMBER OF REPORTS RECEIVED INVOLVING A SINGLE  
11 INCIDENT;

12 (e) THE NUMBER OF TIMES SAFE2TELL WAS USED BY A REPORTING  
13 PARTY TO MAKE A THREAT AGAINST OR OTHERWISE HARM ANOTHER  
14 PERSON;

15 (f) THE NUMBER OF TIMES A REPORTING PARTY WAS IN CRISIS AND  
16 WAS REPORTING TO THE PROGRAM TO OBTAIN ASSISTANCE AND THE TIME  
17 IT TOOK TO IDENTIFY THE REPORTING PARTY AND RESPOND;

18 (g) THE EFFECTIVENESS OF THE SAFE2TELL DISPATCH CENTER IN  
19 THE DEPARTMENT OF PUBLIC SAFETY; AND

20 (h) RECOMMENDATIONS REGARDING HOW TO IMPROVE THE  
21 PROGRAM BASED ON THE AVAILABLE DATA.

22 (2) NOTWITHSTANDING THE PROVISIONS OF SECTION 24-1-136  
23 (11)(a)(I), THE REQUIREMENT FOR THE REPORT IN SUBSECTION (1) OF THIS  
24 SECTION CONTINUES INDEFINITELY.

25 **SECTION 3. Appropriation.** For the 2018-19 state fiscal year,  
26 \$164,920 is appropriated to the department of law. This appropriation is  
27 from the marijuana tax cash fund created in section 39-28.8-501 (1),

1 C.R.S., and is based on an assumption that the department will require an  
2 additional 1.6 FTE. To implement this act, the department may use this  
3 appropriation for the office of community engagement.

4 **SECTION 4. Act subject to petition - effective date.** This act  
5 takes effect at 12:01 a.m. on the day following the expiration of the  
6 ninety-day period after final adjournment of the general assembly (August  
7 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a  
8 referendum petition is filed pursuant to section 1 (3) of article V of the  
9 state constitution against this act or an item, section, or part of this act  
10 within such period, then the act, item, section, or part will not take effect  
11 unless approved by the people at the general election to be held in  
12 November 2018 and, in such case, will take effect on the date of the  
13 official declaration of the vote thereon by the governor.
