1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-22-115, **add**  
3 (1)(c) as follows:

4           **24-22-115. Tobacco litigation settlement cash fund - health**  
5 **care supplemental appropriations and overexpenditures account -**  
6 **creation - repeal.** (1) (c) (I) ON JULY 1, 2018, THE STATE TREASURER  
7 SHALL TRANSFER NINETEEN MILLION NINE HUNDRED SIXTY-FIVE  
8 THOUSAND SIXTY-EIGHT DOLLARS FROM THE GENERAL FUND TO THE  
9 TOBACCO LITIGATION SETTLEMENT CASH FUND.

10           (II) THIS SUBSECTION (1)(c) IS REPEALED, EFFECTIVE JULY 1, 2019.

11           **SECTION 2.** In Colorado Revised Statutes, 24-75-1104.5, **add**  
12 (9) as follows:

13           **24-75-1104.5. Use of settlement moneys - programs - repeal.**  
14 (9) (a) FOR THE FISCAL YEAR 2018-19, THE MONEY THAT WAS  
15 TRANSFERRED FROM THE GENERAL FUND TO THE TOBACCO LITIGATION  
16 SETTLEMENT CASH FUND IN ACCORDANCE WITH SECTION 24-22-115  
17 (1)(c)(I), IS ALLOCATED IN THE PERCENTAGES SPECIFIED AND FOR THE  
18 PROGRAMS, SERVICES, AND FUNDS SPECIFIED IN SUBSECTION (1.7) OF THIS  
19 SECTION.

20           (b) THIS SUBSECTION (9) IS REPEALED, EFFECTIVE JULY 1, 2019.

21           **SECTION 3. Safety clause.** The general assembly hereby finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, and safety.
