A BILL FOR AN ACT

101 **CONCERNING COMMUNITY SOLAR GARDENS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill amends the current statute authorizing the creation of community solar gardens (CSGs) by:

- ! Increasing the maximum size of a CSG from 2 megawatts to 10 megawatts; and
- ! Removing the requirement that a CSG subscriber's identified physical location be in the same county as, or a county adjacent to, that of the CSG, while retaining the requirement that it be within the service territory of the

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-23-104, **amend**
3 **(2)(f.5)** as follows:

4 **12-23-104. Board powers and duties - rules. (2)** In addition to
5 **all other powers and duties conferred or imposed upon the board by this**
6 **article, the board is authorized to:**

7 **(f.5) Regulate a licensed master electrician, journeyman**
8 **electrician, or residential wireman who, acting within his or her scope of**
9 **competence, supervises a solar photovoltaic installation pursuant to**
10 **section 40-2-128. C.R.S.; ON AND AFTER JANUARY 1, 2020, ALL**
11 **PHOTOVOLTAIC ELECTRICAL WORK FOR INSTALLATIONS OF AT LEAST**
12 **THREE HUNDRED KILOWATTS, INCLUDING THE INTERCONNECTION OF THE**
13 **MODULES, GROUNDING OF THE MODULES, ANY BALANCE OF SYSTEM**
14 **WIRING, AND THE CUSTOMER-SIDE POINT OF CONNECTION TO THE UTILITY**
15 **GRID, MUST BE PERFORMED BY A LICENSED MASTER ELECTRICIAN,**
16 **LICENSED JOURNEYMAN ELECTRICIAN, LICENSED RESIDENTIAL WIREMAN,**
17 **OR PROPERLY SUPERVISED ELECTRICAL APPRENTICES AND MUST COMPLY**
18 **WITH ALL APPLICABLE REQUIREMENTS OF THIS ARTICLE 23, INCLUDING**
19 **SECTIONS 12-23-105 AND 12-23-110.5, AND ALL APPLICABLE RULES OF**
20 **THE BOARD.**

21 **SECTION 2.** In Colorado Revised Statutes, 40-2-127, **amend**
22 **(2)(b)(I)(A), (2)(b)(II), and (5)(b)(I); and add (2)(b)(I)(D) and (3.5) as**
23 **follows:**

24 **40-2-127. Community energy funds - community solar**
25 **gardens - definitions - rules - legislative declaration. (2) Definitions.**

1 As used in this section, unless the context otherwise requires:

2 (b) In addition:

3 (I) (A) "Community solar garden" means a solar electric
4 generation facility with a nameplate rating ~~of two megawatts or less~~
5 WITHIN THE RANGE SPECIFIED UNDER SUBSECTION (2)(b)(I)(D) OF THIS
6 SECTION that is located in or near a community served by a qualifying
7 retail utility where the beneficial use of the electricity generated by the
8 facility belongs to the subscribers to the community solar garden. There
9 shall be at least ten subscribers. The owner of the community solar garden
10 may be the qualifying retail utility or any other for-profit or nonprofit
11 entity or organization, including a subscriber organization organized
12 under this section, that contracts to sell the output from the community
13 solar garden to the qualifying retail utility. A community solar garden
14 shall be deemed to be "located on the site of customer facilities".

15 (D) A COMMUNITY SOLAR GARDEN MUST HAVE A NAMEPLATE
16 RATING OF FIVE MEGAWATTS OR LESS; EXCEPT THAT THE COMMISSION
17 MAY, IN RULES ADOPTED PURSUANT TO SUBSECTION (3)(b) OF THIS
18 SECTION, APPROVE THE FORMATION OF A COMMUNITY SOLAR GARDEN
19 WITH A NAMEPLATE RATING OF UP TO TEN MEGAWATTS ON OR AFTER JULY
20 1, 2023.

21 (II) "Subscriber" means a retail customer of a qualifying retail
22 utility who owns a subscription and who has identified one or more
23 physical locations to which the subscription is attributed. Such physical
24 locations must be within the service territory of the same qualifying retail
25 utility ~~and also in the same county as, or a county adjacent to, that of AS~~
26 the community solar garden. The subscriber may change from time to
27 time the premises to which the community solar garden electricity

1 generation shall be attributed, so long as the premises are within the
2 ~~geographical limits allowed for a subscriber~~ SAME SERVICE TERRITORY.

3 **(3.5) Standards for construction and operation.** THE
4 FOLLOWING REQUIREMENTS APPLY TO ANY COMMUNITY SOLAR GARDEN
5 EXCEEDING TWO MEGAWATTS:

7 (a) THE INITIAL INSTALLATION OF ANY PHOTOVOLTAIC MODULE OR
8 ASSOCIATED ELECTRICAL EQUIPMENT == IS SUBJECT TO FINAL INSPECTION
9 AND APPROVAL IN ACCORDANCE WITH SECTION 12-23-116.

10 (b) IF A QUALIFYING RETAIL UTILITY OWNS ALL OR PART OF A
11 COMMUNITY SOLAR GARDEN, THE UTILITY SHALL USE ITS OWN EMPLOYEES
12 TO OPERATE AND MAINTAIN THE MODULES AND OTHER ELECTRICAL
13 EQUIPMENT THAT THE UTILITY OWNS.

15 **(5) Purchases of the output from community solar gardens.**

16 (b) (I) (A) The output from a community solar garden shall be sold only
17 to the qualifying retail utility serving the geographic area where the
18 community solar garden is located.

19 (B) Once a community solar garden is part of a qualifying retail
20 utility's plan for acquisition of renewable resources, as approved by the
21 commission, THE COMMISSION SHALL BY JANUARY 30, 2020, INITIATE A
22 PROCEEDING, OR CONSIDER IN AN ACTIVE PROCEEDING, TO DETERMINE
23 WHETHER the qualifying retail utility shall purchase all of the electricity
24 and renewable energy credits generated by the community solar garden
25 OR WHETHER A SUBSCRIBER MAY, UPON BECOMING A SUBSCRIBER, CHOOSE
26 TO RETAIN OR SELL TO THE QUALIFYING RETAIL UTILITY THE SUBSCRIBER'S
27 RENEWABLE ENERGY CREDITS.

1 (C) The amount of electricity and renewable energy credits
2 generated by each community solar garden shall be determined by a
3 production meter installed by the qualifying retail utility or third-party
4 system owner and paid for by the owner of the community solar garden.

5 **SECTION 3.** In Colorado Revised Statutes, 40-2-128, **amend** (1)
6 introductory portion, (1)(a)(I)(D), and (1)(d) introductory portion; and
7 **repeal** (1)(c) as follows:

8 **40-2-128. Solar photovoltaic installations - supervision by**
9 **certified practitioners - qualifications of electrical contractors.**

10 (1) For all photovoltaic installations funded wholly or partially through
11 ratepayer-funded incentives as part of the renewable energy standard
12 adjustment allowed under section 40-2-124 WITH A DIRECT CURRENT
13 DESIGN CAPACITY OF LESS THAN THREE HUNDRED KILOWATTS:

14 (a) (I) (D) By submitting an initial application for funding or an
15 initial contract proposal, the applicant assumes responsibility for
16 employing or contracting with one or more certified energy practitioners
17 or licensed master electricians, licensed journeyman electricians, or
18 licensed residential wiremen to supervise the installation and as necessary
19 to maintain the three-to-one ratio required by paragraphs (b) and (c) of
20 ~~this subsection (1)~~ SUBSECTION (1)(b) OF THIS SECTION, including during
21 any off-site, preinstallation assembly. Payment of any incentives for the
22 work shall not be approved until the applicant supplies the name and
23 certification number of each certified energy practitioner or the license
24 number of each master electrician, journeyman electrician, or residential
25 wireman who actually provided on-site supervision or was present to
26 maintain the three-to-one ratio required by paragraphs (c) and (d) of this

1 (2) In addition to all other powers and duties conferred or imposed upon
2 the board by this article 115, the board is authorized to:

3 (f) Regulate a licensed master electrician, journeyman electrician,
4 or residential wireman who, acting within his or her scope of competence,
5 supervises a solar photovoltaic installation pursuant to section 40-2-128.
6 ON AND AFTER JANUARY 1, 2020, ALL PHOTOVOLTAIC ELECTRICAL WORK
7 FOR INSTALLATIONS OF AT LEAST THREE HUNDRED KILOWATTS, INCLUDING
8 THE INTERCONNECTION OF THE MODULES, GROUNDING OF THE MODULES,
9 ANY BALANCE OF SYSTEM WIRING, AND THE CUSTOMER-SIDE POINT OF
10 CONNECTION TO THE UTILITY GRID, MUST BE PERFORMED BY A LICENSED
11 MASTER ELECTRICIAN, LICENSED JOURNEYMAN ELECTRICIAN, LICENSED
12 RESIDENTIAL WIREMAN, OR PROPERLY SUPERVISED ELECTRICAL
13 APPRENTICES AND MUST COMPLY WITH ALL APPLICABLE REQUIREMENTS
14 OF THIS ARTICLE 115, INCLUDING SECTIONS 12-115-109 AND 12-115-115,
15 AND ALL APPLICABLE RULES OF THE BOARD.

16 **SECTION 5. Act subject to petition - effective date.** (1) Except
17 as otherwise provided in subsection (2) of this section, this act takes
18 effect at 12:01 a.m. on the day following the expiration of the ninety-day
19 period after final adjournment of the general assembly (August 2, 2019,
20 if adjournment sine die is on May 3, 2019); except that, if a referendum
21 petition is filed pursuant to section 1 (3) of article V of the state
22 constitution against this act or an item, section, or part of this act within
23 such period, then the act, item, section, or part will not take effect unless
24 approved by the people at the general election to be held in November
25 2020 and, in such case, will take effect on the date of the official
26 declaration of the vote thereon by the governor.

1 (2) Section 4 of this act takes effect only if House Bill 19-1172
2 becomes law, in which case section 4 takes effect October 1, 2019.
