Bill Summary

offers to its students. The bill adds basic life skills education to this list of courses and programs.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-11-503, **add**
3 (3)(f)(XVIII) as follows:

4 **22-11-503. Performance reports - contents - rules.** (3) In
5 addition to any information specified by rule of the state board, each
6 school performance report shall include the following information
7 concerning the operations and environment of the public school that is the
8 subject of the report:

9 (f) Information concerning whether the following courses and
10 programs, which are not included in the statewide assessments, are
11 available to students enrolled in the public school and, to the extent they
12 are available on the public school's or school district's website, internet
13 links to descriptions of these courses and programs:

14 (XVIII) BASIC LIFE SKILLS EDUCATION, WHICH INCLUDES THE
15 FOLLOWING INFORMATION:

16 (A) FINANCIAL LITERACY CURRICULUM, AS DESCRIBED IN SECTION
17 22-32-135, SUCH AS HOW TO FORMULATE A HOUSEHOLD BUDGET,
18 BALANCE A CHECKING ACCOUNT, READ AND UNDERSTAND THE TERMS AND
19 CONDITIONS OF A CREDIT CARD, AND OTHERWISE MANAGE PERSONAL
20 FINANCES;

21 (B) HOME ECONOMICS AND NUTRITION EDUCATION, AS DESCRIBED
22 IN SECTION 22-32-136, SUCH AS MAKING HEALTHFUL FOOD CHOICES,
23 ESTABLISHING HEALTHY EATING HABITS AND A BALANCED DIET, AND
24 RECOGNIZING APPROPRIATE PORTION SIZES;

25 (C) STUDENT WELLNESS EDUCATION AND PHYSICAL ACTIVITY, AS

1 DESCRIBED IN SECTION 22-32-136.5;

2 (D) AUTOMOTIVE EDUCATION THAT TEACHES STUDENTS HOW TO
3 CARE FOR AND MAINTAIN AUTOMOBILES, SUCH AS HOW TO CHANGE A FLAT
4 TIRE AND HOW TO PUT ON SNOW CHAINS AND SNOW TIRES;

5 (E) WOOD SHOP, METAL SHOP, OR OTHER CLASSES THAT TEACH
6 STUDENTS ABOUT OPERATING MACHINERY AND BUILDING OR REPAIRING
7 REAL OR PERSONAL PROPERTY; AND

8 (F) HEALTH EDUCATION CONCERNING THE PROPER RESPONSE TO
9 AND TREATMENT OF COMMON MEDICAL CONDITIONS, INCLUDING HOW TO
10 PERFORM CARDIOPULMONARY RESUSCITATION AND THE HEIMLICH
11 MANEUVER AND WHAT TO DO WHEN A PEER LOSES CONSCIOUSNESS OR HAS
12 A SEIZURE; AND

13 **SECTION 2. Act subject to petition - effective date.** This act
14 takes effect at 12:01 a.m. on the day following the expiration of the
15 ninety-day period after final adjournment of the general assembly (August
16 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
17 referendum petition is filed pursuant to section 1 (3) of article V of the
18 state constitution against this act or an item, section, or part of this act
19 within such period, then the act, item, section, or part will not take effect
20 unless approved by the people at the general election to be held in
21 November 2020 and, in such case, will take effect on the date of the
22 official declaration of the vote thereon by the governor.
