A BILL FOR AN ACT

101 **CONCERNING THE REGULATION OF PHARMACY TECHNICIANS BY THE**
102 **STATE BOARD OF PHARMACY, AND, IN CONNECTION THEREWITH,**
103 **MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires pharmacy technicians practicing in Colorado on or after June 15, 2020, to obtain a certification from the state board of pharmacy (board). An applicant for certification by the board must provide proof of certification by a board-approved, nationally recognized organization that certifies pharmacy technicians and must either submit

to a criminal history record check or provide evidence of submitting to a criminal history record check at the time of hire as a pharmacy technician. If an applicant is not certified by a national certifying organization at the time of application for state certification, the board may grant a provisional certification to the applicant to allow the applicant up to 18 months or, if granted a hardship extension, an additional period determined by the board, to obtain national certification. A provisional certification is not renewable, and if the provisional certificant fails to obtain the national certification within the 18-month period or extended period granted by the board, the provisional certification expires and the person cannot practice as a pharmacy technician until the person satisfies all requirements for certification by the board.

To renew a certification, in addition to board requirements for renewal, a pharmacy technician must satisfy renewal and continuing education requirements of the national accrediting organization that certified the pharmacy technician.

Similar to pharmacists and interns, a pharmacy technician certified by the board is subject to the jurisdiction of the board and to discipline by the board for engaging in unprofessional conduct.

The bill maintains the limitation on the number of interns and pharmacy technicians that a pharmacist may supervise but specifies that if the pharmacist is supervising 3 or more pharmacy technicians, a majority of the pharmacy technicians must be certified.

The bill replaces one nonpharmacist member of the board with a certified pharmacy technician member with 5 years of pharmacy technician experience.

The regulation of pharmacy technicians by the board is subject to the same sunset review that applies to the board and its functions in regulating the practice of pharmacy.

8 (8.5) "CERTIFICATION" MEANS A CERTIFICATION TO PRACTICE AS

1 A PHARMACY TECHNICIAN ISSUED BY THE BOARD IN ACCORDANCE WITH
2 SECTION 12-280-115.5 (2) AND INCLUDES A PROVISIONAL CERTIFICATION
3 ISSUED IN ACCORDANCE WITH SECTION 12-280-115.5 (3).

4 (8.7) "CERTIFYING ORGANIZATION" MEANS A BOARD-APPROVED,
5 NATIONALLY RECOGNIZED ORGANIZATION THAT CERTIFIES PHARMACY

7 (38) "Pharmacy technician" OR "CERTIFICANT" means ~~an~~

13 (38.5) (a) "PRACTICE AS A PHARMACY TECHNICIAN" MEANS

15 PRACTICE OF PHARMACY, UNDER THE SUPERVISION AND DELEGATION OF
16 A SUPERVISING PHARMACIST:

17 (I) RECEIVING AND INITIALLY INPUTTING NEW WRITTEN,
18 FACSIMILE, OR ELECTRONIC ORDERS;

19 (II) PREPARING, MIXING, ASSEMBLING, PACKAGING, LABELING, OR
20 DELIVERING A DRUG OR DEVICE;

21 (III) PROPERLY AND SAFELY STORING DRUGS OR DEVICES;

22 (IV) MAINTAINING PROPER RECORDS FOR DRUGS AND DEVICES;

23 (V) TRANSFERRING PRESCRIPTIONS; AND

24 (VI) OTHER ACTIVITIES AS AUTHORIZED AND DEFINED BY THE
25 BOARD BY RULE.

26 (b) "PRACTICE AS A PHARMACY TECHNICIAN" DOES NOT INCLUDE
27 ACTIVITIES OR SERVICES DESCRIBED IN SUBSECTION (38.5)(a) OF THIS

1 SECTION THAT ARE PERFORMED BY EMPLOYEES OR PERSONNEL OF A
2 PRACTITIONER DISPENSING DRUGS TO PATIENTS PURSUANT TO SECTION
3 12-42.5-118 (6) OR OF A REGISTERED OTHER OUTLET, WHICH
4 PRACTITIONER OR OTHER OUTLET DOES NOT STORE, COMPOUND, DISPENSE,
5 OR DELIVER CONTROLLED SUBSTANCES.

6 (49) "Supervision" means that a licensed pharmacist is on the
7 location and readily available to consult with and assist ~~unlicensed~~
8 CERTIFICANTS PRACTICING AS PHARMACY TECHNICIANS AS DESCRIBED IN
9 SUBSECTION (38.5) OF THIS SECTION OR ANCILLARY personnel performing

22 (50)(a) "Telepharmacy outlet" means a remote pharmacy site that:
23 (IV) Has a pharmacy technician on site who, under the remote
24 supervision of a licensed pharmacist located at the central pharmacy,
25 performs the tasks described in ~~subsection (39)(b)~~ SUBSECTION (38.5) of
26 this section.

27 **SECTION 2.** In Colorado Revised Statutes, 12-280-104, **amend**

1 as relocated by House Bill 19-1172 (3) as follows:

2 **12-280-104. State board of pharmacy - creation - subject to**
3 **termination - repeal of parts.** (3) Parts 1 to 3 of this article 280 are
4 repealed, effective September 1, 2021. Before the repeal, the board and
5 the regulation of the practice of pharmacy pursuant to parts 1 to 3 of this
6 article 280, INCLUDING THE REGULATION OF THE PRACTICE AS A
7 PHARMACY TECHNICIAN, are scheduled for review in accordance with
8 section 24-34-104.

10 **SECTION 3.** In Colorado Revised Statutes, 12-280-108, **amend**
11 **as relocated by House Bill 19-1172** (1)(b), (1)(c), (1)(e), and (1)(f)(I) as
12 follows:

13 **12-280-108. Powers and duties.** (1) The board shall:

14 (b) Prescribe forms and receive applications for licensure,
15 CERTIFICATION, and registration and grant, renew, reactivate, and reinstate
16 licenses, CERTIFICATIONS, and registrations;

17 (c) Deny, suspend, or revoke licenses, CERTIFICATIONS, or
18 registrations;

19 (e) Administer examinations to, and determine the qualifications
20 and fitness of, applicants for licensure, CERTIFICATION, or registration;

21 (f) Keep a record of:

22 (I) All licenses, CERTIFICATIONS, registrations, and license,
23 CERTIFICATION, and registration renewals, reactivations, and
24 reinstatements for a reasonable period;

25 **SECTION 4.** In Colorado Revised Statutes, 12-280-112, **amend**

15 **SECTION 5.** In Colorado Revised Statutes, 12-280-114, **amend**
16 **as relocated by House Bill 19-1172 (2)(a), (3), (6), and (7); and add as**
17 **relocated by House Bill 19-1172 (2)(c)** as follows:

18 **12-280-114. Licensure, certification, or registration -**
19 **applicability - applications - licensure and certification requirements**
20 **- rules.** (2) (a) Every applicant for a license OR CERTIFICATION under this
21 article 280 must read and write the English language, or if the applicant
22 is a partnership, each member of the partnership must read and write the
23 English language. If the applicant is a Colorado corporation, the
24 corporation must be in good standing, and if the applicant is a foreign
25 corporation, it must be qualified to do business in this state.

26 (c) THE BOARD SHALL ISSUE A CERTIFICATION TO AN APPLICANT TO
27 PRACTICE AS A PHARMACY TECHNICIAN WHO SATISFIES THE

1 REQUIREMENTS OF THIS ARTICLE 280, THIS SECTION, AND SECTION
2 12-280-115.5.

3 (3) Every applicant for a license, CERTIFICATION, or registration
4 under this article 280 shall make written application in the manner and
5 form prescribed by the board, setting forth the applicant's name and
6 address, the applicant's qualifications for the license, CERTIFICATION, or
7 registration, and other information required by the board. The applicant
8 shall submit with the application the required fee, and, if the applicant is
9 required to take an examination, the applicant shall appear for
10 examination at the time and place fixed by the board.

11 (6) No applicant shall exercise the privileges of licensure,
12 CERTIFICATION, or registration until the board grants the license,
13 CERTIFICATION, or registration.

14 (7) The board may require any applicant for licensure OR
15 CERTIFICATION to display written or oral competency in English. The
16 board may utilize a standardized test to determine language proficiency.

21 **check - rules.** (1) ON OR AFTER MARCH 30, 2020, A PERSON SHALL NOT
22 ENGAGE IN THE PRACTICE AS A PHARMACY TECHNICIAN UNLESS THE
23 PERSON HAS OBTAINED A CERTIFICATION OR PROVISIONAL CERTIFICATION
24 FROM THE BOARD IN ACCORDANCE WITH THIS SECTION.

25 (2) IN ADDITION TO ANY OTHER REQUIREMENTS SPECIFIED IN
26 SECTION 12-280-114 OR THIS ARTICLE 280, TO BE CERTIFIED AS A
27 PHARMACY TECHNICIAN, AN APPLICANT MUST:

1 (a) PROVIDE PROOF SATISFACTORY TO THE BOARD THAT THE
2 APPLICANT HAS OBTAINED AND MAINTAINS IN GOOD STANDING
3 CERTIFICATION AS A PHARMACY TECHNICIAN FROM A CERTIFYING
4 ORGANIZATION; AND

6 FORM AND MANNER AS DETERMINED BY THE BOARD BY RULE; OR

7 (II) PROVIDE PROOF SATISFACTORY TO THE BOARD THAT THE
8 APPLICANT SUBMITTED TO A CRIMINAL HISTORY RECORD CHECK AS A
9 CONDITION OF EMPLOYMENT AT A PHARMACY OR OTHER OUTLET, AS
10 REQUIRED BY THE APPLICANT'S CURRENT EMPLOYER, AS A CONDITION OF
11 PARTICIPATING IN A COURSE OF STUDY FOR OR WITH A CERTIFYING
12 ORGANIZATION, OR IN CONNECTION WITH OBTAINING CERTIFICATION FROM

14 (3) (a) IF AN APPLICANT FOR CERTIFICATION AS A PHARMACY
15 TECHNICIAN HAS NOT SATISFIED THE REQUIREMENTS OF SUBSECTION (2)(a)
16 OF THIS SECTION AT THE TIME OF APPLICATION TO THE BOARD, THE BOARD
17 MAY GRANT THE APPLICANT A PROVISIONAL CERTIFICATION UPON
18 SATISFACTION OF ALL OTHER REQUIREMENTS FOR CERTIFICATION
19 SPECIFIED IN THIS SECTION AND SECTION 12-280-114.

20 (b) (I) EXCEPT AS PROVIDED IN SUBSECTION (3)(b)(II) OF THIS
21 SECTION, A PROVISIONAL CERTIFICATION IS VALID FOR NOT MORE THAN
22 EIGHTEEN MONTHS AFTER THE DATE OF ISSUANCE AND IS NOT RENEWABLE.

24 TO THIS SUBSECTION (3) FAILS TO SATISFY THE REQUIREMENTS OF

6 A PROVISIONAL CERTIFICANT TO APPLY FOR A HARDSHIP EXTENSION TO
7 EXTEND THE VALIDITY OF THE PROVISIONAL CERTIFICATION BEYOND
8 EIGHTEEN MONTHS. THE BOARD SHALL ESTABLISH CRITERIA FOR
9 QUALIFYING FOR A HARDSHIP EXTENSION BASED ON:

18 SECTION.

20 **SECTION 7.** In Colorado Revised Statutes, 12-280-116, **amend**
21 **as relocated by House Bill 19-1172** (1) and (2) as follows:

22 **12-280-116. Expiration and renewal of licenses, certifications,**
23 **or registrations.** (1) All licenses, CERTIFICATIONS, and registrations
24 issued pursuant to this article 280, EXCEPT PROVISIONAL CERTIFICATIONS
25 ISSUED PURSUANT TO SECTION 12-280-115.5 (3), are subject to the
26 renewal, expiration, reinstatement, and delinquency fee provisions
27 specified in section 12-20-202 (1) and (2). Any person whose license,

1 CERTIFICATION, or registration expires is subject to the penalties provided
2 in this article 280 or section 12-20-202 (1).

3 (2) A pharmacist who fails to renew his or her license OR A
4 PHARMACY TECHNICIAN WHO FAILS TO RENEW HIS OR HER CERTIFICATION
5 ISSUED PURSUANT TO SECTION 12-280-115.5 (2) on or before the
6 applicable renewal time may have ~~his or her~~ THE license OR
7 CERTIFICATION, AS APPLICABLE, reinstated in accordance with section
8 12-20-202 (2) for the remainder of the current renewal period by filing a
9 proper application, satisfying the board that the pharmacist OR PHARMACY
10 TECHNICIAN, AS APPLICABLE, is fully qualified to practice, and paying the
11 reinstatement fee as provided in section ~~12-280-112 (1)(e)~~ 12-280-112
12 (1)(e) AND (1)(t) and all delinquent fees.

15 **12-280-117.5. Continuing education for pharmacy technicians**
16 **- exceptions - inactive status.** (1) **THE** BOARD SHALL NOT RENEW,
17 REINSTATE, OR REACTIVATE THE CERTIFICATION OF A PHARMACY
18 TECHNICIAN THAT WAS ISSUED PURSUANT TO SECTION 12-280-115.5 (2)
19 UNTIL THE PHARMACY TECHNICIAN PRESENTS EVIDENCE THAT THE
20 PHARMACY TECHNICIAN **MAINTAINS ACTIVE CERTIFICATION WITH A**
21 **CERTIFYING ORGANIZATION. SUBJECT TO SUBSECTION (2) OF THIS SECTION,**
22 THE EVIDENCE MAY BE PROVIDED BY AN ATTESTATION ON THE
23 CERTIFICATION RENEWAL APPLICATION.

24 **(2)** THE BOARD MAY ANNUALLY AUDIT UP TO FIVE PERCENT OF THE
25 PHARMACY TECHNICIANS CERTIFIED AND RESIDING IN COLORADO TO
26 DETERMINE COMPLIANCE WITH THIS SECTION.

1 (3) IF A PHARMACY TECHNICIAN FAILS TO COMPLETE THE
2 CONTINUING EDUCATION AND RENEWAL REQUIREMENTS OF, AND
3 MAINTAIN ACTIVE CERTIFICATION WITH, A CERTIFYING ORGANIZATION,
4 THE PHARMACY TECHNICIAN'S STATE CERTIFICATION BECOMES INACTIVE.
5 AN INACTIVE CERTIFICANT IS NOT REQUIRED TO COMPLY WITH ANY
6 CONTINUING PHARMACY TECHNICIAN EDUCATION REQUIREMENT SO LONG
7 AS THE CERTIFICANT REMAINS INACTIVE, BUT THE CERTIFICANT MUST
8 CONTINUE TO PAY APPLICABLE FEES, INCLUDING RENEWAL FEES. THE
9 BOARD SHALL NOTE "INACTIVE STATUS" ON THE FACE OF ANY
10 CERTIFICATION IT ISSUES TO A CERTIFICANT WHILE THE CERTIFICANT
11 REMAINS INACTIVE. BEFORE AN INACTIVE PHARMACY TECHNICIAN
12 RESUMES PRACTICE AS A PHARMACY TECHNICIAN AFTER BEING PLACED ON
13 AN INACTIVE LIST, THE PHARMACY TECHNICIAN MUST FILE AN
14 APPLICATION TO ACTIVATE THE CERTIFICATION, PAY THE CERTIFICATION
15 RENEWAL FEE, AND MEET THE CONTINUING EDUCATION REQUIREMENTS OF
16 THIS SECTION. IF A PHARMACY TECHNICIAN ENGAGES IN PRACTICE AS A
17 PHARMACY TECHNICIAN WHILE ON INACTIVE STATUS, THAT CONDUCT IS
18 GROUNDS FOR CERTIFICATION REVOCATION UNDER THIS ARTICLE 280.

19 **SECTION 9.** In Colorado Revised Statutes, 12-280-118, **amend**
20 **as relocated by House Bill 19-1172** (3)(b) and (5) as follows:

21 **12-280-118. Prescription drug outlet under charge of**
22 **pharmacist - rules.** (3) (b) An outlet as recognized in section
23 12-280-119 (1)(d) need not be under the direct charge of a pharmacist,
24 but a licensed pharmacist shall either initially interpret all prescription
25 orders compounded or dispensed from the outlet or provide written
26 protocols for compounding and dispensing by ~~unlicensed persons~~
27 PHARMACY TECHNICIANS. An outlet qualifying for registration under this

1 subsection (3)(b) may also apply to the board for a waiver of the
2 requirements concerning physical space, equipment, inventory, or
3 business hours as necessary and consistent with the outlet's limited public
4 welfare purpose. In determining the granting or denial of a waiver
5 application, the board shall ensure that the public interest criteria set forth
6 in section 12-280-101 are satisfied. All other provisions of this article
7 280, except as specifically waived by the board, apply to the outlet.

21 (II) SPECIFIC TASKS DESCRIBED IN SECTION 12-280-103 (38.5) OR

23 A PHARMACY TECHNICIAN WHO IS UNDER THE PHARMACIST'S SUPERVISION.

23 TECHNICIAN is not engaging in activities prohibited pursuant to section
24 12-42.5-123. The agreement does not constitute a restriction or discipline
25 by the board. However, if the pharmacist, ~~or~~ intern, OR PHARMACY
26 TECHNICIAN fails to comply with the terms of an agreement entered into
27 pursuant to this section, the failure constitutes a prohibited activity

1 pursuant to section 12-42.5-123 (1)(r), and the pharmacist, ~~or~~ intern, OR
2 PHARMACY TECHNICIAN is subject to discipline in accordance with section
3 12-42.5-124.

4 (4) This section does not apply to a pharmacist, ~~or~~ intern, OR
5 PHARMACY TECHNICIAN subject to discipline for prohibited activities as
6 described in section 12-42.5-123 (1)(e).

7 **SECTION 33.** In Colorado Revised Statutes, 24-34-104, **amend**
8 (21)(a)(II) as follows:

9 **24-34-104. General assembly review of regulatory agencies**
10 **and functions for repeal, continuation, or reestablishment - legislative**
11 **declaration - repeal.** (21) (a) The following agencies, functions, or both,
12 will repeal on September 1, 2021:

13 (II) The state board of pharmacy and the regulation of the practice
14 of pharmacy, INCLUDING THE REGULATION OF THE PRACTICE AS A
15 PHARMACY TECHNICIAN, by the department of regulatory agencies through
16 the division of professions and occupations in accordance with parts 1 to
17 3 of article 42.5 of title 12; ~~C.R.S.~~;

18 **SECTION 34. Appropriation.** (1) For the 2019-20 state fiscal
19 year, \$183,063 is appropriated to the department of regulatory agencies.
20 This appropriation is from the division of professions and occupations
21 cash fund created in section 24-34-105 (2)(b)(I), C.R.S. To implement
22 this act, the department may use this appropriation as follows:

23 (a) \$156,972 for use by the division of professions and
24 occupations for personal services, which amount is based on an
25 assumption that the division will require an additional 1.2 FTE;

26 (b) \$10,546 for use by the division of professions and occupations
27 for operating expenses; and

1 (c) \$15,545 for the purchase of legal services.

2 (2) For the 2019-20 state fiscal year, \$15,545 is appropriated to
3 the department of law. This appropriation is from reappropriated funds
4 received from the department of regulatory agencies under subsection
5 (1)(c) of this section. To implement this act, the department of law may
6 use this appropriation to provide legal services for the department of
7 regulatory agencies.

8 (3) For the 2019-20 state fiscal year, \$128,188 is appropriated to
9 the department of public safety for use by the biometric identification and
10 records unit. This appropriation is from the Colorado bureau of
11 investigation identification unit fund created in section 24-33.5-426,
12 C.R.S., and is based on an assumption that the department will require an
13 additional 0.7 FTE. To implement this act, the unit may use this
14 appropriation for criminal history record checks.

15 **SECTION 35. Act subject to petition - effective date -**
16 **applicability.** (1) Except as otherwise provided in subsection (2) of this
17 section, this act takes effect October 1, 2019; except that, if a referendum
18 petition is filed pursuant to section 1 (3) of article V of the state
19 constitution against this act or an item, section, or part of this act within
20 the ninety-day period after final adjournment of the general assembly,
21 then the act, item, section, or part will not take effect unless approved by
22 the people at the general election to be held in November 2020 and, in
23 such case, will take effect on the date of the official declaration of the
24 vote thereon by the governor.

25 (2) (a) Sections 1 through 17 of this act take effect only if House
26 Bill 19-1172 becomes law.

27 (b) Sections 18 through 33 of this act take effect only if House

1 Bill 19-1172 does not become law.

2 (3) This act applies to the practice as a pharmacy technician on or

3 after March 30, 2020.
