**A BILL FOR AN ACT**

101      **CONCERNING THE PENALTY FOR A PERSON WHO PASSES A SNOWPLOW**  
102              **THAT IS PERFORMING ITS SERVICE FUNCTION IN ECHELON**  
103              **FORMATION WITH AT LEAST ONE OTHER SNOWPLOW, AND, IN**  
104              **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

Under current law, a person commits a class B traffic offense if the person fails to exercise more than ordinary care and caution in approaching, overtaking, or passing an authorized service vehicle that is

performing its service function and displaying its lights. The bill states that a person commits a class A traffic offense if the person passes a snowplow that is operated by a state, county, or local government, displaying its lights, and performing its service function in echelon formation with one or more other such snowplows. "Echelon formation" means a formation in which snowplows are arranged diagonally, with each unit stationed behind and to the right, or behind and to the left, of the unit ahead.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 42-4-214, **amend** (1)  
3 and (6) as follows:

4           **42-4-214. Visual signals on service vehicles - definition.**

5 (1) Except as otherwise provided in this section, ~~on or after January 1,~~  
6 ~~1978,~~ every authorized service vehicle ~~shall~~ MUST, in addition to any  
7 other equipment required by this ~~article~~ ARTICLE 4, be equipped with one  
8 or more warning lamps mounted as high as practicable, which ~~shall~~ MUST  
9 be capable of displaying in all directions one or more flashing, oscillating,  
10 or rotating yellow lights. Only yellow and no other color or combination  
11 of colors ~~shall~~ MAY be used as a warning lamp on an authorized service  
12 vehicle; except that an authorized service vehicle snowplow operated by  
13 a ~~general purpose~~ STATE, COUNTY, OR LOCAL government may also be  
14 equipped with and use no more than two flashing, oscillating, or rotating  
15 blue lights as warning lamps. Lighted directional signs used by police and  
16 highway departments to direct traffic need not be visible except to the  
17 front and rear. Such lights ~~shall~~ MUST have sufficient intensity to be  
18 visible at five hundred feet in normal sunlight.

19           (6) (a) Any person who violates any provision of this section  
20 commits a class B traffic infraction; EXCEPT THAT A PERSON COMMITS A  
21 CLASS A TRAFFIC INFRACTION IF THE PERSON PASSES AN AUTHORIZED

1 SERVICE VEHICLE SNOWPLOW THAT IS OPERATED BY A STATE, COUNTY, OR  
2 LOCAL GOVERNMENT, DISPLAYING LIGHTS AS AUTHORIZED IN SUBSECTION  
3 (1) OF THIS SECTION, AND PERFORMING ITS SERVICE FUNCTION IN ECHELON

5 (b) AS USED IN THIS SUBSECTION (6), UNLESS THE CONTEXT  
6 OTHERWISE REQUIRES, "ECHELON FORMATION" MEANS A FORMATION IN  
7 WHICH SNOWPLOWS ARE ARRANGED DIAGONALLY, WITH EACH UNIT  
8 STATIONED BEHIND AND TO THE RIGHT, OR BEHIND AND TO THE LEFT, OF  
9 THE UNIT AHEAD.

10 **SECTION 2.** In Colorado Revised Statutes, 42-4-224, **amend** (6)  
11 as follows:

12 **42-4-224. Horns or warning devices - definition.** (6) (a) Any  
13 person who violates any provision of this section commits a class B  
14 traffic infraction; EXCEPT THAT A PERSON COMMITS A CLASS A TRAFFIC  
15 INFRACTION IF THE PERSON PASSES AN AUTHORIZED SERVICE VEHICLE  
16 SNOWPLOW THAT IS OPERATED BY A STATE, COUNTY, OR LOCAL  
17 GOVERNMENT, DISPLAYING LIGHTS AS AUTHORIZED IN SECTION 42-4-214,  
18 AND PERFORMING ITS SERVICE FUNCTION IN ECHELON FORMATION WITH  
19 ONE OR MORE OTHER SUCH SNOWPLOWS.

20 (b) AS USED IN THIS SUBSECTION (6), UNLESS THE CONTEXT  
21 OTHERWISE REQUIRES, "ECHELON FORMATION" MEANS A FORMATION IN  
22 WHICH SNOWPLOWS ARE ARRANGED DIAGONALLY, WITH EACH UNIT  
23 STATIONED BEHIND AND TO THE RIGHT, OR BEHIND AND TO THE LEFT, OF  
24 THE UNIT AHEAD.

25 **SECTION 3. Appropriation.** For the 2019-20 state fiscal year,  
26 \$3,375 is appropriated to the department of revenue for use by the  
27 division of motor vehicles. This appropriation is from the licensing

1 services cash fund created in section 42-2-114.5 (1), C.R.S. To implement  
2 this act, the department may use this appropriation for DRIVES  
3 maintenance and support.

4           **SECTION 4. Act subject to petition - effective date.** This act  
5 takes effect at 12:01 a.m. on the day following the expiration of the  
6 ninety-day period after final adjournment of the general assembly (August  
7 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a  
8 referendum petition is filed pursuant to section 1 (3) of article V of the  
9 state constitution against this act or an item, section, or part of this act  
10 within such period, then the act, item, section, or part will not take effect  
11 unless approved by the people at the general election to be held in  
12 November 2020 and, in such case, will take effect on the date of the  
13 official declaration of the vote thereon by the governor.
