A BILL FOR AN ACT

101 **CONCERNING THE SALES AND USE TAX TREATMENT OF CERTAIN**
102 **WHOLESALE SALES RELATED TO THE PRODUCTION OF**
103 **AGRICULTURAL PRODUCTS.**

Bill Summary

Wholesale sales are not subject to sales and use taxes. The bill includes sales of fertilizer used in the production of agricultural and livestock products in the definition of "wholesale sales" for sales and use tax purposes.

The bill further specifies that, for purposes of defining a wholesale

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 35-12-103, **amend**
3 **the introductory portion and (30) as follows:**

4 **35-12-103. Definitions.** As used in this ~~article~~ **ARTICLE 12**, unless
5 **the context otherwise requires:**

6 (30) "Specialty fertilizer" means a commercial fertilizer
7 distributed primarily for nonfarm use, such as home gardens, lawns,
8 shrubbery, flowers, golf courses, parks, ~~AND cemeteries. greenhouses,~~
9 ~~hydroponic facilities, and nurseries.~~

10 **SECTION 2.** In Colorado Revised Statutes, 39-26-102, **add**
11 **(19)(e), (19)(f), and (19)(g) as follows:**

12 **39-26-102. Definitions.** As used in this article 26, unless the
13 **context otherwise requires:**

14 (19) (e) "WHOLESALE SALE" INCLUDES SALES OF FERTILIZER FOR
15 USE IN THE PRODUCTION OF AGRICULTURAL ~~COMMODITIES~~. FOR PURPOSES
16 OF THIS SUBSECTION (19)(e), "FERTILIZER" MEANS FERTILIZER AS DEFINED
17 IN SECTION 35-12-103 (12), BUT NOT INCLUDING SPECIALTY FERTILIZER AS
18 DEFINED IN SECTION 35-12-103 (30).

19 (f) "WHOLESALE SALE" INCLUDES SALES OF SPRAY ADJUVANTS FOR
20 USE IN THE PRODUCTION OF AGRICULTURAL ~~COMMODITIES~~. FOR PURPOSES
21 OF THIS SUBSECTION (19)(f), "SPRAY ADJUVANTS" MEANS PRODUCTS THAT
22 ARE USED TO INCREASE THE EFFECTIVENESS OF A PESTICIDE.

1 **SECTION 3. Applicability.** This act applies to sales occurring
2 prior to, on, or after the effective date of this act.

3 **SECTION 4. Safety clause.** The general assembly hereby finds,
4 determines, and declares that this act is necessary for the immediate
5 preservation of the public peace, health, and safety.
