of regulatory agencies' sunset review by extending the repeal date of in-home support services for certain home- and community-based services (HCBS) waivers under the Colorado medical assistance program by 7 years, from 2019 to 2026. Prior to the repeal, the department of regulatory agencies shall conduct a sunset review of the program.

The bill amends the eligibility definition for in-home support services, removing the reference to specific HCBS waivers and including those waivers for which there is state and federal authority for in-home support services.

The bill removes language relating to an obsolete reporting requirement.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 25.5-6-1207
3 as follows:

4 **25.5-6-1207. Repeal of part.** This part 12 is repealed, effective
5 September 1, ~~2019~~ 2028. Prior to such repeal, in-home support services
6 established under this part 12 shall be reviewed as provided for in section
7 24-34-104. ~~C.R.S.~~

8 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**
9 (17)(a)(X); and **add** (29)(a)(V) as follows:

10 **24-34-104. General assembly review of regulatory agencies**
11 **and functions for repeal, continuation, or reestablishment - legislative**
12 **declaration - repeal.** (17) (a) The following agencies, functions, or both,
13 are scheduled for repeal on September 1, 2019:

16 (1.5) ~~The state department shall develop a plan to expand the provision~~
17 ~~of in-home support services to include clients eligible for home- and~~

20 ~~children's extensive support services pursuant to part 4 of this article. On~~
21 ~~or before March 1, 2015, the state department shall report to the public~~

27 **SECTION 5. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the
2 ninety-day period after final adjournment of the general assembly (August
3 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
4 referendum petition is filed pursuant to section 1 (3) of article V of the
5 state constitution against this act or an item, section, or part of this act
6 within such period, then the act, item, section, or part will not take effect
7 unless approved by the people at the general election to be held in
8 November 2020 and, in such case, will take effect on the date of the
9 official declaration of the vote thereon by the governor.
