2 **SECTION 1.** In Colorado Revised Statutes, 22-35-107, **amend**

5 **membership - duties - reports.** (8) (a) This section is repealed, effective  
6 ~~July 1, 2019~~ **SEPTEMBER 1, 2024.**
