**Bill Summary**

The bill adds Colorado state university - global campus to the list of designated institutions of higher education for purposes of tuition assistance for members of the National Guard.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 23-7.4-302, **amend**  
3 (3)(a) as follows:

4           **23-7.4-302. Tuition for members of the National Guard -**  
5 **definitions.** (3) (a) For purposes of this section, "designated institution  
6 of higher education" means the Colorado state university - Pueblo, Adams  
7 state university, Colorado Mesa university, Metropolitan state university  
8 of Denver, Fort Lewis college, Western state Colorado university, all  
9 independent area technical colleges, all local district colleges, the  
10 university of northern Colorado, the university of Colorado at Boulder,  
11 the university of Colorado at Denver, the university of Colorado at  
12 Colorado Springs, Colorado state university, COLORADO STATE  
13 UNIVERSITY - GLOBAL CAMPUS, the Colorado school of mines, the  
14 university of Colorado health sciences center, all community colleges  
15 governed by the state board for community colleges and occupational  
16 education, and any private institution of higher education in Colorado that  
17 qualifies for the college opportunity fund pursuant to article 18 of this  
18 title 23 and that offers an accredited certificate or degree program in  
19 homeland security. For a member of the Colorado National Guard  
20 enrolled in a private institution of higher education, tuition assistance is  
21 limited to the completion of the accredited certificate or degree program  
22 in homeland security and is provided at the discretion of the adjutant  
23 general of the department of military and veterans affairs.

24           **SECTION 2. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
