**A BILL FOR AN ACT**

101     **CONCERNING THE INCLUSION OF FIREFIGHTERS EMPLOYED BY THE**  
102             **DEPARTMENT OF PUBLIC SAFETY IN THE DIVISION OF FIRE**  
103             **PREVENTION AND CONTROL IN CERTAIN EMPLOYEE BENEFITS,**  
104             **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

malfunction in connection with a stressful or strenuous activity related to an emergency response activity. In addition, certain employers of firefighters may make contributions into a multiple employer health trust established to provide benefits to volunteer firefighters diagnosed with certain covered cancers.

Beginning July 1, 2020, the bill adds the division of fire prevention and control in the department of public safety (division) to the definition of "employer" for the purpose of providing benefits for a heart and circulatory malfunction and to the definition of "employer" for the purpose of providing benefits for certain covered cancers.

In addition, beginning July 1, 2020, the bill expands the definition of "state trooper" for purposes of the public employees' retirement association to include all current and future employees of the division that are classified as a firefighter I through firefighter VII class titles.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 29-5-301, **amend** (1)  
3 as follows:

4 **29-5-301. Definitions.** As used in this part 3, unless the context  
5 otherwise requires:

6 (1) "Employer" means a municipality, special district, fire  
7 authority, or county improvement district that employs one or more  
8 firefighters. BEGINNING JULY 1, 2020, "EMPLOYER" ALSO MEANS THE  
9 DIVISION OF FIRE PREVENTION AND CONTROL CREATED IN SECTION  
10 24-33.5-1201. "Employer" does not include a power authority created  
11 pursuant to section 29-1-204 or a municipally owned utility.

12 **SECTION 2.** In Colorado Revised Statutes, 29-5-402, **amend** (3)  
13 as follows:

14 **29-5-402. Definitions.** As used in this part 4, unless the context  
15 otherwise requires:

16 (3) "Employer" means a municipality, special district, fire  
17 authority, or county improvement district that employs one or more

1 firefighters, part-time firefighters, or volunteer firefighters. BEGINNING  
2 JULY 1, 2020, "EMPLOYER" ALSO MEANS THE DIVISION OF FIRE  
3 PREVENTION AND CONTROL CREATED IN SECTION 24-33.5-1201.  
4 "Employer" does not include a power authority created pursuant to  
5 section 29-1-204 or a municipally owned utility.

6 **SECTION 3.** In Colorado Revised Statutes, 24-51-101, **amend**  
7 (46) as follows:

8 **24-51-101. Definitions.** As used in this article 51, unless the  
9 context otherwise requires and except as otherwise defined in part 17 of  
10 this article 51:

11 (46) "State trooper" means an employee of the Colorado state  
12 patrol, Colorado bureau of investigation, or successors to these agencies,  
13 who is vested with the powers of peace officers as provided for in section  
14 24-33.5-409. In addition, for members who were not members, inactive  
15 members, or retirees on December 31, 2019, "state trooper" includes a  
16 county sheriff, undersheriff, deputy sheriff, noncertified deputy sheriff,  
17 or detention officer hired by a local government division employer on or  
18 after January 1, 2020, and a corrections officer classified as I through IV  
19 hired by a state division employer on or after January 1, 2020. BEGINNING  
20 JULY 1, 2020, "STATE TROOPER" ALSO INCLUDES AN EMPLOYEE OF THE  
21 DIVISION OF FIRE PREVENTION AND CONTROL IN THE DEPARTMENT OF  
22 PUBLIC SAFETY WHO IS CLASSIFIED IN THE FIREFIGHTER I THROUGH  
23 FIREFIGHTER VII CLASS TITLES.

24 **SECTION 4. Appropriation.** (1) For the 2020-21 state fiscal  
25 year, \$977 is appropriated to the department of health care policy and  
26 financing for use by the executive director's office. This appropriation is  
27 from the general fund. To implement this act, the department may use this

1 appropriation for transfer to department of public health and environment  
2 for facility survey and certification, which amount is subject to the "(M)"  
3 notation as defined in the annual general appropriation act for the same  
4 fiscal year.

5 (2) For the 2020-21 state fiscal year, the general assembly  
6 anticipates that the department of health care and policy financing will  
7 receive \$977 in federal funds to implement this act. The appropriation in  
8 subsection (1) of this section is based on the assumption that the  
9 department will receive this amount of federal funds to be used for  
10 transfer to department of public health and environment for facility  
11 survey and certification.

12 (3) For the 2020-21 state fiscal year, \$1,954 is appropriated to the  
13 department of public health and environment for use by the health  
14 facilities and emergency medical services division. This appropriation is  
15 from reappropriated funds received from the department of health care  
16 policy and financing under subsections (1) and (2) of this section. To  
17 implement this act, the department may use this appropriation for transfer  
18 to department of public safety.

19 (4) For the 2020-21 state fiscal year, the general assembly  
20 anticipates that the department of public health and environment will  
21 receive \$2,197 in federal funds for use by the health facilities and  
22 emergency medical services division, which amount is included for  
23 informational purposes only. The appropriation in subsection (3) of this  
24 section is based on the assumption that the department will receive this  
25 amount of federal funds to be used for transfer to department of public  
26 safety.

27 (5) For the 2020-21 state fiscal year, \$4,151 is appropriated to the

1 department of public safety for use by the division of fire prevention and  
2 control. This appropriation is from reappropriated funds received from  
3 the department of public health and environment under subsections (3)  
4 and (4) of this section. To implement this act, the division may use this  
5 appropriation for personal services and wildland fire management  
6 services.

7 (6) For the 2020-21 state fiscal year, \$22,598 is appropriated to  
8 the department of public safety for use by the division of fire prevention  
9 and control. This appropriation is from various cash funds, including: the  
10 Firefighter, First Responder, Hazardous Materials Responder, and  
11 Prescribed Fire Training and Certification Fund created in Section  
12 24-33.5-1207 (1), C.R.S.; the Fire Suppression Cash Fund created in  
13 Section 24-33.5-1207.6 (1), C.R.S.; the Fireworks Licensing Cash Fund  
14 created in Section 24-33.5-2004 (6)(b), C.R.S.; the Fire Service Education  
15 and Training Fund created in Section 24-33.5-1207.5 (1), C.R.S.; the  
16 Health Facility Construction and Inspection Cash Fund created in Section  
17 24-33.5-1207.8, C.R.S.; the Public School Construction and Inspection  
18 Cash Fund created in Section 24-33.5-1207.7, C.R.S.; the Wildland-urban  
19 Interface Training Fund created in Section 24-33.5-1212 (5)(a)(I), C.R.S.;  
20 and from various other sources of cash funds including gifts and grants.  
21 To implement this act, the division may use this appropriation for  
22 personal services and wildland fire management services.

23 **SECTION 5. Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, or safety.
