2 SECTION 1. In Colorado Revised Statutes, 2-5-126, add (2)(w)

2-5-126. Annual enactment of Colorado Revised Statutes validation - effective date. (2) The annual statutes, copies of which shall
be delivered to each member of the general assembly, together with a
listing of the revisor's changes, constitute the official report of the
committee on legal services and are hereby enacted in accordance with
this section as follows:

10 (w) Colorado Revised Statutes 2019. COLORADO REVISED 11 STATUTES 2019, WHICH CONSISTS OF ALL OF THE LAWS OF THE STATE OF 12 COLORADO OF A GENERAL AND PERMANENT NATURE ORIGINALLY 13 ENACTED IN "COLORADO REVISED STATUTES 1973", INCLUDING 14 SUBSEQUENT ENACTMENTS MADE PURSUANT TO SECTION 2-5-125, AND 15 ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND 16 PERMANENT NATURE ENACTED AT THE FIRST REGULAR SESSION OF THE 17 SEVENTY-SECOND GENERAL ASSEMBLY AND AS APPROVED BY THE VOTERS 18 AT THE ODD-NUMBERED YEAR STATEWIDE ELECTION ON NOVEMBER 5, 19 2019. THE EFFECTIVE DATE FOR COLORADO REVISED STATUTES 2019 IS 20 FIXED AS THE FIRST DAY THAT IS NOT A SATURDAY, SUNDAY, OR LEGAL 21 HOLIDAY FOLLOWING THE EFFECTIVE DATE OF THIS SUBSECTION (2)(w). 22 **SECTION 2.** Safety clause. The general assembly hereby finds,

determines, and declares that this act is necessary for the immediatepreservation of the public peace, health, or safety.
