A BILL FOR AN ACT

101 **CONCERNING AUTHORIZING COLORADO STATE PATROL PORT OF**
102 **ENTRY OFFICERS TO DIRECT TRAFFIC.**

Bill Summary

The bill authorizes a port of entry officer to direct traffic in addition to existing enforcement powers.

1 **SECTION 1.** In Colorado Revised Statutes, 42-8-104, **amend** (2)
2 as follows:

3 **42-8-104. Powers and duties - rules.** (2) A port of entry officer,
4 during the time that ~~he or she~~ THE OFFICER is actually engaged in
5 performing ~~his or her~~ THE OFFICER'S duties as such and while acting under
6 proper orders or rules issued by the chief of the Colorado state patrol,
7 shall ~~have and~~ exercise all the powers invested in peace officers in
8 connection with DIRECTING TRAFFIC AND IN the enforcement of the
9 provisions of this ~~article~~, ARTICLE 8; articles 2, 3, and 20 of this ~~title~~,
10 TITLE 42; part 5 of article 4 of this ~~title~~, TITLE 42; and sections 42-4-209,
11 42-4-225 (1.5), 42-4-235, 42-4-1407, 42-4-1409, and 42-4-1414; except
12 that an officer ~~shall~~ DOES not have the power to serve civil writs and
13 process and, in the exercise of ~~his or her~~ THE OFFICER'S duties, an officer
14 ~~shall have~~ HAS the authority to restrain and detain persons or vehicles and
15 may impound any vehicle until any tax or license fee imposed by law is
16 paid or until compliance is had with any tax or regulatory law or rule
17 issued thereunder.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, or safety.
