1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (11)
3 as follows:

4 **2-3-1203. Sunset review of advisory committees - legislative**
5 **declaration - definition - repeal.** (11) (a) ~~The following statutory~~
6 ~~authorizations for the designated advisory committees will repeal on~~
7 ~~September 1, 2020:~~

8 ~~(1) The nurse-physician advisory task force for Colorado health~~

10 ~~(b) This subsection (11) is repealed, effective September 1, 2022.~~

11 **SECTION 2.** In Colorado Revised Statutes, 12-30-105, **repeal** (7)
12 as follows:

13 **12-30-105. Nurse-physician advisory task force for Colorado**
14 **health care - creation - duties - definition.** (7) ~~This section is repealed,~~
15 ~~effective September 1, 2020. Before the repeal, the functions of the~~
16 ~~NPATCH are scheduled for review in accordance with section 2-3-1203.~~

17 **SECTION 3. Act subject to petition - effective date.** This act
18 takes effect at 12:01 a.m. on the day following the expiration of the
19 ninety-day period after final adjournment of the general assembly (August
20 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a
21 referendum petition is filed pursuant to section 1 (3) of article V of the
22 state constitution against this act or an item, section, or part of this act
23 within such period, then the act, item, section, or part will not take effect
24 unless approved by the people at the general election to be held in

1 November 2020 and, in such case, will take effect on the date of the
2 official declaration of the vote thereon by the governor.
