101      **CONCERNING AUTHORIZING THE PEACE OFFICERS STANDARDS AND**  
102            **TRAINING BOARD TO ESTABLISH A SCHOLARSHIP PROGRAM FOR**  
103            **LAW ENFORCEMENT AGENCIES WITH LIMITED RESOURCES TO**  
104            **ASSIST THE AGENCIES WITH THE PAYMENT OF TUITION COSTS**  
105            **FOR PEACE OFFICER CANDIDATES TO ATTEND AN APPROVED**

(P.O.S.T.) board to establish a scholarship program for law enforcement agencies in rural and smaller jurisdictions with limited resources due to their size or location to assist the agencies with the payment of tuition costs for peace officer candidates to attend an approved basic law enforcement training academy.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-31-310, **amend**  
3 (2) and (3); and **add** (4) as follows:

4 **24-31-310. Resources for the training of peace officers - peace**  
5 **officers in rural jurisdictions - legislative declaration.** (2) The ~~moneys~~  
6 MONEY collected and transferred to the P.O.S.T. board cash fund pursuant  
7 to section 42-3-304 (24) ~~C.R.S., shall~~ MUST be used to provide training  
8 programs for peace officers, especially peace officers in rural and smaller  
9 jurisdictions that have limited resources due to the size or location of such  
10 jurisdictions. The ~~moneys shall~~ MONEY MUST be used and distributed  
11 pursuant to ~~subsection (3)~~ SUBSECTION (3) OR (4) of this section.

12 (3) The ~~moneys~~ MONEY collected and transferred to the P.O.S.T.  
13 board cash fund pursuant to section 42-3-304 (24) ~~C.R.S., shall~~ MUST be  
14 used and distributed as determined by the P.O.S.T. board. The ~~moneys~~  
15 MONEY in the fund ~~shall~~ MUST be used to pay the salary and benefits of  
16 any employee hired by the department of law in order to administer the  
17 peace officer training programs and to cover any other costs incurred by  
18 the P.O.S.T. board in connection with such programs. Under no  
19 circumstance shall general fund ~~moneys~~ MONEY be used to cover such  
20 costs incurred by the department of law or the P.O.S.T. board.

21 (4) (a) SUBJECT TO THE AVAILABLE MONEY COLLECTED,  
22 TRANSFERRED TO, AND REMAINING IN THE P.O.S.T. BOARD CASH FUND,  
23 THE P.O.S.T. BOARD MAY ESTABLISH A SCHOLARSHIP PROGRAM FOR LAW

1 ENFORCEMENT AGENCIES IN RURAL AND SMALLER JURISDICTIONS WITH  
2 LIMITED RESOURCES DUE TO THEIR SIZE OR LOCATION TO ASSIST THE  
3 AGENCIES WITH THE PAYMENT OF TUITION COSTS FOR PEACE OFFICER  
4 CANDIDATES TO ATTEND AN APPROVED BASIC LAW ENFORCEMENT  
5 TRAINING ACADEMY. A PERSON WHOSE TUITION COSTS TO ATTEND AN  
6 APPROVED BASIC LAW ENFORCEMENT TRAINING ACADEMY WERE PAID FOR  
7 PURSUANT TO THIS SUBSECTION (4) MUST BE EMPLOYED FOR AT LEAST  
8 THREE YEARS BY A LAW ENFORCEMENT AGENCY IN A RURAL AND SMALL  
9 JURISDICTION AFTER ATTENDING THE APPROVED BASIC LAW ENFORCEMENT  
10 TRAINING ACADEMY OR THE PERSON SHALL REIMBURSE THE COST OF  
11 ATTENDING THE BASIC LAW ENFORCEMENT TRAINING ACADEMY TO THE  
12 P.O.S.T. BOARD.

13 (b) THE P.O.S.T. BOARD SHALL PROMULGATE RULES AS MAY BE  
14 NECESSARY TO IMPLEMENT AND ADMINISTER THE SCHOLARSHIP PROGRAM.

15 (c) AS USED IN THIS SUBSECTION (4), UNLESS THE CONTEXT  
16 OTHERWISE REQUIRES, "RURAL" MEANS AN AREA DEFINED OR DESIGNATED  
17 AS RURAL BY THE FEDERAL OFFICE OF MANAGEMENT AND BUDGET.

18 **SECTION 2. Act subject to petition - effective date.** This act  
19 takes effect at 12:01 a.m. on the day following the expiration of the  
20 ninety-day period after final adjournment of the general assembly (August  
21 5, 2020, if adjournment sine die is on May 6, 2020); except that, if a  
22 referendum petition is filed pursuant to section 1 (3) of article V of the  
23 state constitution against this act or an item, section, or part of this act  
24 within such period, then the act, item, section, or part will not take effect  
25 unless approved by the people at the general election to be held in  
26 November 2020 and, in such case, will take effect on the date of the  
27 official declaration of the vote thereon by the governor.
