A BILL FOR AN ACT

101 **CONCERNING THE MODIFICATION OF THE REQUIREMENTS FOR THE**
102 **SALE OF FIREWORKS FOR TRANSPORT BY THE PURCHASER**
103 **PURSUANT TO AN EXPORTER OF FIREWORKS LICENSE.**

Bill Summary

The bill eliminates the ability for an exporter of fireworks licensee (exporter) to sell certain fireworks for transport in the purchaser's vehicle if the purchaser displays to the exporter a valid driver's license issued by a state other than Colorado and a valid vehicle registration showing the purchaser owns a vehicle in a state other than Colorado.

The bill allows an exporter to sell certain fireworks for transport in the purchaser's vehicle if the purchaser displays to the exporter a valid driver's license and a valid wholesale or retail license number or resale license number regardless of the issuing state.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-2006,
3 **amend** (2) as follows:

4 **24-33.5-2006. Exportation of fireworks.** (2) The exporter may
5 transport such fireworks by common carrier or by the exporter's vehicle;
6 except that the sale of the fireworks for transport in the purchaser's
7 vehicle is unlawful unless

8 ~~(a) The exporter requires the purchaser to display a valid motor~~
9 ~~vehicle driver's license issued by a state other than the state of Colorado~~
10 ~~and records the number and state of issue of such driver's license on the~~
11 ~~bill of lading pertaining to the sale, and further requires the purchaser to~~
12 ~~display a valid motor vehicle registration showing that the purchaser~~
13 ~~owns a motor vehicle licensed in a state other than the state of Colorado,~~
14 ~~which license plate number and state of issue shall be recorded on the bill~~

16 ~~(b) The~~ THE exporter requires the purchaser to display a valid
17 motor vehicle driver's license issued by A JURISDICTION OTHER THAN the
18 state of Colorado and records the number and state JURISDICTION of issue
19 of the driver's license on the bill of lading pertaining to the sale, and
20 further requires the purchaser to furnish a valid wholesale, ~~or~~ retail,
21 license number or resale license number issued by the governing body of
22 a state or local authority located outside of the state of Colorado, which
23 number and state OR LOCAL AUTHORITY of issue shall be recorded on the

1 bill of lading pertaining to the sale.

2 **SECTION 2. Safety clause.** The general assembly hereby finds,
3 determines, and declares that this act is necessary for the immediate
4 preservation of the public peace, health, or safety.
