101 **CONCERNING THE ONE-YEAR SUSPENSION OF A SCHEDULED PAY**
102 **INCREASE FOR MEMBERS OF THE COLORADO GENERAL**
103 **ASSEMBLY, AND, IN CONNECTION THEREWITH, REDUCING AN**
104 **APPROPRIATION.**

For the period commencing on the first day of the legislative session beginning in January of 2021, and ending on the day before the first day of the legislative session beginning in January of 2022, the bill

freezes the annual base compensation of members of the general assembly at \$40,242, which is the same amount as the annual base compensation for members of the general assembly whose terms commenced on the first day of the legislative session beginning in January of 2019.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-2-307, **amend**
3 (1)(b) as follows:

4 **2-2-307. Compensation of members - reimbursement of**
5 **expenses - repeal.** (1) (b) (I) EXCEPT AS OTHERWISE PROVIDED IN
6 SUBSECTION (1)(b)(II) OF THIS SECTION, commencing on the first day of
7 the legislative session beginning in January of 2019, and the first day of
8 each legislative session beginning in January each two years thereafter,
9 all members of the general assembly whose terms commence on such day
10 and members appointed to fill vacancies for unexpired terms of those
11 members shall receive as an annual base compensation for their services
12 an amount equal to twenty-five percent of the total annual salary paid as
13 of such day to the judges of the county court in Class B counties, as
14 defined in section 13-6-201. ~~C.R.S.~~ The base compensation shall be
15 payable in twelve equal monthly amounts. The director of research of the
16 legislative council appointed pursuant to section 2-3-304 (1) ~~C.R.S.~~, shall
17 post the amount of the current annual base compensation payable to a
18 member of the general assembly pursuant to this ~~paragraph (b)~~
19 SUBSECTION (1)(b) on the website of the general assembly.

20 (II) FOR THE PERIOD COMMENCING ON THE FIRST DAY OF THE
21 LEGISLATIVE SESSION BEGINNING IN JANUARY OF 2021, AND ENDING ON
22 THE DAY BEFORE THE FIRST DAY OF THE LEGISLATIVE SESSION BEGINNING
23 IN JANUARY OF 2022, ALL MEMBERS OF THE GENERAL ASSEMBLY WHOSE

1 TERMS COMMENCE ON THE FIRST DAY OF THE LEGISLATIVE SESSION
2 BEGINNING IN JANUARY OF 2021 SHALL RECEIVE AS AN ANNUAL BASE
3 COMPENSATION FOR THEIR SERVICES FORTY THOUSAND TWO HUNDRED
4 FORTY-TWO DOLLARS, WHICH IS THE SAME AMOUNT AS THE ANNUAL BASE
5 COMPENSATION FOR THEIR SERVICES FOR MEMBERS OF THE GENERAL
6 ASSEMBLY WHOSE TERMS COMMENCED ON THE FIRST DAY OF THE
7 LEGISLATIVE SESSION BEGINNING IN JANUARY OF 2019.

8 **SECTION 2. Appropriation - adjustments to 2020 legislative**
9 **appropriation bill.** To implement this act, the general fund appropriation
10 made in the annual legislative appropriation act (House Bill 20-1345) for
11 the 2020-21 state fiscal year to the legislative department for use by the
12 general assembly is decreased by \$46,887.

13 **SECTION 3. Safety clause.** The general assembly hereby finds,
14 determines, and declares that this act is necessary for the immediate
15 preservation of the public peace, health, or safety.
