6 portion; and **add** (d)(2.7)(A.5) as follows:

8 **Requirements - Electronic Participation**

2 procedures for AND LIMITATIONS ON making bill requests:

3 (A.5) AN INTERIM COMMITTEE MAY NOT REQUEST THE
4 OFFICE OF LEGISLATIVE LEGAL SERVICES TO DRAFT
5 MORE THAN TWICE THE NUMBER OF BILLS THE
6 INTERIM COMMITTEE IS AUTHORIZED TO
7 RECOMMEND TO THE LEGISLATIVE COUNCIL, AS
8 SPECIFIED IN JOINT RULE 24 (b)(I)(D), OR AS
