The bill eliminates the statewide social studies assessment in high school and reduces state expenditures annually.

**Appropriation Summary:** For FY 2020-21, the bill reduces appropriations to the Colorado Department of Education by \$667,680.

## **Summary of Legislation**

Under current law, the Colorado Department of Education (CDE) administers a statewide assessment in social studies to students once in elementary school, once in middle school, and once in high school. The department administers the test in a representative sample of public schools each year, and in each public school at least once every three years. This bill removes the requirement that a statewide social studies assessment be administered in high school.

## **State Expenditures**

The bill reduces state expenditures from the State Education Fund by \$667,680 annually. The CDE issued a Request for Proposals in Spring 2017 for a vendor to develop the statewide social studies assessments, along with English Language Arts, math, and science assessments. The resulting vendor contract was prepared to include possible testing reductions, including estimating cost reductions should the high school social studies assessment be eliminated. Based on the final vendor contract, the expenditure reduction for the elimination of high school social studies assessments will be \$667,680 in both FY 2020-21 and FY 2021-22. The vendor contract term expires December 31, 2024.

## **School District**

This bill eliminates statewide social studies tests in high school, and therefore reduces the total number of statewide tests administered in school districts. As a result, schedule, workload and administrative costs related to statewide social studies testing are also reduced at the school and district level.

## **Effective Date**

The bill takes effect August 5, 2020, if the General Assembly adjourns on May 6, 2020, as scheduled, and no referendum petition is filed.

## **State Appropriations**

For FY 2020-21, this bill reduces appropriations from the State Education Fund by \$667,680.
