**A BILL FOR AN ACT**

101      **CONCERNING THE USE OF A PERSON'S DRIVER'S HISTORY RECORD TO**  
102              **MAKE DECISIONS THAT CONCERN THE PRACTICE OF AN**  
103              **OCCUPATION.**

**Bill Summary**

The bill limits the time the appropriate regulatory authority in the department of revenue and the department of regulatory agencies may use a driver's history to make certain decisions about a license, permit, certification, or registration that is necessary to practice an occupation or profession or to operate a business.

The decisions that are limited by the bill concern:

- Issuing, renewing, reinstating, or reactivating the license, permit, certification, or registration; and
- Taking disciplinary action against the holder of the license, permit, certification, or registration.

The events in a driver's history used to make these decisions may be used only if the event occurred within 3 years before:

- The person applied for the license, permit, certification, or registration; or
- The act upon which the discipline is based.

2           **SECTION 1.** In Colorado Revised Statutes, 12-20-102, **add** (7.5)  
3 as follows:

4           **12-20-102. Definitions.** As used in this title 12, unless the context  
5 otherwise requires:

6           (7.5) (a) "DRIVER'S HISTORY" MEANS A DRIVER'S HISTORY RECORD  
7 MADE AND MAINTAINED IN ACCORDANCE WITH SECTION 42-2-121 (2).

8           (b) "DRIVER'S HISTORY" DOES NOT INCLUDE A MISDEMEANOR OR  
9 FELONY CONVICTION, NOTWITHSTANDING THAT THE CONVICTION IS  
10 INCLUDED WITHIN THE DRIVER'S HISTORY RECORD MADE AND MAINTAINED  
11 IN ACCORDANCE WITH SECTION 42-2-121 (2).

12           **SECTION 2.** In Colorado Revised Statutes, 12-20-202, **add** (5.5)  
13 as follows:

14           **12-20-202. Licenses, certifications, and registrations - renewal**  
15 **- reinstatement - fees - occupational credential portability program**  
16 **- temporary authority for military spouses - definitions - exceptions**  
17 **for military personnel - rules - consideration of criminal convictions**  
18 **or driver's history - executive director authority. (5.5) Driver's**  
19 **history.** A REGULATOR SHALL NOT CONSIDER AN EVENT IN AN  
20 APPLICANT'S DRIVER'S HISTORY WHEN DETERMINING WHETHER TO ISSUE

17 **- oaths - witness statements - subpoenas - appointment of**  
18 **administrative law judge - driver's history.** (4) (a) UNLESS  
19 SUBSECTION (4)(b) OF THIS SECTION APPLIES, A REGULATOR SHALL NOT  
20 CONSIDER AN EVENT WITHIN THE DRIVER'S HISTORY OF A LICENSEE,  
21 CERTIFICANT, OR REGISTRANT WHEN DETERMINING:

22 (I) WHETHER TO IMPOSE DISCIPLINE;

23 (II) THE TYPE OF DISCIPLINE TO IMPOSE; OR

24 (III) THE SEVERITY OF DISCIPLINE TO IMPOSE.

25 (b) A REGULATOR MAY CONSIDER AN EVENT WITHIN A DRIVER'S  
26 HISTORY IF:

27 (I) THE EVENT IS RELEVANT TO THE [REDACTED] PERFORMANCE OF THE

1 PROFESSION OR OCCUPATION FOR WHICH THE LICENSEE, CERTIFICANT, OR  
2 REGISTRANT IS LICENSED, CERTIFIED, OR REGISTERED; AND

3 (II) (A) THE OPERATION OF A MOTOR VEHICLE IS A DUTY OF THE  
4 PROFESSION OR OCCUPATION FOR WHICH THE LICENSEE, CERTIFICANT, OR  
5 REGISTRANT IS LICENSED, CERTIFIED, OR REGISTERED;

6 (B) THE EVENT IS A PART OF A PATTERN OF BEHAVIOR THAT IS  
7 RELEVANT TO THE PERFORMANCE OF THE PROFESSION OR OCCUPATION  
8 FOR WHICH THE LICENSEE, CERTIFICANT, OR REGISTRANT IS LICENSED,

12 **SECTION 4.** In Colorado Revised Statutes, 44-1-103, **add** (1.5)  
13 as follows:

14 **44-1-103. Definitions.** As used in this title 44, unless the context  
15 otherwise requires:

16 (1.5) (a) "DRIVER'S HISTORY" MEANS A DRIVER'S HISTORY RECORD  
17 MADE AND MAINTAINED IN ACCORDANCE WITH SECTION 42-2-121 (2).

18 (b) "DRIVER'S HISTORY" DOES NOT INCLUDE A MISDEMEANOR OR  
19 FELONY CONVICTION, NOTWITHSTANDING THAT THE CONVICTION IS  
20 INCLUDED WITHIN THE DRIVER'S HISTORY RECORD MADE AND MAINTAINED  
21 IN ACCORDANCE WITH SECTION 42-2-121 (2).

22 **SECTION 5.** In Colorado Revised Statutes, **add** 44-1-104 as  
23 follows:

24 **44-1-104. Use of driver's history for professional licensing,**  
25 **permit, or registration decisions.** (1) WHEN A PERSON APPLIES FOR A  
26 LICENSE, PERMIT, OR REGISTRATION UNDER THIS TITLE 44, THE  
27 DEPARTMENT SHALL NOT CONSIDER AN EVENT IN THE APPLICANT'S

1 DRIVER'S HISTORY WHEN DETERMINING WHETHER TO ISSUE TO THE  
2 APPLICANT A NEW, RENEWAL, OR REINSTATED LICENSE, PERMIT, OR  
3 REGISTRATION UNLESS:

4 (a) THE EVENT IS RELEVANT TO THE [REDACTED] PERFORMANCE OF THE  
5 PROFESSION OR OCCUPATION THAT IS THE SUBJECT OF THE APPLICATION;

6 AND

7 (b) (I) THE OPERATION OF A MOTOR VEHICLE IS A DUTY OF THE  
8 PROFESSION OR OCCUPATION THAT IS THE SUBJECT OF THE APPLICATION;

9 (II) THE EVENT IS A PART OF A PATTERN OF BEHAVIOR THAT IS  
10 RELEVANT TO THE [REDACTED] PERFORMANCE OF THE PROFESSION OR OCCUPATION  
11 THAT IS THE SUBJECT OF THE APPLICATION; OR

12 (III) THE EVENT OCCURRED WITHIN THREE YEARS BEFORE THE  
13 DATE THAT THE APPLICANT SUBMITTED THE APPLICATION TO THE  
14 DEPARTMENT.

15 (2) (a) UNLESS SUBSECTION (2)(b) OF THIS SECTION APPLIES, THE  
16 DEPARTMENT SHALL NOT CONSIDER AN EVENT WITHIN THE DRIVER'S  
17 HISTORY OF A LICENSE HOLDER, PERMIT HOLDER, OR REGISTRANT WHEN  
18 DETERMINING:

19 (I) WHETHER TO IMPOSE DISCIPLINE;

20 (II) THE TYPE OF DISCIPLINE TO IMPOSE; OR

21 (III) THE SEVERITY OF DISCIPLINE TO IMPOSE.

22 (b) THE DEPARTMENT MAY CONSIDER AN EVENT WITHIN A  
23 DRIVER'S HISTORY IF:

24 (I) THE EVENT IS RELEVANT TO THE [REDACTED] PERFORMANCE OF THE  
25 PROFESSION OR OCCUPATION FOR WHICH THE LICENSE HOLDER, PERMIT  
26 HOLDER, OR REGISTRANT IS LICENSED, PERMITTED, OR REGISTERED; AND

27 (II) (A) THE OPERATION OF A MOTOR VEHICLE IS A DUTY OF THE

1 PROFESSION OR OCCUPATION FOR WHICH THE LICENSE HOLDER, PERMIT  
2 HOLDER, OR REGISTRANT IS LICENSED, PERMITTED, OR REGISTERED;

3 (B) THE EVENT IS A PART OF A PATTERN OF BEHAVIOR THAT IS  
4 RELEVANT TO THE PERFORMANCE OF THE PROFESSION OR OCCUPATION  
5 FOR WHICH THE LICENSE HOLDER, PERMIT HOLDER, OR REGISTRANT IS  
6 LICENSED, PERMITTED, OR REGISTERED; OR

7 (C) THE EVENT OCCURRED WITHIN THREE YEARS BEFORE THE ACT  
8 UPON WHICH THE DISCIPLINE IS BASED.

9 **SECTION 6. Act subject to petition - effective date.** This act  
10 takes effect at 12:01 a.m. on the day following the expiration of the  
11 ninety-day period after final adjournment of the general assembly; except  
12 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
13 of the state constitution against this act or an item, section, or part of this  
14 act within such period, then the act, item, section, or part will not take  
15 effect unless approved by the people at the general election to be held in  
16 November 2022 and, in such case, will take effect on the date of the  
17 official declaration of the vote thereon by the governor.
