2 **year beginning July 1, 2018.** In Session Laws of Colorado 2018, **amend**
3 section 11 (2), of chapter 368, (HB 18-1006), as follows:

4 Section 11. **Capital construction appropriation.** (2) For the
5 2018-19 state fiscal year, ~~\$1,162,500~~ \$1,709,476 is appropriated to the
6 department of public health and environment for use by the laboratory
7 services division. This appropriation is from the newborn screening and
8 genetic counseling cash funds created in section 25-4-1006 (1), C.R.S. To
9 implement this act, the division may use this appropriation for capital
10 construction related to laboratory space expansion and equipment
11 purchase. Any money appropriated in this subsection (2) not expended
12 prior to July 1, 2019, is further appropriated to the division for the
