Annual enactment of Colorado Revised Statutes -5 validation - effective date. (2) The annual statutes, copies of which shall 6 be delivered to each member of the general assembly, together with a 7 listing of the revisor's changes, constitute the official report of the 8 committee on legal services and are hereby enacted in accordance with 9 this section as follows: 10 (x) Colorado Revised Statutes 2020. COLORADO REVISED 11 STATUTES 2020, WHICH CONSISTS OF ALL OF THE LAWS OF THE STATE OF 12 COLORADO OF A GENERAL AND PERMANENT NATURE ORIGINALLY 13 ENACTED IN "COLORADO REVISED STATUTES 1973", INCLUDING 14 SUBSEQUENT ENACTMENTS MADE PURSUANT TO SECTION 2-5-125, AND 15 ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND 16 PERMANENT NATURE ENACTED AT THE SECOND REGULAR SESSION OF THE 17 SEVENTY-SECOND GENERAL ASSEMBLY, THE FIRST EXTRAORDINARY 18 SESSION OF THE SEVENTY-SECOND GENERAL ASSEMBLY, AND AS APPROVED 19 BY THE VOTERS AT THE GENERAL ELECTION ON NOVEMBER 3, 2020. THE 20 EFFECTIVE DATE FOR COLORADO REVISED STATUTES 2020 IS FIXED AS THE 21 FIRST DAY THAT IS NOT A SATURDAY, SUNDAY, OR LEGAL HOLIDAY 22 FOLLOWING THE EFFECTIVE DATE OF THIS SUBSECTION (2)(x). 23 **SECTION 2. Safety clause.** The general assembly hereby finds, 24 determines, and declares that this act is necessary for the immediate 25 preservation of the public peace, health, or safety.
